### REPORT BY THE DIRECTOR OF COMMUNITY AND CULTURAL SERVICES

LOTTERIES AND AMUSEMENTS ACT 1976 – SECTION 16
APPLICATION FOR GRANT OF PERMIT FOR PRIZE BINGO
THE TORRENS PUBLIC HOUSE, NORTH HYLTON ROAD, SUNDERLAND

#### 1.0 INTRODUCTION

1.1 An application has been received from Susan Elizabeth Edwards for a permit for the provision of prize bingo at the above premises. It is intended that the prize bingo be run as a form of amusement for customers.

#### 2.0 CONSULTATION REPLIES

- 2.1 Northumbria Police have no objections to the application.
- 2.2 The Director of Development and Regeneration has been consulted with regard to Planning matters and has no objection to the application.
- 2.3 The views of the Health and Safety Section have been requested and any comments received will be reported at the meeting.

#### 3.0 RELEVANT STATUTORY PROVISIONS

- 3.1 The local authority has a general discretion whether or not to grant an application for a prize bingo permit. However, the discretion to refuse an application is limited to the extent that only matters relevant to the purpose of the licensing requirements should be taken into account. Matters which are relevant to other areas of statutory control should be disregarded. Relevant matters for consideration include the need for the proposal and its social effects, and matters of public order.
- 3.2 An application may not be refused unless the applicant has been given the opportunity to attend before the Committee to give representations.

#### 4.0 CONCLUSION

4.1 Members are requested to consider the above application and, if so minded, are recommended to grant the application.
