Washington Village Conservation Area: Character Appraisal & Management Strategy

The Director of Development and Regeneration submitted a report (copy circulated) to seek the comments of the Committee on the Strategy prior to its presentation to Cabinet to:-

- Report on the outcome of consultations on the draft version of the Character Appraisal and Management Strategy;
- Adopt the revised document as Formal Planning Guidance

Mr. Mark Taylor, Senior Conservation Officer, presented the report.

Councillor M. Forbes queried the extent to which Tree Preservation Orders could be used in conservation areas and was advised that within a conservation area all trees have a level of protection that is not as robust but similar to trees covered by a Tree Preservation Order. All the exemptions listed for protected trees in general apply to trees within a conservation area. There is a need to notify the Council of an intention to work on trees that have a diameter of more than 75mm measured at 1.5m above ground.

Councillor G. Hall made reference to the consultation process and queried how many members of the public had attended the public meetings.

Mr. Taylor advised that 12 people had attended and 5 had made comments. The Chairman stated that consultation events in the Washington area were usually well attended and he suggested that the small turnout could be attributed to widespread support for the Strategy. Councillor Snowdon advised that prior to the public consultation event the document had been discussed at various community groups and it was felt appropriate that a representative from each group attended the formal consultation event. Consultation, therefore, was probably more widespread than is apparent.

Councillor Wood commended the report and reiterated that more should be done to encourage public involvement in consultation.

The Chairman referred to the Townscape map in the Strategy and asked what the definition of an 'active frontage' was. Mr. Taylor advised that this referred to commercial frontage with transparent windows which enabled communication between inside and outside.

5. RESOLVED that the Committee note and support Washington Village Conservation Area: Character Appraisal & Management Strategy.
