Apologies for absence were submitted on behalf of Councillors Lauchlan, G. Miller, D. Snowdon and H. Trueman.

Minutes of the Last Meeting of the Committee held on 4th June, 2015

1. RESOLVED that the minutes of the last meeting of the Committee held on 4th June, 2015 (copy circulated) be confirmed and signed as a correct record.

Partner Agency Reports

(a) Report of the Washington Area Community Voluntary Sector Network

The Washington Area Community Voluntary Sector Network submitted a report (copy circulated) to inform the Committee of activity, progress, issues and concerns of the sector.

(For copy report – see original minutes)

Jacqui Reeves, VCS Representative, presented the report and advised that the Network was to work on a Washington Area Plan.

Councillor Kelly commented that this was a worthwhile project and was willing to support in any way he could.

2. RESOLVED that Members noted the contents of the report.

(b) Northumbria Police

Inspector Steve Pescod of Northumbria Police presented the Washington Sector Performance Update.

Inspector Pescod advised that the figures presented were from April 2015 to October 2015 in comparison to April 2014 to October 2014.

The increase in Theft figures were mainly due to Wheelie Bin thefts and the change in Council policy requiring a crime number before a replacement would be issued.

Inspector Pescod informed the Committee that there had been a notable rise in Anti-Social Behaviour in the Lambton/Concord Front Street area there would be a heavy presence of officers patrolling and issuing dispersal orders.

Councillor D. E Snowdon enquired as to how the dispersal order would work with young children. Inspector Pescod advised that it would depend on the age range and Officers would not let very young children wander off on their own.

Councillor Kelly referred to the youth providers working in the area and suggested it be useful for them to work with the Police. Councillor Scaplehorn advised that Phil McAloon was due to meet with the Police soon.

In response to Councillor P. Walker's concerns that a dispersal order may be forcing the youths into a different area, Inspector Pescod advised that they were fully aware of the issue and they did not want to transfer the problem into another area so they would be taking details of all youths encountered.

3. RESOLVED that the report be received and noted.

c) Fire Authority

Steve Graham, Station Manager was in attendance and advised that extra resources would be in place for Bonfire night.

In response to Councillor D. E. Snowdon's enquiry over who to report issues of litter to on the night, David Hardy, Area Response Manager advised that it would be the same procedures as usual.

Colin McCartney, Gentoo advised that they had a planned schedule also and he would share this with Mr Hardy's Team.

People Board - Progress Report

The Chair of the People Board submitted a report (copy circulated) to provide the Committee with an update of the progress against the current year's (2015/2016) People Board Work Plan.

Councillor Farthing presented the report and referred to the Washington Strategic Partners Health Group and requested consideration of which Members to appoint to the group. The Committee agreed that Councillors Farthing and Fletcher sit on the Strategic Partners Health Group.

With regard to the Financial Inclusion project Councillor Kelly commented that he supported the proposal but cautioned that there were a lot of areas to cover under this.

Councillor Farthing advised that this was very much an unknown quantity at the moment and would be looked at in greater detail once the first tranche of people had been affected under the new plans.

Karon Purvis, Area Officer (Washington) advised that this would be looked at during the working groups.

REPORT OF WASHINGTON AREA COMMUNITY VOLUNTARY SECTOR NETWORK

1. Purpose of the Report

1.1 The report provides an update with regard to the Washington Area Community and Voluntary Sector Network

2. Background

- 2.1 To develop the capacity and influence of the Voluntary and Community Sector (VCS) across the City, Area Networks have been established and delegates represent each Area Network at Area Committee taking forward issues on behalf of the whole VCS in the area and reporting back, providing a two-way flow of communication.
- 2.2 Washington Area Network delegates will present a report to each Area Committee meeting informing Members of activity, progress, issues and concerns of the sector.

3. Washington Area Community and Voluntary Sector Network (ACVSN) Progress Report

- The Washington Network will continue to work on developing and supporting the VCS re collaboration, communications, intelligence and mapping.
- The Network has met twice since the last Area Committee
- The Network is working to produce its own Washington Area Network work plan.
- The Network held an Extra-ordinary meeting November 25th. It was to host the Annual Budget Consultation with the voluntary and community sector. 4 organisations were represented with a total of 8 attending where a number of issues were discussed and the sector identified their spending priorities in the context of the Council's anticipated budget cuts for the 2016/17.

Washington Area Committee Report 1st September to 24th November 2015

Fatalities

As can be seen from the attached report for the Sunderland area there have been no fire deaths in the period, free Home Fire Risk Assessment inspections continue to be the focus of the district and are proving to be successful in tackling unwanted fire deaths. Unfortunately there are still occurrences of fire deaths so it is important that we don't let our guard down and we continue to promote fire safety in homes across the Washington area.

Injuries from Accidental dwelling fires

The numbers of injuries from accidental fires in dwellings for Washington for the period were 0 which was the same for that period last year, which is also very pleasing.

Numbers of accidental dwelling fires

Total numbers of accidental fires in dwellings in Washington was 7 and a similar number were recorded for the same period last year. Calls ranged from tumble dryer faults to chip pan left unattended, 2 grill pan fires, fuse box wiring fault and cigarette within a bin chute.

Deliberate primary fires excluding road vehicles

Numbers of deliberate primary fires showed a slight increase from 3 incidents to 5 for same period last year. A number of these incidents were started maliciously examples being fires in garden sheds, commercial sized refuse bins against premises damaging guttering and pallets set alight adjacent to commercial premises. Visits have been made to some of these areas to issue letters to warn occupants of the dangers of leaving combustibles outside premises unsecured and to maintain a higher level of housekeeping.

Deliberate Vehicle fires

The area has seen a slight increase in vehicle fires over the period from 2 incidents up to 3 however there are no trends indicated in this area. In all cases Police were requested for suspected malicious ignition.

Deliberate secondary fires

This is our target area; deliberate secondary fires have seen a very slight decreased over the 3 month period from 89 calls attended down to 83. Washington West and West East experiencing the highest numbers of call at 31 and 20 respectively. The highest incidence of calls involve loose refuse and rubbish.

In an attempt to address this type of incident I have:-

- Looked to set up a joint initiative involving Sunderland City Council, Oxclose and District Young Peoples Project, TWFRS Volunteers, Gentoo and Princes Trust Team to carry out litter picks in hot spot areas and place stickers on wheelie bins and generally clean up areas.
- Highlighted schools in the immediate vicinity that may benefit from a visit to our safety works centre in Newcastle.

- Our Community Fire Safety team have visited school pupils to make a joint visit with the Police to educate them in the dangers of fire setting and to pass on fire safety advice leading up to bonfire night.
- Highlight and Target the hot spot areas to our local firefighters as well as the council on a
 regular basis to focus our attention in these areas thereby increasing our ASB reporting of
 fly tipping and rubbish left on streets and back lanes and have it removed.
- Unoccupied / Derelict premise boarded up or demolished as soon as possible i.e. Armstrong House, Penshaw House, Spout Lane area.
- Working with LMAPS partners re locate 3G CCTV cameras into vulnerable areas.

The Target streets have been identified and ASB uplifts arranged, I will also be working with the Police and other agencies through the LMAPs to address the increase in these types of incidents and hopefully address the problem and lower the numbers of that type of incident.



LI16 - Deliberate secondary fires by month and year




LI16 - Deliberate secondary fires by time of day and year

People Board Progress Report

1 Purpose of Report

1.1 To provide an update of progress against the current year's (2015/16) People Board Work Plan.

2. Background

2.1 Earlier this year the Local Area Plan's priorities associated with People were referred to the Washington People Board to action on behalf of the Area Committee. The People Board continue to initiate action on those priorities and **Item 3 Annex 1** outlines progress to date.

3 Area Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:-
- a. Influencing decisions on services delivered at a local level; and
- b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's Corporate Outcomes Framework at a local level and ensures maximum impact where necessary through utilising its own resources.
- 3.2 Area Place and People Boards were set up to support the Area Committee in identifying areas of priority and ensure action in line with those priorities.
- 3.3 Each ward has one elected member representative, whose role it is to liaise with their ward colleagues in between meetings and feedback collective views into the Board meetings. Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision making body and the work / recommendations of the Board will be presented to the Area Committees for final endorsement. - The group is also considering how to support the 'Out of Hospital/Befriending' priority for older people. This will be in partnership with the CCG and the VCS. Annex 2 details a proposed Project Brief for a small grants scheme to deliver a 'Home from hospital' initiative through the VCS.
- Members are requested to discuss and determine any additional detail to be included in the proposed project brief included as Annex 2
- Elected Members are already working alongside their communities to both develop and deliver Local Area Plans and in doing so support the development of the Area VCS networks. This mechanism provides the potential to achieve much greater impact through the utilisation of additional resources from partners. Matching their funding streams with existing SIB resources to develop projects that will build additional capacity in the voluntary sector.
- Washington Way to Well Being Charter Mark Scheme now underway. 13 organisations have completed their applications. More are currently being supported to complete. The Bike Hub is now open and courses and cycling activities underway. A range of exercise classes, walk to jog sessions and live well sessions are well attended.

Local priority: Community Inclusion and support for VCS

VCS Network

- The Network is keen to empower the smaller grass roots groups to contribute to delivering local priorities and the AC Network Reps have produced a leaflet to promote what they do, how the Network works, and how the Network partners the AC
- The Community & Volunteer Development Officer (Washington Trust) has worked with a number of organisations and partners. The project is looking at opportunities to provide individual support to organisations. The Volunteer Steering Group is now established and is looking to implement an action plan to co-ordinate activity across the area.
- The board has identified a need to continue to support the local VCS and community inclusion and is requesting the Area Committee to consider aligning SIB funding from the 2015/16 budget to identify how to sustain what is currently being delivered in Washington. Annex 3 includes the Board's recommendations and proposals to sustain the local approach to developing volunteering and further develop the support for the local VCS, particularly the more informal grass roots organisations.
- Area Committee will be requested to support the People Board's recommendation under Item 5 Finance Report

Young People

 Area Committee agreed to fund the Young Peoples Can Do Fund at the October meeting. The first Call for Projects has been launched with a deadline for applications 16th December. Applicants will be asked to present their applications to the January People Board 12th January 2016.

Holiday Hunger

- A detailed evaluation of the pilot scheme was undertaken and shared with the People Board. The evaluation calculated the level of take up, and need for this/or similar type of scheme in the future.
- The board was asked to note that it would not be appropriate to repeat the scheme in this form due to the low numbers accessing the scheme but to use the learning to tie into other opportunities to access appropriate support.
- Unspent SIB has been returned to the budget

Local priority: Employment, enterprise and lifelong learning

Employability Support Services

- The People Board requests the Area Committee to align SIB 2015/16 funding to deliver a Washington Skills Conference/Work Discovery Event in early 2016.
- Building on last year's Washington Working 4U Conference, the Board is suggesting a bigger event with Washington Secondary Schools and local businesses/companies.
- Area Committee will be requested to support the People Board's recommendation and align £15,000 under Item 5 Finance Report

Financial Inclusion

- Following the People Board's recommendation and Area Committee's approval to align SIB funding at the October meeting, work has commenced to draft proposals to develop a local approach to improve the resilience of families most in need, through the provision of co-ordinated services focusing upon increasing financial capability, improving health and wellbeing and enhancing community self-help support systems. The project will:
 - Be based on robust evidence and identified need, and will provide local financial inclusion and support services for Washington residents
 - Provide information, advice and guidance to support Washington residents to access financial inclusion services, debt advice, and relevant support services.

Washington Area Committee: Funding Opportunity

Introduction and background

Washington Area Committee would like to invite interested VCS groups and organisations to submit proposals to deliver activities and opportunities to support older people leaving hospital or those already discharged but identified as needing additional support and care.

As part of area priorities for health and well-being the Washington Area Committee would like to invite project proposals which complement and work in partnership with existing support in the Washington area.

Legal Status of the organisation

Your organisation must have all of the relevant governance and statutory requirements in place. This includes a written constitution, a management committee or other governing body, insurance, financial accounting systems and any other legislative requirements relevant to your area of work (such as Employment legislation, Disclosure and Barring Service (DBS) and Safeguarding arrangements). You must sign a declaration to indicate your project is able to demonstrate all requirements are in place.

There is an opportunity for local groups and organisations with a proven track record in delivering grant funded projects to deliver projects on behalf of the Washington Area Committee and applications demonstrating strong partnership working are encouraged.

Project Information and Outcomes

As part of the area priority to develop initiatives to provide support for older people, the Washington Area Committee would like to invite project proposals from local VCS organisations which complement and work in partnership with existing support in the Washington area.

As the city's population of older people increases and there is also an increasing number of hospital admissions and readmissions, the Area Committee and the Clinical Commissioning Group are keen to see the local VCS develop and deliver valuable 'Home from Hospital' schemes. These schemes need to:

- To reduce A & E attendance
- Support people to self care
- Enable timely discharge from hospital
- Provide care closer to home

It is anticipated such schemes delivered at a local level can help improve the well-being of older people and reduce social isolation and loneliness as well as reducing the demand on health and care services.

The project(s) must:-

- 1. Engage more older people coming home from hospital and those at risk of or experiencing social isolation, in activities and services to improve their wellbeing
- 2. Reduce isolation and increase social interaction of older people coming home from hospital
- 3. Increase awareness of support available to older people coming home from hospital
- 4. Provide local support, services and activities which help older people live independently following a stay in hospital

Any project proposal should link into the work of integrated teams in Washington and potentially the CAB project the practices have commissioned so that there is a clear link across all services. Applicants need also to be aware of the Recovery at Home Service.

Project proposals can be targeted to any part of Washington. All beneficiaries must live in Washington.

Budget: There is a total fund of £40,000

All applications will be subject to formal assessment and scoring. It is not expected to fund any single project form one organisation for more than £10,000.

However another option would be for several organisations who already deliver similar services could form a consortia/partnership and deliver a range of service provision adding additionality and added value to existing support in the Washington area. Washington Area committee are keen to develop new initiatives which evidence a locality partnership approach and can provide some sustainability to the services provided. Any such application could apply for the total fund as long as project outcomes reflected the investment.

Assessment

Each project application will be assessed and scored against set criteria. The results of that assessment and a recommendation will be presented to the full Area Committee, who will decide which project proposals will be supported.

Community Inclusion and support for the Washington VCS including volunteering

The People Board recommends the following action:

- 1. The current Community and Volunteer Support Project (Washington Trust) be evaluated the Trust to submit a summary of all activity
- 2. Desktop evaluation of outputs and milestones to identify refocus and retargeting required
- 3. Any reprofiling of the current budget (Year 2) be approved by the Area Co-ordinator
- 4. Area Committee to discuss any issues and agree to align additional funding to support further development of the approach.
- 5. The Board has identified:
 - a. The project could and does support the council's journey with regards to our partners doing more
 - b. The project is successful and is good at what it does and is keen to grow the informal groups to become more structured and stronger but it has took a year to realise the initial focus on CAs has not been successful
 - c. The project could build further ties to the Washington Area Network's aspirations re the mentoring/peer support by larger organisations for smaller informal groups.
 - d. The current post could take on or facilitate further opportunities to deliver elements of other Area Committee funded projects making it about additionality rather than another post or another organisation. Whilst at the same time assisting with sustaining a project the Area Committee has already invested in.
 - e. The volunteering element of the current project is now growing and it needs a real push again this will help be able to contribute to the Council's agenda. The gap in this element is the deployment of volunteers and there needs to be a longer term plan.
 - f. The Washington Trust would also be required to access additional funding to present a sustainable approach
- 6. Area Committee is requested to consider a targeted approach rather than an open call for projects to sustain this project, and is requested to align SIB 2015/16 budget to develop this proposal

Summary of CVDO activity to date (as at end of October 2015)

The CVDO project has two specific areas of activity: to provide a community development support offer to voluntary and community sector (VCS) organisations operating within Washington and co-ordinating and developing volunteer opportunities.

Community Development

The CVDO project is currently supporting a range of community groups across Washington. These groups include:

- Community centre based organisations such as Harraton, Springwell Village VC
- Environmental groups
- Tenant and Resident Associations

- Issue specific groups e.g. litter
- A growing number of community groups which aim to support schools

The CVDO project is providing the following forms of support and assistance to community groups:

- Development of appropriate governance arrangements
- Support to develop internal procedures and processes such as safeguarding and risk assessment
- Fund-raising advice and assistant (the project has supported 6 new groups to secure funding for the first time)
- Project development e.g. Rickleton Park
- Volunteer support/development
- IT and social media development the project manages a volunteer whom provides other volunteers with social media and web-site development advice and support

To date (end of October 2015) the CVDO has, in worked directly with **20 small community organisations** operating within Washington. These groups have ranged from relatively well established organisations such as Springwell Village Community Venue, Harraton & District Community Association to new and emerging groups such as The Friends of Rickleton Primary School and Springwell Ladybirds. This activity has brought the project into direct contact with over **100 individual volunteers.** From this overall figure, approximately 25% had not been part of a formal group before being supported by the CVDO project.

The CVDO has worked intensively with 4 community organisations to produce organisational reviews via the SWOT process. A further 2 SWOT reviews have been completed but with the organisation taking less of an active role in their production. With the support of the CVDO 8 new community groups have been formally established in Washington during year one. During the same period no community organisations operating within Washington have dissolved, though it is reasonable to say that several remain vulnerable. A great deal of work has taken place relating to grant aid in terms of building internal capacity to raise the levels of grant aid (external to the city Council) secured by the production of better applications. With the support of the CVDO 7 community groups have secured grant aid for the first time with a further 4 applying for non- city council funding for the first time.

Volunteer Support/Development

The CVDO project provides a range of volunteer development support and co-ordination services. Broadly speaking this can be described as:

- Acting as a point of contact for Washington residents whom wish to volunteer in their community and referring them on to CVS organisations which operate within the town
- Supporting VCS organisations in Washington to develop internal processes which allow them to more effectively recruit, appropriately manage, develop and support volunteers.
- Co-ordinate the Washington Volunteer Steering Group which is made up of the organisations in Washington with the largest numbers of volunteers (Gentoo, Sunderland City Council etc)
- Act as a point of contact for corporate volunteering activity. Currently the project is working with the Department of Work and Pensions and HM Revenues and Customs

 both of which have allowed their staff to volunteer in Washington.
- Co-ordination a range of volunteer groups which pick litter across the town (some of these individual groups also receive community development support)

 Delivery of the Washington 100 Project which seeks to locate and manage 100 Washington residents to form a pool of volunteers.

The CVDO project has also worked to develop volunteering within Washington, in both terms of collectives and individuals.

- Over 20 volunteers, with no history of volunteering, have been supported by the CVDO project to take up volunteering roles within Washington in groups/organisations that are already operating. Additionally, over 30 individuals have been supported to volunteer in new groups which have been created during the past 12 months.
- A database has been created to manage the Washington 100 Volunteering Project.
 Work is continuing to identify and appropriately train, the individuals who collectively will form the Washington 100 volunteer pool. (41 recruited to date)
- The project has worked with 6 community organisations to help them host, support and manage volunteers by the development and introduction of a range of policies and procedures to make the organisation more "volunteer aware" and "volunteer friendly". As part of this work the project has supported organisations to develop: volunteer policies (this is becoming more and more a requirement for grant aid). This activity helps their sustainability going forward in terms of both volunteer recruitment and retention.
- Corporate volunteering is, it is felt, an underutilized area of volunteering activity in Washington - The CVDO project, working both with Sunderland Volunteers Centre, but also on its own, has been actively developing an environment, and associated infrastructure, to make Washington a more attractive location for corporate volunteering. 3 corporate volunteering activities have taken place within year 1
- 4 volunteer training courses have been delivered by the CVDO.

Recommendation: Area Committee is requested to consider a targeted approach rather than an open call for projects to sustain this project.

Members are requested to support the People Board recommendation to align £35,000 SIB 2015/16 budget to develop this proposal

REPORT OF THE CHAIR OF THE PLACE BOARD

Place Board Progress Report

1 Purpose of Report

1.1 To provide an update of progress against the current year's (2015/16) Place Board Work Plan.

2. Background

2.1 Earlier this year the Local Area Plan's priorities associated with Place were referred to the Washington Place Board to action on behalf of the Area Committee. The Place Board continue to initiate action on those priorities and **Annex 1** outlines progress to date.

3 Area Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:-
- a. Influencing decisions on services delivered at a local level; and
- b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's Corporate Outcomes Framework at a local level and ensures maximum impact where necessary through utilising its own resources.
- 3.2 Area Place and People Boards were set up to support the Area Committee in identifying areas of priority and ensure action in line with those priorities.
- 3.3 Each ward has one elected member representative, whose role it is to liaise with their ward colleagues in between meetings and feedback collective views into the Board meetings. Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision making body and the work / recommendations of the Board will be presented to the Area Committees for final endorsement. 4. Key Areas of Influence/Achievements up to 30th November 2015

4.1 Outlined below is a summary of the key areas of influence / achievements of the Washington Place Board up to 30th November 2015.

Influencing role: Highways Maintenance Programme

- The proposal for the 2016-2017 Highways Maintenance programme is to continue with the 25% Member influence. The financial value of the 25% will be determined once the Capital Programme value is confirmed early in the new calendar year (2016), but is likely to be something similar to last year.
- Highway Officers are gathering intelligence from Technical Condition Surveys, Highway Inspections, Member/Public reports and Complaints, Insurance Claim locations and local knowledge.
- All members were sent an email in October 2015, and asked to submit streets they wished to be considered for the 2016-17 HM Programme. Members are encouraged to forward their streets for consideration to Graham Carr, the Highway Asset Manager and also through their Place Board Member representative in the timescales outlined in the email.
- From this information a list will be compiled, the Streets on the list will be inspected and prioritised before appropriate treatments for the type of repair needed are determined and accurate estimates can be prepared. Once this information is known a potential list of priority schemes for each area can be prepared.
- In order to capture the medium term requirements for capital highway maintenance schemes, it is intended, resources permitting, to compile indicative programmes for a further two years in which streets that don't meet the priority for 2016-2017 can be included. These programmes will not be fixed but flexible and be dependent on the priorities in any given year.
- For each Area, a prioritised list of streets will be brought forward for consideration in next year's programme. These will be circulated in advance of the February 2016 Place Board. Highway Officers will attend the February Place Board to aid discussion and agree a prioritised list of schemes.
- The Place Board's recommendations will be presented to the March Area Committee for approval of the final Area Highway Maintenance Programme 2016-2017.

Influencing role: Flood risk is Washington

- The board was informed of a Washington Flood Study. See map attached as Annex 2
- The drainage areas included in the study are All of 08-D14, All of 08-D15 and the Northern section of 08-D16.
- Stage 1 of the study will comprise a data collection exercise, jointly with Northumbrian Water, the Environment Agency and the Council. This data collection will then prioritise the worst flooding areas within the study area. The three agencies then have the option to take the priorities onto the next stage jointly, individually or not at all. The stage 2 exercise is more in depth and includes hydraulic models if they haven't been done before and options of what could be done to prevent the flooding.
- In Washington there are 680 properties which are at risk of flooding from a 1 in 30 flood event which is a high risk.



Washington Events Programme 2016

Introduction and background

Washington Area Committee would like to invite interested groups and organisations to submit proposals to deliver the Washington Events Programme for 2016.

As part of area priorities for community support and inclusion and for developing a cultural identity, the Washington Area Committee would like to invite project proposals which complement and work in partnership with existing support in the Washington area. Local events have traditionally always been key to enhancing community inclusion and involvement in Washington and in supporting a cultural identity for the area and over the last 8 years a number of community led events have taken place and been very successful.

Legal Status of the organisation

Your organisation must have all of the relevant governance and statutory requirements in place. This includes a written constitution, a management committee or other governing body, insurance, financial accounting systems and any other legislative requirements relevant to your area of work (such as Employment legislation, Disclosure and Barring Service (DBS) and Safeguarding arrangements). You must sign a declaration to indicate your project is able to demonstrate all requirements are in place.

The successful applicant will also be required to submit Annual Management Accounts and the organisation's Business Plan should they be awarded the grant. This will only be required AFTER the award of the grant has been confirmed.

There is an opportunity for local groups and organisations with a proven track record in delivering grant funded projects to deliver projects on behalf of the Washington Area Committee and applications demonstrating strong partnership working are encouraged.

Project proposals

Local events have been key to enhancing community inclusion and involvement in the Washington area and in supporting a cultural identity for the area. Washington Area Committee would like to invite project proposals to deliver the 2016 Washington Events Programme. Washington Area Committee requires an organisation or consortium/partnership to co-ordinate and deliver the programme of events for the year. This programme is made up of a number of elements (as a minimum):

Project outcomes

- The successful applicant will be required to co-ordinate and manage the events, ensure an events safety plan and all infrastructure is in place for each event where appropriate, develop opportunities for additional resources for the programme, coordinate any community programmes or community contributions or activity, and liaise and consult directly with the Washington Area Committee Place Board with regards to progress.
- 2. The project proposal for the Events Programme must identify and include the following
 - a. Proposed dates and venues for each event
 - b. All infrastructure required The successful applicant will be expected to supply all necessary infra-structure that will be required to deliver the events.
 - c. The successful applicant will be expected to develop all the events and work in partnership with the Area Committee's Place Board and the local VCS where relevant. In particular, the successful applicant will also be required to manage and co-ordinate relevant steering groups for individual events where appropriate. All Steering Groups will be required to work with the appointed lead to help develop and deliver the activities and entertainment, including the heritage elements which have historically been a main feature of one of the previous events.
 - d. The successful applicant will also be required to work through the WAC Place Board who will be responsible for providing any advice and guidance with regards to new sources of funding and that any match, agreement or contribution will be in line with general principles of the council having regard to reputation, procurement policy and procedures, corporate identity and appropriate advertising content and any other relevant City of Sunderland strategies, policies and procedures.
- 3. The proposal must include how it will develop
 - All relevant Event Management Plans for individual event including health and safety, access, permissions, licensing etc.
 - Communications Plans
 - Promotional and Marketing plans
 - Community participation and a partnership approach utilising local community resources where appropriate

Budget

There is a total of £50,000 SIB identified for this proposal. As a minimum the applicant will need to evidence how it intends to deliver those events identified above on behalf of the Washington Area Committee. Area Committee will be pleased to receive any additional proposals the applicant feels they can deliver as part of the programme for 2016 – as long as the original list of events are confirmed as deliverable. However, no further funding will be available from the Washington Area Committee for additional events. This fund could be considered as 'seed' funding and the successful applicant will be free to raise any additional resources for their proposed programme and pilot a more business approach model to delivering local community events.

Where external funding or resources are identified the applicant will need ensure any new source or opportunity is agreed via the Place Board and that any match, agreement or contribution will be in line with general principles of the council having regard to reputation, procurement policy and procedures, corporate identity and appropriate advertising content and any other relevant City of Sunderland strategies, policies and procedures. The Place Board will have the responsibility to provide guidance and advice as required.

Title of Report:

Strategic Initiative Budget (SIB) and Community Chest - Financial Statement and proposals for further allocation of resources

Author(s):

Head of Scrutiny and Area Arrangements.

Purpose of Report:

Area Committee has delegated budgets to allocate to specific strategic priorities identified in the Local Area Plan, with the overall aim to benefit the wider community and to attract other funding into the area. The report provides a financial statement as an updated position on progress in relation to allocating SIB, and Community Chest and presents proposals for further funding requests.

Description of Decision:

REPORT OF THE HEAD OF SCRUTINY AND AREA ARRANGEMENTS

Strategic Initiative Budget (SIB), Community Chest – Financial Statement and proposals for further allocation of resources

1. Purpose of Report

1.1 Area Committee has delegated budgets to allocate to specific strategic priorities identified in the Local Area Plan, with the overall aim to benefit the wider community and to attract other funding into the area. The report provides a financial statement as an update position on progress in relation to allocating SIB and Community Chest and presents proposals for further funding requests.

2 Strategic Initiatives Budget (SIB)

2.1 The table below shows the financial position of SIB for 2015/2016:

2.2 Members are asked to note the balance of £108,713.50 this includes returns to the budget as detailed in the table above in 2.1.

3. People based priorities

- 3.1 Following the November People Board it was agreed to seek approval from the Area Committee to align £35,000 SIB 2015/16 to develop the People based priority to support community inclusion and the local VCS. Proposals for evaluating volunteering in Washington and determining the need for support for the grass roots community organisations are under consideration. This evaluation will also consider the successes and lessons learned from the successful Community Volunteer Development Project, will determine the project's focus for Year 2, and will identify how the project can be sustained to help deliver new outcomes some of which are identified by the council to encourage partners and local communities to be more involved in delivering much needed services and support. Proposals for moving forward are detailed under Item 3 People Board Progress Report. All proposals will be subject to a Call for Projects and an Area Committee decision. If this request for alignment of funds is approved the balance of SIB funding remaining to be allocated would be £73,713.50
- 3.2 Following the November People Board it was agreed to seek approval from the Area Committee to align SIB 2015/16 to develop the People based priority for employment, enterprise and life-long learning. Proposals for holding a Washington Skills Conference/Work Discovery Event are detailed in **Item 3** of the People Board Progress Report. All proposals will be subject to a Call for Projects and an Area Committee decision. Members are requested to align a budget of £15,000 to develop this project. If this request for alignment of funds is approved the balance of SIB funding remaining to be allocated would be £58,713.50

4. Place based priorities

4.1 Following the November Place Board it was agreed to seek approval from the Area Committee to align SIB 2015/16 to develop the Place based priority for Environment and Green Space. Washington Area Committee has for some time focused on delivering neighbourhood improvements in partnership with local organisations and community. Area Committee is requested to enhance the current programmes by agreeing to provide an equipment bank for use by volunteers and partners to deliver identified neighbourhood improvements. It will help add value to current projects such as the Neighbourhood Improvements Project and the Community Volunteering Project. It will also provide an opportunity to enhance sustainability of those initiatives as well as fulfil some of the objectives of the council to involve partners and volunteers in delivering key services in the community.

Proposals to further develop that approach are included under **Item 4** Place Board Progress Report and are presented to the Area Committee for consideration. All project proposals will be subject to a Call for Projects and an Area Committee decision. Members are requested to align a budget of £25,000 to develop this project. If this request for alignment of funds is approved the balance of SIB funding remaining to be allocated would be £33,713.50

4.2 Following the November Place Board it was agreed to seek approval from the Area Committee to align additional SIB 2015/16 to develop the Place based priority for developing local industrial areas. Place Board and Area Committee supported and agreed the development of a local Business Watch scheme targeting the local industrial estates at the last Area Committee in October. The aim was to encourage a group of business' who work together with the Police and other agencies to make their area a safer place for all to work, live and visit.

Since that decision the council has identified that it has not the resources to lead that initiative. Area Committee are asked to consider an alternative proposal utilising enforcement resources to take a targeted approach.

Proposals to develop this approach are detailed under **Item 4** and are presented to the Area Committee for consideration. All project proposals will be subject to a Call for Projects and an

Area Committee decision. Members aligned £10,000 at the last meeting and are requested to align a further budget of £25,000 to develop this project, making a total of £35,000 available. If this request for alignment of funds is approved the balance of SIB funding remaining to be allocated would be £8,713.50
