### **STRATEGIC INITIATIVES BUDGET (SIB): REGENERATION ISSUES REPORT**

#### **Report of the Chief Executive (Designate)**

#### **1.0 Purpose Of The Report**

1.1 This report outlines current expenditure from the Strategic Initiatives Budget (SIB) and applications for funding from this budget in order to support new initiatives, which will benefit the area.

#### **2.0 Description of Decision (Recommendation)**

2.1 The Committee is requested to approve the following:

- Funding to support proposals for new projects. Full applications are included in Annex 1
- Note SIB Statement of Resources in Annex 2

2.2 Following the recent communication with Members, the Committee is requested to consider the principle of deferring commitment of expenditure from next year's SIB budget (subject to budget approval), except in cases of clear emergency. The Committee is further requested to defer consideration of Strategic Investment Plan (SIP) expenditure until the new financial year.

#### **3.0 Background**

3.1 Each Regeneration Framework area has been allocated a minimum budget of £200,000 per annum over the last thirteen years. Over this period, therefore, the Framework area has been allocated £2,748,568 in this way.

#### **4.0 Current Position**

4.1 Following the 29 October 2008 Committee meeting, a balance of £100,878 remained to be allocated from 2008/09.

4.2 There are two applications for funding presented to this Committee requesting a total of £10,000 from the 2008/09 budget and a further £35,095 from the 2009/10 budget subject to approval. Should the Committee grant this request, £214,664 will be committed from this years budget, leaving a balance of £90,878 for 2008/09 with one meeting remaining. A further £35,095 being committed, subject to approval, from the 2009/10 budget.

## **5.0 Reasons for the Decision**

- 5.1 SIB was established to promote action on key priorities identified in the relevant Area Regeneration Frameworks, and to attract other funding into the area. Applications for SIB funding should demonstrate the potential benefits to local communities the proposed project would bring, and subsequently be able to provide evidence and statistics that can illustrate these benefits.
- 5.2 The suggestion to defer new applications seeking funding from the 2009/10 SIB budget (subject to approval) and SIP allocation is to enable the Area Committee to maximise the amount of budget available using their newly developed Local Area Plans.

Each project is required to indicate whether it has an equal opportunities policy, or what measures it employs to address equal opportunity issues, in section 4 of its application form, which is attached as Annex 2.

## 7.5 Public Relations and Publicity

Each project is required to indicate how it will promote SIB via project publicity in Section 3.7 of the application form. The Marketing and Communications Co-ordinator for the Sunderland City Council implements the publicity and public relations schedule on behalf of the Area Committee.
