#### **Reception of Petitions**

Councillor Donaghy - Petition from residents opposing councils and private companies buying up houses in the area and turning them into HMOs which residents state they were not consulted on. Residents intend to fight this on the grounds that:

- 1. Residents were not consulted on the implementation of HMOs;
- 2. Asylum seekers with no background checks, and bail hostels are being housed next to families with several examples reported: and
- 3. ASB has repeatedly been reported by residents where these HOMs have been placed.

Councillor Hodson - Petition from residents requesting Sunderland City Council to reverse its plan to cut "free after 3pm" parking in Sunderland Council carparks.

Councillor Haswell – Petition from residents requesting Sunderland City Council to carry out a review of the Saint Lukes Road/Front Road/Westmoor Road/European Way roundabouts and present plans to change the layout and make them safer for drivers and pedestrians.

# Petition requesting that the Council urgently carry out road resurfacing of unacceptable sections of Harperley Drive and Dipton Gardens

A petition signed by 31 residents of Harperley Drive and Dipton Gardens requesting that the council urgently carry out road resurfacing of unacceptable sections of Harperley Drive and Dipton Gardens, was presented at Council on 14th June 2023 by Councillor Tye and referred to the Executive Director of City Development.

Council Officers have considered the petition and advised as follows.

#### Appointment of Independent Persons – Localism Act 2011

- 1. In accordance with the Localism Act 2011, the Council is required to appoint at least one Independent Person (IP) to assist in carrying out its duties in respect of dealing with Code of Conduct complaints. The IP must be consulted before the Council takes a decision in respect of any allegation made against an elected member (including town councillors) which has been investigated. They may also be consulted about any other aspect of a councillor's alleged breach of the Council's Code of Conduct for Members and may be consulted by a councillor against whom any allegation has been made. In addition, the Local Authorities (Standing Orders) (England) (Amendment) Regulations 2015 have made provision for IPs to be included in Panels which exercise certain advisory functions in connection with disciplinary and dismissal procedures involving the Chief Executive, Chief Finance Officer or Monitoring Officer.
- 2. The Council awards an annual allowance of £1,000 for the role of IP, plus reasonable travel and subsistence expenses.
- 3. The Council currently has one IP, namely Dennis Hall, a retired local government officer of many years' experience, who has also held the role of

monitoring officer. At its meeting on 12<sup>th</sup> September 2023, the Council agreed to appoint two IPs and determined that should Mr Hall confirm his wish to be reappointed to the role, he would not be required to attend at interview, but would be requested to submit an updated CV, which he has done.

4. A Panel comprised of Cllr Dodds (Chair of the Standards Committee), Cllr Mullen and Cllr Hodson interviewed applicants for the second IP role and following the conclusion of the recruitment process, the Panel recommends the appointment of Dr Stuart Green. Dr Green is a university lecturer with a professional background in accounting, auditing and risk management. He has held the role of Independent Person at three other local authorities, as well as other governance roles such as the chair or vice-chair of various public sector audit committees. Dr Green is also a current member of the Council's Independent Remuneration Panel.

#### **RECOMMENDATION**

To appoint Dennis Hall and Stuart Green as Independent Persons, each for a term of two years' duration, which may be extended by the Council for two further two-year terms (i.e. six years in total) and to award an annual allowance of £1,000 and reasonable travel and subsistence expenses in respect of the roles.

# ITEM 11 – UPDATE TO THE CONSTITUTION

## A. Attesting the Seal of the Council

- 1. Article 15.05 of the Constitution authorises the following officers to attest the Council's seal: Chief Executive; Director of Finance; Assistant Director of Law and Governance; Senior Manager Law and Governance and the Specialist Lead (Commercial Law). It is proposed that in addition to the officers referred to above, the Deputy Section 151 officer (currently the Assistant Director of Finance), the Governance Law Specialist and Commercial Law Specialists, be authorised to attest the seal.
- 2. Authorising additional officers to attest the seal will provide greater flexibility with regard to the execution and conclusion of agreements and legal orders, some of which relate to matters which are required to be completed at short notice, whilst also retaining the power to execute such documents at an appropriate level of seniority.
