# Place Board Progress Report.

The Chairman of the West Sunderland Area Place Board submitted a report (copy circulated) which provided an update on progress against the current year's Place Board Work Plan.

Councillor Tye, presented the report drawing Members' attention to the initiation of action towards achieving key priorities as detailed in Appendix 1 of the report together with a summary of key areas of influence and achievements of the Place Board in relation to Responsive Local Services, Public Protection and Regulatory Services, Highways Capital Maintenance, Shopping Centres and Environment and Street Scene Improvements as at 30<sup>th</sup> November, 2014.

Councillor S. Watson referred to her request during discussion at the Place Board on the West Area Event, that as many local traders as possible were encouraged to provide stalls. Helen Peverley, Area Coordinator advised that a full project Team had been assembled and that this would be picked up as part of its remit. # People Board Progress Report.

The Chairman of the West Sunderland Area People Board submitted a report (copy circulated) which provided an update on progress against the current year's People Board Work Plan.

Councillor Atkinson presented the report drawing Members' attention to the initiation of action towards achieving the key priorities as detailed in Appendix 1 of the report, together with a summary of key areas of influence and achievements of the People Board in relation to Youth Contracts, Local Multi Agency Partnership, Job Prospects and Health and Well Being as at 30<sup>th</sup> September, 2014.

Councillor Gofton stated that there was so much that was good about the report and so much that that she could comment on, however if there was one thing that she had to single out for special praise it would be the job clubs. In the past it had always been a struggle to tie up all the disparate ends of the problem, however the work of the People Board as a catalyst to enable the Council, VCS and the DWP to come together and address the hurdles faced by clients had been amazing. Ms Peverley advised that it was hoped that the best practice developed by the West Area would be influential to city wide delivery, benefitting the residents of Sunderland as a whole.

Councillor S. Watson referred to the WIRES project that she had been involved with as part of her lead member role. The work of the local employers in conjunction with the Community Job Clubs to develop the intensive pre-employment workshops had been transformational for the young people on the course. The confidence boosting nature of the project had been visible.

There being no further questions or comments on the report, it was:-

# Report of the West Area Voluntary and Community Sector Network (AVCSN)

The AVCS Network submitted a progress report (copy circulated) which briefed the Committee on issues pertinent to the Voluntary and Community Sector.

Gilly Stanley, Acting Area Community Officer presented the report highlighting the following feedback and input arising from the two VCS meetings held since the Area Committee:-

- i) the assistance of the Network in the hosting and marketing of the West Sunderland Area Events,
- ii) the participation of the Network in supporting the work of Healthwatch Sunderland,
- iii) the support from the Network in delivering the Committee's priorities in relation to Job prospects, Activities for Older and Younger Persons, Street Scene and Environmental Improvements together with Health and Wellbeing,
- iv) in addition the Network received information on and considered how it could support initiatives in relation to:
  - Housing Renewal
  - Maximising Green Space and improving Health and Wellbeing
  - E Learning
  - Local Multi Agency Partnerships

Bill Leach confirmed that the Network would continue to support the Area Committee and its priorities in as many different ways as possible. He particularly valued the information exchange that was possible via the Network meetings and would continue to disseminate it as widely as possible. Councillor Tye noted the reluctance of Mr Leach to 'blow his own trumpet' so highlighted on his behalf the award winning nature of the services provided by the likes of the Tansey Centre, Youth Almighty and the Pallion Action Group. This in turn was a reflection of the work carried out by the Area Committee to enable the Voluntary Sector to 'showcase' themselves more readily.

The Chairman thanked Ms Stanley and Mr Leach for their report, and it was:-

# **Report of the Northumbria Police – Sunderland West**

Inspector Lisa Laverick of Northumbria Police presented a report (copy circulated) which provided the Committee with an update on the Force's most recent performance indicators showing actual crimes for the period 1<sup>st</sup> April, 2014 to 20<sup>th</sup> September, 2014 and the percentage increase / decrease against the same period last year.

Particular reference was paid to crime levels in relation to violent crime, vehicle crime, burglary from dwelling, burglary other than dwelling, criminal damage, theft and handling, shoplifting, youth ASB and Non Youth ASB. In addition members were informed of the particular crime patterns in respect of the Barnes, Pallion, St. Anne's, Sandhill, Silksworth and St Chad's wards for the period 21<sup>st</sup> September, 2014 to 17<sup>th</sup> November, 2014.

Councillor Essl referred to the action detailed in the report to tackle anti-social behaviour undertaken by the Neighbourhood Policing Team in the Eden Vale area. This had included the Team working closely with the Council, youth providers and liaising directly with residents through the use of mediators. Councillor Essl believed that it was important that elected officials were also involved in such initiatives. Councillor Tye advised that he had met with the mediator as part of his LMAPs role.

Councillor Gofton referred to the deployment of the Body Worn Cameras (BWCs) and asked whether they had made a difference? Inspector Laverick advised that they had been invaluable in the campaign against domestic violence with the evidence they provided enabling victimless prosecutions to take place. The cameras were worn by the 24/7 Unit and the Neighbourhood Policing Team and were switched on every time an incident occurred.

Councillor D. Dixon placed on record his thanks to Northumbria Police for their efforts to curb the incidents of anti-social behaviour in Herrington Country Park.

Councillor Allan stated that looking at the crime figures there had been a long term and continuing rise in burglary from dwellings and thefts from motor vehicles. He asked if there were any underlying reasons. Inspector Laverick replied that there were occasions when people left their property unsecured however the main modus operandi was the forcing of locks. The crime figures reflected a small number of hardened offenders operating in small pockets. In response to a further question from Councillor Allan, Inspector Laverick advised that there was no evidence to suggest that 'false burglaries' were being carried out in order to generate insurance claims.

- i) the number of deaths from accidental / all dwelling fires (none),
- ii) the number of injuries from accidental / all dwelling fires (1),
- iii) accidental fires in domestic properties (8),
- iv) deliberate property fires (none), and
- v) deliberate vehicle fires (2)

Helen Peverly, Area Coordinator, advised that the TWFRS's usual representative at the Area Committee, Jeff Wilkinson, had now retired and that his replacement Steve Burdis would be attending future meetings.

# Strategic Initiatives Budget (SIB) and Community Chest – Financial Statement and Proposals for Further Allocation of Resources

The Chief Executive submitted a report (copy circulated) in respect of the above matter.

Helen Peverley, Area Coordinator, presented the report highlighting the financial statement, details of 12 projects approved for support from the 2014/15 Community Chest budget, details of 6 projects approved for support from the maximising green spaces fund, together with details of 4 further SIB funding requests.

Councillor Gofton having sought clarification regarding the approval mechanism for small grants made in relation to the delivery of priorities under the Health Plan on a Page, Ms. Stanley advised Members that in line with the Area Committee's delegated decision making powers, the Committee was requested to approve £80,000 of grant to

support the delivery of the Health Plan. Further recommendations were made to carry out a call for projects to support the delivery of the Plan with a request that all projects, below the value of £5,000, were presented to the People Board, to ensure they were fully in keeping with the Health Plan requirements. Where the activity was over £5000 full details would continue to be presented to the Area Committee for its approval.

Consideration having been given to the report, it was:-

- 7. RESOLVED that:-
  - (i) the Area Committee's funding statement as detailed in paragraphs 2.1, and 3.1, of the report be received and noted,
  - (ii) approval be given to the recommendation of the People Board that £80,000 SIB funding from the 2014/15 budget be allocated towards the development of a Health Programme using the small grants process, (as detailed in annex 1 to the report),
  - (iii) approval be given to the recommendation of the People Board that £31,837 SIB funding from the 2014/15 budget be allocated to support the extension the Community Work Clubs via the West Intensive Recruitment Employment Support (WIRES) programme (as detailed in annex 2 to the report),
  - (iv) approval be given to the recommendation of the People Board that £4,500 SIB funding from the 2014/15 budget be allocated to enable the Community Work Clubs to design and deliver a comprehensive training package to ensure continued support for residents in relation to seeking employment (as detailed in annex 2 to the report),
  - (v) approval be given to the recommendations of the Place and People Boards that £40,000 SIB funding from the 2014/15 budget be allocated to support the development of the West Area Event (as detailed in annex 3 to the report),
  - (vi) the approval of six projects using the small grants process from the Maximising Green Spaces fund (as detailed in annex 4 of the report) be noted, and
  - (vii) the approval of the 12 Community Chest applications as (detailed in Annex 5) of the report be noted.

# West Area Committee Annual Report 2014-15

# 1 Purpose of Report

1.1 To approve the West Committee's Annual Report as part of the combined Area Committee Annual Report 2014-15 to be presented to Full Council.

#### 2. Background

- 2.1 This will be the fourth year that all Area Committee reports have been brought together in one combined report and presented to Full Council.
- 2.2 Area Committees are appointed by the Council to ensure improved service delivery at a local level in the context of best value and more efficient, transparent and accountable decision making. They deliver this role through:
  - Monitoring the quality and effectiveness of services delivered by the Council and other main providers in the area
  - Working in partnership to develop efficient and effective solutions to city-wide issues as well as supporting local area priorities
- 2.3 2014-15 has been an incredibly busy and challenging year for us all a year when Sunderland, amongst many things, commemorated its WW1 heroes. The Annual Report for 2014/15 showcases some of the key achievements delivered this year through the dedicated work of the five Area Committees and their supporting Place and People Boards. It also highlights how we translate the principles of a community leadership council in practice and the central role played by local councillors in helping to strengthen our communities.

2014/2015 has been an exceptionally busy year for the West Area Committee – they have been working hard to support local communities, including the establishment of local trader groups to enable and empower them to become more resilient during these difficult times. Enabling communities who are struggling to survive each day takes initiative and fresh ideas – and to gather these ideas and understand what the real priorities are for the Area has been the key. Using the broad outcomes of Improving Health & Wellbeing, Enhancing Skills & Creating Job Prospects and Maximising Green Spaces, the Committee has worked alongside the Voluntary and Community Sector and Partners to deliver some fantastic results which have not only improved lives for communities but which have also created a momentum to develop mainstream delivery pathways – therefore the ripple effect has in fact been city-wide improvement in some instances.




Pallion Traders Association - working hard to ensure our local high streets thrive

The Area Committee has continued to influence core service delivery too – enabling services to improve using their local intelligence. The Place and People Boards have continued to be pivotal, providing an opportunity for focussed discussion with officers and partners, to support the Committee to make the right decisions for the communities within the West.

#### Resources

Through the Strategic Initiatives Budget (SIB) we have funded a range of projects to support delivery of our priorities achieving positive outcomes for local people. A snapshot of the projects that funding has been allocated to is below.



Breakdown of how SIB has been allocated in line with People, Place and Economy priorities during 2014/15

In addition to larger scale projects a range of smaller scale support has been provided to community groups. 65 Community Chest grants have been awarded totalling £49,820, the average value being £800. The benefits for local communities' have ranged from local events to the creation of a community shop!

The Area Committee has influenced core 'People, Place and Economy' service delivery, considering how services are delivered across the locality and has directly influenced the development of services for the city working across multiple strategic partnerships. Some key achievements include:

#### **Community Work Clubs & Empowering Volunteers**

A gap was identified in support for those residents who are actively seeking work but not receiving support from the 'Work Programme'. A local 'work club' programme, was developed and delivered locally through all 6 wards within the West Area by three of our VCS organisations as a consortium. The programme has been incredibly successful and the lessons learned have influenced the creation and development of a new approach to supporting people into work, working in partnership with the Department for Work and Pensions (DWP) and the Council Welfare Service.

Now instead of community work clubs being restricted to a physical base, support can be delivered to smaller community groups with volunteers trained to help more people in a wider range of locations.

Another successful new approach in helping job seekers in the community is the West Area Committee funded 'West Intensive Recruitment Employment Support' (WIRES) project. This works closely with employers such as UNIPRES and Housing 21 to identify possible new jobs, and the type of skills and training which people will need to take them. The project provides intensive coaching to prepare job seekers to apply for posts including interview techniques, making sure they have all the up-to-date qualifications and training certificates necessary to apply, and setting up a daily programme of activities at times which reflect the normal working day so that people are fully prepared to start work immediately.

During 2014/2015 West Area Committee funded community employment and skills initiatives have;

- Provided help and practical support to 851 unemployed job seekers though the job clubs
- Helped 177 local people find work
- Provided training for 129 to increase their employability
- Supported nine local people to set up their own businesses

#### Health

During 2014 West Area Committee developed and approved a West Health Plan, in partnership with the Clinical Commissioning Group (CCG) and the VCS, supported by Public Health

The plan aligned the outcomes of the Health and Wellbeing Board, CCG, and Public Health with the West local area priority to improve the Health of residents. It also identified all of the partners with whom Committee could work to encourage and improve communication, engagement and delivery.

West Area Committee has worked hard over the last year to work towards achieving the outcomes on the plan. As well as working with partners to improve pathways and communication, they have financially supported projects to improve health and wellbeing, advocating the Health Champion Programme; Dementia Awareness; Healthy Eating; Increasing Physical activity – the list goes on. They have also attracted match funding from the CCG and Public Health to support delivery to address health priorities.

More recently, as an outcome of both the Health Champion Programme and also the Community Work Club project, it was clear that mental health is a real issue for people within the West (and in fact nationwide). However even more concerning is the lack of engagement by those individuals who are most in need of support. This lack of engagement it appeared, from the feedback received during the Community Work Club lessons learnt feedback, was either fear of the repercussions or lack of awareness. However these communities are opening up to trusted networks – such as their local CA or support groups.

The Area Committee took radical action – they are currently supporting several groups to deliver alternative therapy activities to enable our communities to engage with those who are most vulnerable, in confidence and as part of a trusted relationship, to enable the Area Committee to understand the barriers to engagement and fundamentally onto the road to recovery, lessons learnt from the projects will be used to influence improvements to health pathways – using robust evidence and analysis.

**Maximising Green Spaces** – Neglected green and open spaces across the community are being brought back into use for local people with funding from the West Committee. Voluntary groups, schools, community partners and local groups were asked to identify sites to clean-up; create recreational space, heritage walks, growing or play spaces for everyone to enjoy. The Committee also toured the area and highlighted key sites that they knew their communities would benefit from improvement. The Place Board now reviews the plan every month to ensure good progress is being made.

**Empowering Communities** - As Chair of the West Area Committee, it is also a great privilege to chair the West Voluntary and Community Sector (VCS) Network meetings. These meetings support the sector allowing information to be shared and opportunities to be offered. The VCS Network plays a vital role in the life of the community and they form a key part of the West Area Committee as a partner, alongside the Police and Fire Services. During 2014-2015 the network has gone from strength to strength and we are working closely in partnership to address core issues within the city as well as working together to develop a large-scale community Heritage event to celebrate the heritage of the West, as we remember those who died and the families who suffered during WW1.

Our thanks go to the members of West Area Committee, our partners and officers, Voluntary and Community Sector and our communities – without their hard work and dedication we would not have achieved such positive outcomes. We look forward to working together throughout 2015-2016, building upon our strong foundations and continuing to create opportunities for communities to become more resilient and confident for the future. 1460

# 1 Purpose of Report

1.1 To provide an update of progress against the current year's (2014/15) Place Board Work Plan.

# 2. Background

2.1 Earlier this year the Local Area Plan's priorities associated with Place were referred to the West Place Board to action on behalf of the Area Committee. The Place Board continue to initiate action on those priorities and **Item 3 Annex 1** outlines progress to date.

# 3 Area Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:-
- a. Influencing decisions on services delivered at a local level; and

# 1 Purpose of Report

- 3.2 Area Place and People Boards were set up to support the Area Committee in identifying areas of priority and ensure action in line with those priorities.
- 3.3 Each ward has one elected member representative, whose role it is to liaise with their ward colleagues in between meetings and feedback collective views into the Board meetings. Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision making body and the work / recommendations of the Board will be presented to the Area Committees for final endorsement. To the end of December 2014 there have been 5 clients from the West who have received support under this project, 3 have gone on to start their own businesses and 1 decided</li> </ul>

<ul> <li>not to take the self-employment route but still managed to gain employment (was previously unemployed), the remaining client will start in self-employment in February 2014. Of the 3 new start businesses 2 are hairdressers, 1 is a joiner/handyman and 1 is Property Maintenance.</li> <li>The delivery organisation has been made aware of the West WIRES project and will raise awareness of this project to provide a further referral route.</li> </ul>
<ul> <li>Support for existing businesses –</li> <li>The contract for delivery of the project was awarded to the North East BIC (in collaboration with New Skills Consulting and Pulse Marketing) on the 20th August 2014. The project has 3 stages. Stage 1 is business intelligence, Stage 2 is business diagnostics and Stage 3 is analysis and reporting. Stage 1 of the project was completed in mid- December 2014, this encomposed deals based reports</li> </ul>
<ul> <li>December 2014, this encompassed desk based research in order to pull together the information to produce the business directory.</li> <li>Stage 2 of the project commenced in January 2015 with</li> </ul>
the production of the business diagnostic questionnaire. This will be sent to 100 of the businesses within the directory who are selected as being within a business sector which has potential to diversify into the personalisation sector. The business diagnostic will help to identify i) if there is an awareness of the personalisation agenda, ii) what the appetite within the business sector is to diversify into this sector and iii) the skills gaps and additional support that would be needed in order to achieve this.
<ul> <li>Following the completion of stage 2 of the project, Stage 3 can commence whereby data from the diagnostics will be analysed and the final report will be written up. This will be reported to a People Board later in the year along with recommendations for consideration.</li> <li>Lessons Learnt -</li> </ul>
• Overall, this project which is supporting new business in the West will make a difference to 10 people by giving them the bespoke business support, access to finance and specialist training they need to start a business and also to be able to offer those business services to residents with personal budgets. As a pilot project it will also provide vital learning to the West Area committee (and the wider Council), about the scope and nature of what works and

This will provide an evidence base to underpin any further initiatives around job prospects that may be commissioned in the future.</li> <li>The project to support existing business in the West will provide the West Area Committee with a better understanding of the business make-up within the West through the business intelligence gathered. It will also provide data on the barriers and skills gaps that existing business have that prevent them from diversifying or</li> </ul>
expanding their business. This data in turn could help with a wider understanding of common entrepreneurial skills gaps, which could help with influencing schools and vocational training providers in the delivery of skills linked

	to entrepreneurialism.

# REPORT OF WEST AREA VOLUNTARY AND COMMUNITY SECTOR NETWORK

### 1. Purpose of the Report

1.1 The report provides an update with regard to the West Area Voluntary and Community Sector Network.

# 2. Background

- 2.1 To develop the capacity and influence of the Voluntary and Community Sector (VCS) across the City, Area Networks have been established and delegates represent each Area Network at Area Committee, taking forward issues on behalf of the whole VCS in the area, reporting on area priority delivery by the VCS, and reporting back, providing a two-way flow of communication.
- 2.2 West Area Network delegates will present a report to each Area Committee meeting informing Members of activity, progress, issues and concerns of the sector.
- 3. West Area Voluntary and Community Sector Network (AVCSN) Progress Report The West AVCSN has met twice since the last Area Committee in December 2014.
- 3.1 The West VCSN continue to deliver activities and services which support the Area Committee priorities of Streetscene and Environmental improvements, Activities for Young People, Health and Wellbeing, Job Prospects, Skills & Training and Activities for older persons to reduce social isolation.
- 3.2 In January, the VCSN welcomed the Council's Public Health Practitioner who discussed emotional health and well-being. He informed the group that £31,421 had been allocated by the West Area People Board to support health and mental well-being projects for local residents. He also introduced the Community Mental Health Profile 2014 report, and advised the group that the website provides a detailed breakdown of data for the West area.
- 3.3 The Essence Service delivered a presentation to the group, outlining that it is funded by CCG to assist the quality of life of people who have been diagnosed with Dementia. The service began in September 2014 and work in partnership with the Sunderland Carers Centre. An update on health and social care, and opportunities to improve pathways, was also provided by the City Council's People Directorate.
- 3.4 In February, the Sunderland Carers Centre attended and gave an overview of their work, which is shared across 5 new integrated teams across the city (including one for West). The Centre explained to the group that a variety of carer training is available, and also provided details of a wide range of activities and support given to the many different needs of carer's across the city.
- 3.5 The VCS network has been invited via a small call for projects to be involved in the West Area Heritage Event in May, giving the network an opportunity to showcase the activities being delivered in the West as well as celebrate the heritage of the West area. The network has also discussed the event in detail during each meeting to discuss and gather ideas to ensure the event is well attended and a great success.

- 3.6 The VCS group also considered the selection process for the West Area Committee VCS Representatives, as they are being requested to put forward nominations to replace one network rep. The group will make their decision and appoint the successful candidate at the next VCS meeting on 8<sup>th</sup> April 2015.
- 3.7 The network has also shared and received information which has included:

To address the issue the area has been subject to increased attention as part of a targeted operation. Additional resources dressed in plain clothes and uniform were deployed into the area. The Neighbourhood PC's altered their shift and additional resources from response teams were deployed at times when crimes were being committed. Burglary offences have shown a recent crime spike with OTD's which is garages and sheds. MO's primarily force lock. To address the issue the area has been subject to increased attention as part of a targeted operation. "Op Jive" which has resulted in some excellent arrests and charges. This will also be included within the week of action. Super cocooning has been expanded to incorporate other than dwelling offences which means the neighbourhood team visit every victim and their neighbours giving crime prevention advice. ASB issues within the area of Eden Vale, Beachville Street, Vale Street have been highlighted. NPT are working closely with council, youth providers and liaising direct with residents. All officers working the West area have been tasked with attending the area at key times and it is currently a neighbourhood priority. Council ASB team have conducted lealflet drops, environmental services have increased litter patrols and parking enforcement have also been tasked. Community mediation is currently in the early stages and reported incidents have decreased dramatically.

ASB issues which had risen in and around Somerset Street which are being dealt with by NPT, councillors and partners have shown a reduction of calls. Work is still underway to address social housing in particular private landlords as the increase in recorded calls are centred around one particular street and subjects residing there which has resulted in crime and ASB being committed. Use of the new ASB powers are being utilised to address problem premises and tenants. Youth related ASB is showing a reduction of 17.1%

#### Walk and Talk Budgets

#### 1. Background

- 1.1 Area Committee previously agreed to retain Environment and Street Scene Improvements; Supporting Local Traders and Empowering Communities to improve their neighbourhoods, as local area priorities. One of the processes put into place to continue to support the achievement of these priorities at a ward level, was to align a small amount of SIB funding to each ward (£8k per ward), to support improvements identified through the Walk and Talk programme.
- 1.2 The Walk and Talk programme continues to be incredibly successful and offers the opportunity for ward councillors to be dynamic, flexible and implement small scale people and place based projects, which have a huge positive impact on their local communities.

#### 2. Current Position

- 2.1 The Walk and Talk programme, Area Tour, Trader liaison, and feedback from local residents has identified a number of local environmental improvements that have been delivered across the West area, funded via the walk and talk budget. Further improvements have been identified covering both People and Place based issues which will be considered by Ward members for completion, to continue work towards meeting the local area priorities and issues identified by residents.
- 2.2 The improvements that have been completed and those identified for consideration will use the remainder of the walk and talk budgets, completed and proposed programmes were summarised in December Area Committee.

#### 3. Recommendation

- 3.1 In order to continue to support improvements identified through the walk and talk programme, area tour and those identified by residents and traders, funding will need to be identified to deliver these improvements.
- 3.2 Consider the alignment of funding to support the delivery of local People and Place improvements that are additional to the core offer of the Council.
- 3.3 Consider the extension of the 'Walk and Talk' programme funding at a ward level and align additional funding accordingly.

#### West Health - Joint Working with the CCG

#### 1. Background

- 1.1 As part of the process to establish Area Priorities for 2014/2015, the West People and Place Boards developed a Health Plan on Page, in partnership with the Clinical Commissioning Group and the VCS, supported by Public Health and People/Place Services generally.
- 1.2 The West Health Plan on Page was approved by West Area Committee at its April 2014 meeting. The plan aligned the outcomes of the Health and Wellbeing Board, Children's Local Area Board, HHAS Plan, CCG, and Public Health with the West local area priority to improve the Health and Wellbeing of residents. It also identified all of the partners with whom Committee could work to encourage and improve communication, engagement and delivery.
- 1.3 The key areas within the plan on a page are as follows:
  - Access to health professionals and services
  - Mental Health and Wellbeing
  - Teenage conception rates
  - Obesity and healthy lifestyles
- 1.4 West Area Committee on 3rd December 2014, following a progress update report from the West People Board, approved £80,000 to support further projects which work towards addressing the key areas, highlighted above.
- 1.5 Mental health and Wellbeing has been the first call for projects with proposals being aligned in February at the People Board.

#### 2. CCG – Match Funding to empower VCS Organisations

- 2.1 The CCG recognises that engaging with partners is critical to prioritising and developing joint solutions for local and city-wide problems, developing and mobilising capacity within communities, influencing how public services are delivered within the resources available. The CCG also recognises that our Area Committees, as local advocates and networkers, continue to be well placed to work with local communities in collaboration with partner organisations
- 2.2 The CCG would like to provide funding to each Area (£20,000 per area) to enable the CCG Locality Commission Groups and Area Committees to jointly fund the local Voluntary and Community Sector (VCS) to deliver projects in the community which provide support for the people in each locality based upon the needs identified within the Joint West Health Plan on a page.
- 2.3 The £20,000 would be matched to the £80,000 already approved by the West Area Committee, giving the West a total of £100,000 to support the VCS to deliver projects which support the delivery of the priorities within the West Health Plan on a page.
- 2.4 The key assumptions to deliver successfully in partnership with the CCG are:
  - Joint agreement between CCG and Area Committee for the priority area for funding
  - CCG are involved in the consultation process
  - Funding available to Voluntary and Community Sector organisations who deliver within the West
  - Scrutiny and Area Arrangements administer and monitor the grants to the voluntary sector
  - Area Committee retains formal governance approval of decisions

#### 3. Outline Benefits, Outcomes and Impact

3.1 It is anticipated that the joint funding will further facilitate the development of better relationships between the CCG, Council and Voluntary sector at a locality level, and funding of innovative ways of working.

- 3.2 It would be difficult to measure the outcomes and impact of relationship building of this in terms of activity but could be reported back via a qualitative process with the staff engaged in the process.
- 3.3 The outcomes and the impact of the funding to the successful voluntary sector groups will be formally monitored by the Scrutiny and Area Arrangements team. The Outcomes and measures will be agreed in advance of the funding and voluntary sector groups will need to demonstrate how they meet any criteria set.
- 3.4 Outcomes and impact reports will be reported to the West Area Committee and CCG Locality Groups and Lessons Learnt will be shared with the Health and Wellbeing Board.

#### 4. Delivery Process

- 4.1 The delivery process will be co-ordinated through the West People Board by the West Area Coordinator and the CCG West Locality Manager, using the existing processes for SIB grant funding.
- 4.2 Sunderland CCG Locality Commissioning Teams will be involved in the process of identification and grant awards.
- 4.3 Advice and input will be sought from Public Health Locality Leads.



#### 4. Recommendations

- 4.1 Note the content of the report.
- 4.2 Consider and agree a recommendation to Area Committee to accept the £20,000 funding from the CCG to support further West VCS organisations to deliver innovative projects to support the delivery of outcomes within the joint West Health Plan on a Page.
