LICENSING SUB-COMMITTEE - 18 JANUARY 2024

LICENSING ACT 2003 – CONSIDERATION OF AN APPLICATION FOR THE GRANT OF A PREMISES LICENCE – 138 NEWCASTLE ROAD, SUNDERLAND

1.0 PURPOSE OF REPORT

1.1 To consider an application to grant a premises licence in respect of the above-mentioned premises brought in accordance with Section 17 of the Licensing Act 2003.

2.0 DESCRIPTION OF DECISION

- 2.1 In considering the application the sub-committee will be mindful of the provisions of section 18 of the Licensing Act as stated in paragraphs 5.2 below.
- 2.2 When determining the application, the Sub-Committee is requested to have regard to the representations referred to in paragraph 4.0 below and to take such steps as they consider appropriate for the promotion of the licensing objectives. The steps may be:
 - a) to grant the application subject to the operating schedule modified to such extent as the Sub-Committee considers necessary for the promotion of the licensing objectives, and subject to the relevant mandatory conditions;
 - b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
 - c) to reject the application.

3.0 INTRODUCTION/BACKGROUND

- 3.1 Members will recall that this matter was scheduled to be considered by the Committee at its meeting scheduled for 24th November 2023. Due to an external matter, the hearing was required to be cancelled due to us not being able to meet quorum.
- 3.2 According to the information provided by the applicant's agent, The premises will be a new convenience store where all types of convenience products will be sold including fresh & frozen food, toiletries, household, newspapers etc. Other services will also be offered to customers such as the ability to pay bills & buy lottery tickets. Alcohol is not the intended focus of the business there is an expectation that alcohol sales will have a limited impact on the area as local people are expected to, on the whole, purchase alcohol along with other products.
- 3.3 A copy of the application form, premises plan and a set of proposed conditions, which will be included in the operating schedule are attached at **Appendix 1.**

- 3.4 For Members' information, the premises is situated on Newcastle Road and was formally Booze Busters. The premises is attached to a parade of hot food takeaway outlets. Plans showing the street view of Newcastle Road and an arial plan of the area are shown at **Appendix 2.**
- 3.5 The application is for sale of alcohol Monday Sunday 07:00 to 03:00 and late night refreshment (hot food and drink) Monday Sunday 23:00 03:00. In summary the confirmed proposed licensable activities and opening hours are detailed as follows:

Licensable Activity	Proposed Hours
Sale of Alcohol Off the Premises	Monday to Sunday 07:00 to 03:00
Late night Refreshment	Monday to Sunday 07:00 to 03:00
Opening Times of Premises	Monday to Sunday 07:00 to 03:00

- 3.6 During the consultation period, a statutory notice was published in the Sunderland Echo on 12th October, 2023. In addition, blue site notices were displayed at the premises for a period of 28 days, allowing for any persons to submit any representations.
- 3.7 In line with the statutory procedure set out in the Licensing Act 2003, a 28-day consultation period was allowed for any representations to be made.
- 3.8 Relevant representations were received from local residents, Ward Councillors and Responsible Authorities.

4.0 CURRENT POSITION

- 4.1 During the statutory 28 day consultation, a number of representations were received in objection to the application by email from local residents. In addition to the objections received, the Licensing Section also received a petition from 71 local residents. Copies of the representations are attached at **Appendix 3.**
- 4.2 On 23rd October, 2023 a representation was received in objection to the application from Sarah Norman, representing Public Health in her role as a Responsible Authority. A copy of the representation is attached at **Appendix 4.**
- 4.3 On 26th October, 2023 a representation was received in objection to the application from Scott Lawrence, representing the Licensing Section in his role as a Responsible Authority. A copy of the representation is attached at **Appendix 5.**

- 4.4 On 26th October, 2023 a representation was received in objection to the application from Councillor Kelly Chequer, cabinet member for Healthy City and Ward member for Southwick. A copy of the representation is attached at **Appendix 6.**
- 4.5 On 27th October, 2023 a representation was received in objection to the application from Northumbria Police, acting in their role as a Responsible Authority. A copy of the representation is attached at **Appendix 7.**
- 4.6 On 29th October, 2023 a representation was received in objection to the application from Councillor Michael Hartnack, Ward member for Fulwell. A copy of the representation is attached at **Appendix 8.**
- 4.7 On 30th October, 2023 a representation was received in objection to the application from Amelia Barker, representing the Environmental Health Section in her role as a Responsible Authority. A copy of the representation is attached at **Appendix 9.**
- 4.8 On 14th November, 2023 Northumbria Police submitted further information in support of their representation. A copy of the information is attached at **Appendix 10**.
- 4.9 Between 17th and 20th November, 2023 emails were exchanged between Mr Lawrence and Ms Sherratt regarding the application and proposed amendments to the application. Mr Lawrence submitted further details regarding this exchange which can be found at **Appendix 11.**

A register of refusals of alcohol will be maintained at the premises. The register will be mare Police and an authorised officer of a Responsible Authority. Notices will be displayed at the entrance/exit to the premises asking customers to leave the residents.



I object in the strongest terms to the above application. I am a resident who lives close to the site.

I object to any alcohol license for these premises for the following reasons:

Background

The last 15 years has seen the parade of shops gain two additional A5 licenses. There are now 3 takeaways in a parade of 5 premises. This has transformed the area into a nighttime economic context. This is a residential area.

Issues

The growth in A5 takeaways alongside a drinks outlet has served as a magnet fir crime and Anti-Social Behaviour. Personally I and others have ceased using these outlets as the incidents of ASB became so pervasivebas follows:

- 1. Youth asking shoppers at the predecessor store Simply Food/Drink to buy alcohol for them.
- 2. Youth getting angry when customers refused to cooperate.
- 3. Large gatherings at the front/rear of the alcohol/tobacco outlet when drink was obtained.
- 4. Specific ASB at the rear of the premise after drink 'had been taken'-commonly urination and even fornication on one occasion.
- 6. Thefts from and threats to the off license staff. Northumbria police were called to this premise on numerous occasions. September 2017 (Sept 2, 2017) witnessed serious threats to staff involving a gun and bladed objects. Attacks, including fatal incidents have increased in Sunderland North.
- 7. The granting of 2 additional A5 licenses in the last 10 years had seen the dramatic increase in vehicle churn, double parking on Newcastle Rd and parking across the junction with Joannah street, making resident access to/from Joannah St difficult and at times dangerous.

The 2 additional A5 licenses have meant all the first storey flats are now used, placing additional pressure on parking around the Parade of shops.

A further busy outlet would add to an already chaotic and at times aggravated atmosphere. There is pre-existing community tension between A5 licensees and the immediate residents around parking, bins, noise.

8. The Council's obesity strategy and Drug/Alcohol Partnership Board precepts sit very awkardly with greater alcohol license granting. There is strong evidence that recurrent volume alcohol intake is highly correlated (CC 0.96) to increased obesity and therefore NHS disease burden. Sunderland Council has an opportunity to be seen to publically

align its specific licensing decisions with it's Policy principles for a safer, healthier Sunderland. (SCC, Strategic Plan, 2020-2025).

There is also a strong correlation between alcohol and poverty (Nayakutsikwa, 2021) in the UK. Alcohol also features in many instances of domestic violence. The latter being a major challenge for Sunderland. There are known, crastrophic links between alcohol, domestic violence and sexual assault (Institute for Alcohol Studies, 2019; Phillipson, 2022).

For those with more controlled drinking, there are drinks outlets within 380 metres of the above site.

The addition of another alcohol/tobacco heavy outlet would go completely against Sunderland City Council's progressive developments towards reduced crime, ASB, domestic violence and obesity.

I do not object to a shop without a drinks license opening. I am pro-business. However, we all have to confront the impact of our decisions if we wish for more cohesive communities.

The proposed opening times of 7.00 am - 3.00 a.m. is outrageous and will be objected to on a number of fronts: it goes against every moral and ethical stance on tackling excessive alcohol consumption; the proposed premises sits at the heart of a residential area and therefore would once again be a magnet for antisocial and criminal behaviour, disturbing the peace and the every day lives of local residents; there are already several shops in the surrounding area that sell alcohol, therefore no more are required.

According to Sunderland Council's own Alcohol strategy Page 30 - there is a clear focus on the four licensing objectives, which are:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

Approving this application would be a direct contradiction of these objectives.

In addition to this our hospitals are pushing awareness of the impact of alcohol related injuries and illness which seems to have heightened on the back of the pandemic -

'We promote and sign post patients in our clinics and are seeing a high number of patients alcohol dependent '

Therefore if the council approves this application they will be adding to the NHS challenges and going against their advice.

This view is upheld by The World Health Organisation (WHO) recommends 'Restrict access to retailed alcohol' in order to reduce the harmful use of alcohol.

Every sensible source of information and advice on alcohol consumption suggests that we should not be providing more opportunities to access and consume alcohol, I would therefore expect Sunderland Council to fully uphold their key objectives and the advice of significant professionals when considering this proposal and support local residents by **rejecting** this application.

Notice of objection to this license application.

- 1. I have lived opposite these shops for approx. 20 years therefore know the problems a shop selling alcohol can bring. Over the years there has been a number of robberies at this shop. Both in 2012 and Sept 2017 the robberies involved firearms. 138 Newcastle Road sits in the middle of a residential area, in very close proximity to a large number of properties. Opening a shop selling alcohol is an opportunity for crime with firearms to return. A violent crime also took place further along Newcastle Road in Nov 20. This involved hammer welding robbers. Residential areas are not suitable for premises that are potentially targeted by this behaviour.
- 2. This small row of shops has parking for approximately 11 cars. There is currently 3 takeaway business already in the row of 6 shops. On an evening the number of delivery vehicles already exceeds the number of spaces available. As a result several vehicles often park on the pavement or at an angle blocking some of the main carriageway. This is a danger to pedestrians and oncoming traffic. There is no more available parking for a further takeaway business.
- 3. Noise pollution. As explained previously, the delivery vehicles are constant well into the evening. As traffic eases on an evening the slamming of car doors and the beeping of horns are an abrupt noise which already interrupts sleep. The possibility of this happening until the early hours of the morning as the planning application is requesting will only increase this occurrence and disrupt residents sleep.
- 4. Thompson Park is opposite this establishment. My property backs onto the park. Drugs are already taken/smoked in the park both during the day and evening time as the smell of cannibis is obvious to everyone around. The opportunity to purchase alcohol until the early hours of the morning with open access into the park will increase anti social behaviour.

Being a resident of Zion Terrace and the fact that this mini-mart is in the heart of the local area, the thought of this premises selling alcohol from 11am to 3am is objectionable, ludicrous and unnecessary and will no doubt become a magnet and drive anti-social and criminal behaviour and will disturb residents not only during the small hours but during the day too.

The new hospital car park and premises will likely be affected too, providing a congregating area and dumping ground for waste bottles and food wrappers, further blighting our local community.

I am asking you to reject the application for 138 newcastle road to hold a licence to sell alcohol and refreshments from 7am to 3am.

This protracted availability of alcohol is not required and unnecessary.

The shop will serve alcohol for 20 hours per day, from very early morning to early hours in the morning and will act as a magnet, drawing people from well beyond the community. Many people visiting these premices at such hours will most likely be already under the influence of alcohol, leading to anti social behaviour and will increase the likelihood for public disorder, damage to property both public and private and place all individuals doing so and in the neighbourhood I live in, at risk.

The local police resources are stretched far too thinly as it is. The premises will become a hot spot for police call outs, taking away vital resources from the rest of the city. Resources nmuch needed for crime prevention and detection.

Alcohol is already available in commercial premises, including an all night garage and 2-3 nearby supermarkets, all of which are open until 10pm, 12am or all night.

I fail to see who is being served by such a proposal, certainly not the local community, and by agreeing this proposal places members of the local community at risk.

The proposal is also for 'late night refreshment' also. There are currently 55 other premises, within a one mile radius of this premises, classed as take aways, currently selling food. This does not include retail premises such as delicatessens, bakeries, or cafes and restaurants. 55 premises is a huge number! The vast majority are selling 'fast food' such as pizza and take away meals.

In 2022, the latest reported figures available for Sunderland, 1 in 4 four-year olds were overweight or obese. However, HALF of our 11-year-olds were overweight or obese!

We are making our Sunderland children fatter! This makes Sunderland far more likely to have overweight and obese children than the national average.

As you know, living with obesity, particularly from an early age, creates huge life issues, and reduces the opportunity for the person to lead a full, productive life. Do we want this for our children here in town? Do we want our children growing into overweight and obese adults not only placing them at massive disadvantage but also placing a massive strain on our health services here in the city.

As you know, a child living in deprivation is also far more likely to be overweight or obese. This is not a 'lifestyle' choice for our children. There are signifies of deprivation within 1 mile of this proposed premices.

I therefore call on you to protect our children from this huge risk, a risk or harm far greater and much more likely to lead to life changing disadvantages, massive ill health and inequality than any other single factor effecting the children of Sunderland.

55 premices have already been given licence to sell fast food within one mile of this proposal. We do not need 56.

I the light of this, can I please ask you to refuse the application on the grounds of the massive increased likelihood of public nuisance and disorder and as a protection for our neighbourhood and those that live in it. Be brave. Do not just think that an empty premises needs filling.

I live at the currently empty premise of this application.

I oppose the application in its entirety from 7 am to 3am to sell alcohol at any time.

I know residents have made objections that the area is residential and it would attract anti-social behaviour, criminal behaviour, disruption to peace and quiet.

I wholeheartedly endorse those objections and want to offer my personal experience of living at 1 Elizabeth St SR5 1ND since 1992 and the impacts and consequences of the licensed alcohol premises with the former occupier Boozebuster which closed qutie a few years ago. Living here has been significantly improved with the absence of alcohol licensed premises within feet of my home.

Anti Social behaviour

Whilst the proprietor will offer you assurances that alcohol would not be sold to the underage, the reality is it does happen. I was approached countless times when Boozebuster was open by teenagers asking me to get them cigarettes (pre vapes) and alcohol which I constantly declined. However, teemagers would ask other adults who willingly do this...perhaps reminisce of their own childhoods and think it's harmless and part of growing up and probably passing through Newcastle Rd and not seeing the tangible consequences of their reckless actions. This was a recurring problem when Boozebuster was open and will repeat again. The list below set out my experience of living near Boozebuster as was;

- Teenagers, either just a handful of gangs of up to several gathering in the back lane between the parade of shops and the back lane between Elizabeth St & Joanna St.
- General anti-social behaviour including foul language and disruptive noise
- Urinating against the side of the gable end of my house or the rear back wall of my home and similarly so the first house on Johanna St.
- I have also had to deal with human excrement up the rear wall of my bathroom adjacent to the back lane. i
- Discarding empty cans and bottles wherever they are left in the back lane or more frequently smashing bottles into fragments on the ground.
- This is more prominent in the summer months and light evenings. I resorted to getting the hose pipe out and spraying the side of my house and the rear back yard wall to deter them from sitting on the ground against either wall. They just moved further down the back lane between Elizabeth St and Johanna St.
- This location to gather in the back lane was once articulated by a disagreeable teenager -best here as less
 chance of being seen whereas the local Thompson park is open / exposed so more chance of being seen by
 family / friends of the family.
- I stopped challenging teenagers. The outcome would either be extremely rude and offensive, or polite and say ok and sometimes when going back into my home followed by bottles being thrown against my home as they hurriedly departed laughing, screaming and swearing at their own antics.

- When 101 is rangthere is never an immediate response from Northumbria police. The call is logged and by the time it's responded to by a phone call the problem that day has gone away and then just repeats again.
- I have on occasions rang 999 because of concern of young girls so paralytic drunk they are staggering around the back lane intoxicated and vulnerable. On one occasion, a young teenage girl was so drunk she couldn't position herself to urinate at the rear of the Windmill Chinese takeaway and wet herself standing up.
- On the note of vulnerability there was a TV programme a few years ago about Northumbria Police based at Southwick police station. One of the crimes they were investigating was the rape of a young woman with learning needs. The Police secured footage from a bus operator showing the man picking her up at the bus stop on Newcastle Rd opposite the Stadium of Light metro station. The man took the vulnerable woman back to his flat on Roker Av where he raped her. The Police were able to secure a prosecution. That location is a few mins walk from 138 Newcastle Rd. There are predators who will exploit the opportunity to molest or hurt vulnerable girls / women intoxicated during prolonged hours of access to alchol.

I understand Sunderland Council has an Anti-social behaviour strategy. All of the behaviours experienced above with the exclusion of the last BP have caused harassment, alarm and distress to myself and other immediate neighbours. Approving this license will result in the same problems for residents with some of the current set of teenagers wanting to obtain alcohol.

I understand Cllr Michael Hartnack has contacted Northumbria Police about reported incidents of anti-social behaviour linked to the former Boozebuster occupier. I'm confident there will be some robust information available to you to consider for this application. .

On a more personal note - the accessibility of alcohol at Boozebuster was a significant factor in my own relationship with my partner who was alcohol dependent. The accessibility back then at Boozebuster was 7 am to 11 pm. My partner was in there at 7 am., latterly resorting to stealing alcohol having no means to pay for it. My partner passed away in Feb 2006 five days short of being 47. I truly believe the immediate availability during those hours was a significant part fuelling the alcoholism. If you can appreciate - a sensitive issue and i'm willing to provide you with more details outside of this email if you want to contact me separately.

Whilst I can appreciate that this could happen anywhere near any premises that have an alcohol license, the constant easy access to alcohol iis a problem across the UK and allowing this from 7am to 03 am will just fuel the problem..

Criminal behaviour

138 Newcastle Rd when it operated as Boozsbuster was subject to multiple robberies over the counter as well as break in's and attempted break-ins. The latter I have reported myself to 999 having been disturbed in the rear bedroom of my home with easy views of the rears premises of 138 Newcastle Rd. I understand Cllr Micheal Harnick has asked Northumbria Police for accurate information. Whilst a robbery is aimed at the premises and proprietor, local people using the store could very quickly be embroiled

I would urge the council to reject the application in its entirety and not grant any alcohol license

whatsoever. The volume of oppositions from the local neighbourhood speak volumes in terms of saying this is not needed and there is no justification for this. There are existing outlets that provide 24 hr access to alcohol at Asda Petrol Station on Thompson rd - a 5 min walk up Grange Park Ave from Newcastle Rd.





As a resident of Newcastle Road I would like to register the strongest possible objection to the insane licencing application for the above premises.

I cannot believe that any right-minded person would believe it was reasonable to want to sell alcohol and "late night refreshments" until 3am every day in a residential area and next to a hospital. What possible reasons or justification could there be for this?

I believe that the previous off-licence at this address suffered from theft, staff being threatened and anti-social behaviour. It has been well publicised on TV that shoplifting and threats to retail staff are on the increase and have become a serious issue, surely the problems previously encountered would be magnified with the proposed opening hours.

For years there have been problems with anti-social behaviour and youths drinking in Thompson Park. I believe that this would be made considerably worse with the availability of alcohol until 3am from a shop opposite the park entrance. I know that the park gates are locked at night but the fence is not particularly high and would not deter the drunken louts that these premises would undoubtedly attract.

There is no doubt that this proposal would lead to an increase in intimidating and anti-social behaviour. Would the already over-stretched police be able to cope or respond to this? Or would the residents just have to put up with it?

There are currently two Pizza takeaways and one Chinese takeaway in this block of only six shops which are open until no later than 11pm.

- Why would there be a need for yet another food outlet (assuming that is what the "late night refreshments" refer to)?
- What "refreshments" would they be selling that decent people would need between 11pm-3am? Or would these refreshments be aimed at the drunken louts who might be a bit peckish after drinking all night?
- What about the increase in litter and waste generated by the proposal? I very much doubt that the louts would bring waste bags with them and dispose of their rubbish appropriately.

I cannot see any possible benefit to the local community by granting this licence. All I can foresee is that this this shop would become a magnet for all sorts of undesirables who will generate problems for the community that currently do not exist.



Public safety


The prevention of public nuisance

Objection from Sunderland City Council's Public Health in relation to the licensing application for 138 Newcastle Road, Sunderland, SR5 1NA

As you may be aware Sunderland has significantly worse outcomes in relation to alcohol harms than the England averages. Data from the Public Health Profiles and Local Alcohol Profile for England demonstrates that in Sunderland there has been a rise in admissions for alcohol specific conditions in 2014/15 Sunderland had a rate of 752 per 100,000 and 2021/22 shows a rate of 1,218 per 100,000, with Sunderland being the second highest in the North-East (991) and significantly higher than the England average of (626).

Our data also demonstrates:

- Admission episodes for alcoholic liver disease (Broad) in Sunderland in 2021/22 was 310.1 per 100,000. This
 is above the North East rate (238.5) and significantly higher than the England rate (154.4). Notably,
 Sunderland had the highest admission episodes for alcoholic liver disease in females in England at 239.3 per
 100,000, with the England value at 99.6.
- Alcohol Admissions for under 18's are also a concern with Sunderland having a rate of 76 per 100,000 compared to the England average of 29.3 per 100,000, this is the third highest rate in the North East
- Alcohol-related mortality in Sunderland for 2021 was 64.4 per 100,000. Sunderland had the highest alcohol-related mortality rates in the North-East (50.4) and was significantly above the England average (38.5).
 Sunderland had the second highest alcohol-related mortality rates for females in England at 36.6 per 100,000, with the England value at 21.3.
- Mortality from chronic liver disease was 22.4 per 100,000 in 2017-2019 (3 year range). The rate for 2021 (1 year range) was 33.7 per 100,000 with Sunderland having the highest mortality rate from chronic liver disease in the North-East (21.6). This is comparatively higher than the second highest in the North East (Durham at 25.4) and significantly higher than England (14.5).

The data above reflects the level of chronic heavy drinking in the population and is most likely to be found in higher risk drinkers and dependent drinkers. Our data also shows that 26.3% of adults binge drink and at ward level Fulwell is has one of the highest rates of binge drinking.

Years of life lost indicate the contribution of alcohol misuse to premature death. Early death from chronic conditions is disproportionately prevalent in lower socio-economic groups and is likely to place demand on health and social care services prior to death. The death of people of working age will additionally impact on productivity.

Potential years of life lost due to alcohol-related conditions for Sunderland in 2020 is shown below

This again is higher than the England average of 500 per 100,000 for females and 1,116 for males.

Our Young People's commissioned drug and alcohol service's data also shows that alcohol is the second highest drug for young people accessing specialist substance misuse and alcohol support.

Based on the evidence above it is my position that granting this license to sell alcohol from 7 am until 3 am would undermine the licensing objective of the protection of children from harm.

My name is Scott Lawrence, Senior Licensing Officer for Sunderland City Council. I am representing the Licensing Authority acting in its role as a Responsible Authority.

As the Responsible Authority for the Licensing Section, I work closely with partner agencies to ensure the promotion of the four licensing objectives.

I chair the Council's Responsible Authority Group (RAG), to discuss Licensing applications that are under consideration and issues with licensed premises in the area. The application for 138 Newcastle Road has been a matter that has been brought to the attention of the group and has caused concern.

The premises was formally Booze Busters, which first held a licence on 4th October, 2005. The licence holder was Wine Cellar Trading Ltd. Licence records show that the company was dissolved. An Interim Authority Notice was submitted in the name of Duff & Phelps Limited, however on 1st May, 2019 the Premises Licence lapsed due to no transfer application being submitted to the Licensing Section.

The Premises Licence for Booze Busters was granted for the sale of alcohol, and the licensable hours were Monday to Saturday 08:00 to 23:00, Sunday 10:00 to 22:30.

I note that the premises sits at the boundary of the Fulwell and Southwick wards and I have reviewed the application against similar licences issued in the area. The licences have been granted for the following licensable hours:

Sainsbury's (not currently open) Unit 1, 110 Station Road - Sale of alcohol everyday 07:00 to 23:00,

Heron, Unit 2, 110 Station Road – Sale of alcohol, Monday to Saturday 07:00 to 22:00, Sunday 10:00 to 16:00.

Maps showing the location of the Fulwell and Southwick ward boundaries, together with location of the above stores and Thompson Park are attached at **Appendix SL1**.

Sunderland has one of the highest rates of alcohol dependencies in the country and having reviewed the application against the Council's Alcohol Strategy, the Fulwell ward has one of the highest rates of binge drinking in Sunderland.

The Southwick ward has the highest rate for alcohol specific hospital admissions between 2017-2021. The Southwick ward also is the third most deprived ward in Sunderland. This demonstrates a link between deprivation and alcohol related harms.

I am also aware that the area that the premises is located have high levels of anti-social behaviour such as vehicle disorder, begging and shoplifting at the nearby Tesco store. There is also youth disorder in Roker Park, around McDonalds and Thompson Park where youths/teens are gathering.

I therefore believe that the application with the proposed hours of 07:00-03:00 and conditions are not acceptable in the promotion of the four licensing objectives, in particular the Prevention of Crime and Disorder and Public Nuisance.

On 17th October, 2023, I sent an email to the applicant's agent, Licensing Matters, expressing concerns with the proposed application. I proposed that the hours for the sale of alcohol should be reduced to 08:00 to 23:00 and proposed a set of amended conditions. A copy of the email exchange is attached at **Appendix SL2**.

Unfortunately, at the time of preparing this representation, the Licensing Section have not received a reply from the applicant and/or their representative.

Therefore, the Licensing Authority in its role as a Responsible Authority fully support the representations made against the application for the grant of a Premises Licence at 138 Newcastle Road, Sunderland and consideration should be given for the refusal of the application.





Objection from Cllr Kelly Chequer – cabinet member for Healthy City and ward member for Southwick in relation to the licensing application for 138 Newcastle Road, Sunderland, SR5 1NA

It must be noted for the purpose of this objection that the location of 138 Newcastle Road, while officially in Fulwell ward, is on the boundary of Southwick ward and the houses directly opposite this location on the other side of the road are actually Southwick ward.

I have been contacted by in excess of 30 residents from Newcastle Road and the streets surrounding including Grange Park Avenue, East Grange, West Grange, Grange View, Netherburn Road, Nawton Avenue, Warmouth Drive and Thompson Road. All of these residents are living within a few hundred meters of this location but are residents of Southwick Ward. It is important to me that Southwick Residents have their views heard on this proposal and I have encouraged people to submit their views independently.

You will also be aware that a petition has been submitted by Robert Woodley on behalf of and with signatories from 71 residents of these streets, objecting to this proposal on the grounds of unsocial behaviour, excessive noise and litter. I will also be organising for this petition to be submitted to the next full meeting of Sunderland City Council on the 15th November 2023.

Most residents are not objecting to the property opening, and none of them wish to have a shop sitting empty. All of the people that have contacted me are concerned simply at the proposed operating hours which include selling alcohol from 7am to 3am and the impact this will have on the local area and the quality of life for local residents.

My request as ward councillor on behalf of residents and as the cabinet member for healthy city which includes protecting residents of Sunderland from alcohol harms, is that this application is considered in line with the appropriateness of these extreme opening hours and the sale of alcohol, in a quiet residential area.

My view is that this application does not consider the residential nature of the area at all, and I support the residents in their concerns regarding the sale of alcohol until 3am and the concerns regarding crime and antisocial behaviour which may accompany this. This has been the case when this premises has previously sold alcohol and residents are concerned at the potential for this to return to what is usually an area of low crime and disorder.

As you may be aware Sunderland has significantly worse outcomes in relation to alcohol harms than the England averages, and Southwick ward has worse outcomes specifically.

Please find information below from public health to support my objection as the cabinet member for healthy city:

Data from the Public Health Profiles and Local Alcohol Profile for England demonstrates that in Sunderland there has been a rise in admissions for alcohol specific conditions in 2014/15 Sunderland had a rate of 752 per 100,000 and 2021/22 shows a rate of 1,218 per 100,000, with Sunderland being the second highest in the North-East (991) and significantly higher than the England average of (626).

Our data also demonstrates:

- Admission episodes for alcoholic liver disease (Broad) in Sunderland in 2021/22 was 310.1 per 100,000. This is above the North East rate (238.5) and significantly higher than the England rate (154.4). Notably, Sunderland had the highest admission episodes for alcoholic liver disease in females in England at 239.3 per 100,000, with the England value at 99.6.
- Alcohol Admissions for under 18's are also a concern with Sunderland having a rate of 76 per 100,000 compared to the England average of 29.3 per 100,000, this is the third highest rate in the North East
- Alcohol-related mortality in Sunderland for 2021 was 64.4 per 100,000. Sunderland had the highest alcohol-related mortality rates in the North-East (50.4) and was significantly above the England average (38.5). Sunderland had the second highest alcohol-related mortality rates for females in England at 36.6 per 100,000, with the England value at 21.3.
- Mortality from chronic liver disease was 22.4 per 100,000 in 2017-2019 (3 year range). The rate for 2021 (1 year range) was 33.7 per 100,000 with Sunderland having the highest mortality rate from chronic liver disease in the North-East (21.6). This is comparatively higher than the second highest in the North East (Durham at 25.4) and significantly higher than England (14.5).

The data above reflects the level of chronic heavy drinking in the population and is most likely to be found in higher risk drinkers and dependent drinkers. Our data also shows that 26.3% of adults binge drink and at ward level Fulwell is has one of the highest rates of binge drinking.

Years of life lost indicate the contribution of alcohol misuse to premature death. Early death from chronic conditions is disproportionately prevalent in lower socio-economic groups and is likely to place demand on health and social care services prior to death. The death of people of working age will additionally impact on productivity.

Potential years of life lost due to alcohol-related conditions for Sunderland in 2020 is shown below

This again is higher than the England average of 500 per 100,000 for females and 1,116 for males.

Our Young People's commissioned drug and alcohol service's data also shows that alcohol is the second highest drug for young people accessing specialist substance misuse and alcohol support.

Based on the evidence above it is my position that granting this license to sell alcohol from 7 am until 3 am would undermine the licensing objective of the protection of children from harm.

Please record the following as an objection to the licensing application IN ITS ENTIRITY for the premises known as 138 Newcastle Road, Fulwell, Sunderland.

As an elected councillor, former senior police officer and resident of Fulwell, I make representation in the strongest possible terms, objecting to the granting of ANY off licence sale of alcohol at the premises known as 138 Newcastle Road, Fulwell, Sunderland.

Sunderland Council's four licensing objectives are:

- The prevention of crime and disorder
- · Public safety
- The prevention of public nuisance
- The protection of children from harm

When the premises subject of this application previously operated as an off licence, I recall being the Deputy Police Commander for Sunderland and responsible for licensing issues across the City. These premises were frequently the subject of serious crime, with many incidents of theft of alcohol, at least one armed robbery and on one occasion I recall, a shop assistant being taken hostage at knifepoint while being forced to hand over the content of the till. The location of a business with such a focus on the sale of alcohol is wholly inappropriate, not only in respect of sales up to 2am or 3am but all sales at whatever time of the day. Coupled with the serious and consistent crime outlined above, were frequent instances of disorder in the streets around the premises - this is a vulnerable and almost isolated area within an established and otherwise tranquil residential area, in which an off licence premises of this type is neither needed or wanted, when alcohol is available for purchase and consumption both on and off premises within such a close proximity to 138 Newcastle Road - eg, The Grange Public House, Tesco Supermarket, Asda Petrol Station, Aldi Supermarket and others.

The proposed opening times of 7.00am - 3.00am is outrageous and will be objected to on a number of fronts: it goes against every moral and ethical stance on tackling excessive alcohol consumption; the proposed premises sits at the heart of

a residential area and therefore would once again be a magnet for antisocial and criminal behaviour, disturbing the peace and the every day lives of local residents; there are already several shops in the surrounding area that sell alcohol, therefore no more are required.

Approving this application would be a direct contradiction of these objectives.

In addition to this, our hospitals are pushing awareness of the impact of alcohol related injuries and illness which appear to have increased on the back of the pandemic -

'We promote and sign post patients in our clinics and are seeing a high number of patients alcohol dependent '

Therefore if the council approves this application they will be adding to the NHS challenges and going against their advice.

This view is upheld by The World Health Organisation (WHO) who recommends, 'The restricting of access to retail alcohol' in order to reduce the harmful impact.

Every sensible source of information and advice on alcohol consumption suggests that we should not be providing more opportunities to access and consume alcohol, I would therefore expect Sunderland Council to fully uphold their key objectives and the advice of significant professionals when considering this proposal and support local residents by **rejecting** this application in its entirety.

Northumbria Police understand that the application is for a convenience store with a premises licence to permit the supply of alcohol and late night refreshment until 03:00hrs daily.

The premises are located on one of the main access roads in and out of Sunderland City Centre within a mainly residential area.

The residential properties are to the front, side and rear of the premises, families with children of school age live in some of these premises.

Within the residential area there are several children of school age and late night noise and disorder could affect their sleep pattern and the ability to concentrate at school.

Residents of the area have concern in relation to the disorder, nuisance, their safety, and harm to children if the premises licence is granted.

Within several meters of the premises there is an NHS Hospital.

The proposed premises are within a block of other commercial properties, all closing before or close to 23:00hrs.

Northumbria Police believe that if this application for a new Premises Licence is granted in its current form it will lead to increased damage, assaults, litter, noise and disorder or the potential of such issues, in the surrounding area.

Northumbria Police would re consider its representation to the granting of the Premises Licence 'For the Sale of Alcohol' and 'Late Night Refreshment' if:-

Due to the premises location the permitted hours of the sale of alcohol, late night refreshment and hours that the premises are open to the public are greatly reduced.

That the following be placed on the Premises Licence as conditions, along with any other conditions that the Licensing Committee consider appropriate, or the applicant proposes to maintain the Licensing Objectives.

The Premises Licence Holder and Designated Premises Supervisor shall ensure that at all times when premises are open for any licensable activity, there are sufficient, competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the Licence and for preventing crime and disorder.

A CCTV system shall be designed, installed, and maintained in proper working order, to the satisfaction of the Licensing Authority and in consultation with Northumbria Police. Such a system shall:-

- Be operated by properly trained staff
- Be in operation at all times the premises are being used for licensable activity
- Ensure the coverage of all entrances and exits to the licensed premises internally and externally
- Ensure coverage of such other areas as may be required by the Licensing Authority and Northumbria Police
- Provide continuous recording facilities for each camera to a good standard of clarity. Such recordings must be retained for a minimum of 28 days and must be supplied to a representative of Northumbria Police or a local authority licensing officer
- During times licensable activities are provided, a member of management or staff will be contactable and trained in the retrieval of CCTV footage with the ability to download relevant footage from any request from Northumbria Police to do so.

Alcohol shall not be sold in an open container or be consumed in the licensed premises.

An incident book must be kept at the Premises and maintained up to date (no later than 24 hours after the incident) at all times and will record the time, date and details of all incidents/complaints of crime and disorder or anti-social behaviour, including those reported to the venue. The incident book will also include any faults with the CCTV system and details of any visit by a relevant authority or emergency service and made available to representatives of Northumbria Police or Local Authority Officer upon request.

All members of staff at the premises shall seek credible photographic proof of age evidence from any person who appears to be under the age of 25 and who is seeking to purchase alcohol. Such credible evidence, which shall include a photograph of the customer, will either be a current passport, photographic full driving licence, or proof of age card carrying the hologram 'PASS' logo or HM Forces ID card.

Notices will be displayed at the entrance, all points of sales and in appropriate areas throughout the premises informing customers and reminding staff that the premises are operating a Challenge 25 scheme.

A refusal register shall be maintained and shall be made available upon request to a representative of Northumbria Police or a local authority officer,

All staff engaged, or to be engaged, in the sale of alcohol on the premises shall receive the following training in age restricted sales:-

- induction training which must be completed and documented prior to the sale of alcohol by the staff member (such training to include the prevention of underage sales, proxy purchasing, sales to drunks, conflict resolution, the Challenge 25 Policy and correct form of ID);
- refresher/re-enforcement training at intervals of no more than 6 months.

Training manuals and all staff documented training records will be kept at the premises available for inspection by an appropriate local authority officer or a representative of Northumbria Police on request.

The licence holder shall consider any request from Northumbria Police to withdraw any brand of alcohol drinks or size of bottle of alcohol. Such request must only be made by the police acting reasonably and based on proper evidence that the sale of such products is detrimental to licensing objectives. The request may only be made by an officer having the rank of Chief Inspector or higher.

No persons carrying open vessels of alcohol shall be served at any time and such persons will be asked to leave the premises immediately.

In placing this representation, Northumbria Police request that consideration should be given to all the above to ensure that the Licensing Objectives are maintained.



I am currently employed by Sunderland City Council, City Development Directorate, as a Senior Licensing Officer.

As the Responsible Authority for the Licensing Section, I work closely with partner agencies to ensure the promotion of the four licensing objectives. The application for 138 Newcastle Road has been a matter that has been brought to the attention of the group and has caused concern and I share their concerns on the matter.

On 26th October, 2023 I submitted a representation on behalf of the Licensing Section in objection to the application.

Following the end of the consultation deadline, a number of email exchanges took place between 17th and 20th November, 2023 between myself and the applicant's agent, Ms Gill Sherratt from Licensing Matters. A copy of the email exchange is detailed in Appendix SLA.

In her emails, Ms Sherratt wished to negotiate the conditions and the hours for the sale of alcohol to the following:

- Hours for sale of alcohol (in store) 07:00 to 23:00,
- Delivery of all goods including alcohol 07:00 to 01:00.
- Delivery of all other goods 07:00 to 03:00.
- The applicant also wished to withdraw the late night refreshment activity from the application

Continuation of statement of:

It was a concern that the applicant wished to operate an alcohol delivery service and this had not referenced on the application form.

Operating an alcohol delivery service poses additional risks for the sale of alcohol and I was surprised to find that the applicant had not initially proposed any conditions in the operating schedule to properly identify, assess and control the potential risks when the application was submitted and therefore the Responsible Authorities had not been able to consider this on the application. There are also concerns with potential noise caused from closing/opening of car doors, sounding horns and possible parking issues from delivery drivers visiting the premises in the early hours.

Therefore, acting in my role as Responsible Authority for the Licensing Section, I am unable to support the Premises Licence application at this time.

In relation to deliveries, to be clear, all goods that are available for sale at the store will be available for delivery, it is not an alcohol focused service. On this point a store is entitled to open 24 hours to sell any non-licensable goods without reference to the licensing system, & a committee will not be able to limit opening hours if licensable activities are not being conducted. That being the case, we must ask the question, if deliveries are already taking place where is the evidence that a bottle of wine or other types of alcohol being amongst the goods will be the cause of disturbing residents?

In addition to the above, applicants and holders of licences have had the automatic right to deliver alcohol to customers since the old 1964 legislation, we do not have to apply for it. It is now a common place activity as people's shopping habits and society generally has changed considerably. As you will know COVID has further changed the way people undertake their shopping forever and delivery of goods is at the centre of that. I accept we should have offered the conditions relating to delivery at the outset and that was an oversight, so apologies for that.

I understand that you have the residents' objections & concerns in the back of your mind, but they are a separate consultee in this process and are making their own feeling known. As a responsible authority I would ask you to consider the rights of a **responsible business owner** to ensure that they are able to operate a viable business, particularly given that the licensing system is a permissive regime. Small independent retailers such as this one does not have the resources of Tesco or Asda, the costs to open and then operate a business of this nature are off the scale as I am sure you are very aware and store owners must provide as many services as possible to cover their overheads. Delivery is now a firm part of those efforts all across England & Wales and at Licensing Matters we deal with thousands of small business owners that have partnerships with companies such as UberEATS and Just Eat **and deliver goods** (including alcohol) from their store without issues.

Given the concessions that our client has now made, the committee will only be dealing with the delivery of alcohol between the hours of 23:00 and 03:00. If you feel unable to support the application in its amended form, and in order to assist the committee in their decision, can I ask that you provide some

evidence to back up your assertions, in line with the requirements outlined in the Thwaites case? I am sure that you have other delivery services for alcohol in the area. Please can you provide details of any complaints or disturbances that have been caused by those services or confirm that there have been no such complaints. I think the committee would be grateful for that information as it will make their consideration of this issue much more meaningful.

If you haven't any information in that regard, I would just refer you to the requirement to approach licensing system as a permissive regime and treat applications with a "light touch". If there is an issue with the grant of this licence for delivery (or any other reason), you have the power to review it.

These are significant concessions and I hope that we can agree on that basis.

I do not want to handle the conversation about conditions until the hours are agreed. If we cannot agree to those we will discuss your representation as a whole at the hearing.

Good afternoon Gill.

Thank you for your emails and your client's compromise on the end time for the sale of alcohol to close the store to customers at 12 midnight. I believe that the proposed amended terminal hour of 12 midnight is not really reflective - as the supply (deliveries) is still 3am.

I note in your email that your client wishes to operate an alcohol delivery service, however after reviewing the application, I cannot see any reference to this or what the provision of late-night refreshment entails.

Operating an alcohol delivery service poses additional risks for the sale of alcohol and I was surprised to find that your client had not proposed any conditions in the operating schedule to properly identify, assess and control the potential risks, however I note from this morning's email that you have now proposed conditions, which generally seem satisfactory. However, your client's proposed condition 1 suggests that alcohol supply between midnight and 7am is by delivery, there is no mention of the terminal hour being 3am.

Please note that there are also concerns with potential noise caused from closing/opening of car doors, sounding horns and possible parking issues from delivery drivers visiting the premises in the early hours.

In terms of the email sent to you on 17th October, would you be able to confirm if your client is in agreement with the conditions I proposed?

Given the concerns raised by the residents and responsible authorities during the consultation in relation to the licensable hours and the lack of conditions proposed to mitigate the concerns during the application process, Licensing would not be able to support the application.

Delivery Conditions

- 1. Between 00:00 & 07:00 the store will close to customers and sales of alcohol between those times will only be by way of a pre-order delivery service.
- 2. All persons responsible for the delivery of alcohol will be trained in all elements of Challenge 25, acceptable identification and identifying people who are drunk. They will also be trained in the process for refusing a delivery in the event of a person being unable to prove their age. Training will be recorded and provided to the authorities for inspection upon request.
- 3. At the time of the order the customer will be informed that the person accepting the delivery will need to provide an acceptable form of photographic ID proving that they are 18 years of age or over in line with the Challenge 25 requirements. They will also be informed that the delivery of alcohol will be declined to a person who cannot prove their age upon request.
- 4. Delivery will only be made to a home or business address given at the time of the order & not to any public place such as parks, roadsides, or landmarks.
- 5. The person making the delivery will make the appropriate ID checks at the door of the address according to the Challenge 25 Scheme requirements.
- 6. The only forms of identification that will be accepted will bear their photograph, date of birth and a holographic mark and/or ultraviolet feature. Examples of appropriate identification include a passport, photocard driving licence, military ID, and Home Office approved proof of age ID card bearing the PASS hologram.
- 7. If a third-party delivery service is utilised they will have in place a written contract showing that an ID check is required by the delivery driver at the point of delivery.



Good afternoon Scott.

As you know the above application is at hearing before the subcommittee next Thursday and I am writing to make an offer to resolve your representation.

Our client has a business model that includes an end time to 3am but in light of the objections he has received, and the concerns people have, he is happy to amend the times for alcohol sales. He does so in the spirit of co-operation and to show partnership working with all parties.

I am sure that you appreciate the licensing system

Is permissive and the correct approach is to permit applications unless there is real & clear evidence why the application or hours should not be granted. Having viewed the representations from all authorities there is a clear lack of evidence being presented, and concerns centre around speculation and broad assumptions about what might happen should the licence be granted. That approach is not in line with the statutory duty (the Thwaites case), to handle an application with a "hands off" approach.

All that said in circumstances such as these, where there is a strength of feeling against an application, we draw on the partnership approach that is another central feature of the licensing system and advise clients to limit what they are asking for, with a view to allowing all to see the impact the licence has in reality.

Our client is happy to take this approach and has asked if we could compromise on an end time to the sale of alcohol and store closure to customers of 12 midnight. He does however want to deliver alcohol as many convenience stores now do, via Uber Eats and Deliveroo until 3am. In providing that service the store will be closed (something that will be reflected in the licence), and so there will be no impact.

I know you have proposed conditions but as I don't have access to those at present (I am currently in the car), I will come back to you on those once I hear from you about the hours. I have looked at them and on the whole, they seem fine, but I do need to sit down and consider them properly.

I hope you are able to agree to the above hours and give our client the opportunity to prove himself to you. Of course, if there were to be any issues, he understands that a review of the licence is something you may well consider.
