# REPORT OF THE DIRECTOR OF COMMUNITY AND CULTURAL SERVICES

## **LICENSING COMMITTEE – 27 NOVEMBER 2006**

LICENSING ACT 2003 – REASONABLE FEE FOR THE SUPPLY OF COPIES OF INFORMATION CONTAINED IN THE REGISTER RELATING TO THE ACT

### 1.0 INTRODUCTION

1.1 The purpose of the report is to request Members to determine a reasonable charge for the provision of copies of information held on the register that the Licensing Act 2003 requires the authority to maintain.

### 2.0 Legislation

2.1 Section 8 (4) of the aforementioned Act states:

If requested to do so by any person, a licensing authority must supply him with a copy of the information contained in any entry in its register in legible form.

2.2 Section 8 (5) of the Act states:

A licensing authority may charge such reasonable fee as it may determine in respect of any copy supplied under subsection (4).

# 3.0 Proposed Fee

3.1 The number of requests being received requesting copies of information relating to the register is increasing. It is therefore proposed that a fee be determined for the supplying of copies of the information continued in any entry in our register.

It is proposed that this fee be set at £10.50. For Members' information, this reflects the fee set by the Government for the supply of a copy licence to a licensee in the event of theft, loss etc of the original and the provision of such a copy is very similar in terms of time expended to the provision of any other copy of information contained in our register.

### 4.0 Recommendation

4.1 Members are requested to:

- i) consider the report and, should they be minded, to agree a fee of £10.50 for the provision of copies of information held in the Licensing Register.
- ii) To delegate to the Director of Community and Cultural Services the authority to determine any further increase in this fee.
