1.0 PURPOSE OF THE REPORT

1.1 To consider an application received from Mr. Mark Eggleston for grant of consent to trade in a designated area in respect of a site situated at Sheepfolds Road (North Side), 3 metres west of junction with North Bridge Street, Sunderland.

2.0 DESCRIPTION OF DECISION (RECOMMENDATION)

2.1 The Committee is recommended to give consideration to the grant or refusal of Mr. Eggleston's application for grant of consent to trade in a designated area as highlighted in paragraph 1.1 above, under the terms of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.

3.0 INTRODUCTION/BACKGROUND

- 3.1 The site has been designated by the Council as a consent street for street trading purposes under Part III and Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982. The Council has discretion to grant such consent "if it thinks fit".
- 3.2 The application is to trade any day upon which a football game is to be played at the Stadium of Light. The proposed hours of trading are three hours before kick off and one and a half hours after the end of the game.
- 3.3 The applicant has indicated that the site is proposed to be used for the sale of Espresso coffee, and other hot drinks and snacks from a custom built Piaggio Ape motor vehicle (see Appendix 1 for details).

4.0 CURRENT POSITION

4.1 Members may recall that they considered an application for street trading consents in this location at their meeting on 29 September 2008. 4.2 The Committee at their meeting on 29 September 2008 initially granted consent to trade at this site to another trader. However, this trader has contacted the Council stating that he does not want to renew his consent to trade.

5.0 REASONS FOR THE DECISION

5.1 Paragraph 7 of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982 allows the Council to grant consent if it sees fit to do so. The Council may impose conditions upon the consent.
