## LATEST LIVE CONSULTATIONS

#### Youth Conditional Caution Code of Practice for 16 and 17 Year Olds

This consultation paper invites views from interested parties on the draft Code of Practice for Youth Conditional Cautions for 16 and 17 year olds that will be piloted during 2009. The Code governs the use of these Youth Conditional Cautions as stipulated by the Criminal Justice and Immigration Act 2008.

Launch Date: Monday 2 March 2009

Closing Date: Monday 25 May 2009

# Designated Teachers for Looked After Children: draft Regulations and statutory guidance

This consultation seeks views on draft Regulations made under section 20(3) of the Children and Young Persons Act 2008. The Regulations set out the qualifications and experience which will be required of designated teachers in maintained schools. Consultation is also taking place on the content of the draft statutory guidance to governing bodies of maintained schools (to be issued under section 20(4) of the Act).

Launch Date: Wednesday 25 February 2009

Closing Date: Wednesday 20 May 2009

#### Early Years Foundation Stage Profile Data Arrangements

This consultation invites views on proposals to:

- amend existing regulations to allow local authorities to collect Early Years Foundation Stage Profile (EYFSP) data and supporting individual child level information from nonfunded early years providers (i.e. providers who only provide services to non-funded children);
- start to use existing powers in the regulations for local authorities to collect EYFSP information from schools which are exempt from registration with Ofsted and who are not funded to provide the free entitlement;
- give a clear statutory underpinning for the cases where some early years providers want to voluntarily pass information about children to their local authority; and
- simplify the EYFSP data collection process for early years providers by building on the existing 'eye-profile' system.

Subject to the views submitted as part of this consultation, current regulations will be amended in mid-2009.
