3. Highlights from 2008/09

Policy Review

- 3.1 Members chose to examine music venues in the City as part of the wider development of the Sunderland Music Strategy. Members invited a number of musical performers to attend the committee and share their own experiences of music venues as well as playing live in Committee Room 1. The Committee also took part in two visits; the first visit took outside of Sunderland to look at music venues in neighbouring localities which included The Sage, City Hall and The Studio in Hartlepool and the second visit took Members to various venues in and around Sunderland. The Review Committee also held a number of focus groups with various stakeholders as part of the evidence gathering process. A number of recommendations were made.

Wellness Pricing Framework

- 3.2 A joint meeting of the Policy and Coordination Review and the Culture and Leisure Review Committees was held on 19 June 2008 and a report received on the Wellness Pricing Framework. Subsequent reports were brought to the Culture and Leisure Review Committee around progress and a final report was received in November 2008 which provided Members with an examination of the Wellness Pricing Structure, including comparisons with other local authorities. The

report also provided information on the review committee's proposed undertaking of an annual review of the pricing policy framework relating to Wellness Centres.

Heritage Update

- 3.3 Heritage is a key area within the region. The Committee heard updates throughout the year on a variety of heritage issues including about Heritage Open Days, Bede's Way Annual Walk, the nomination for World Heritage Status for Monkwearmouth-Jarrow for 2010 and Bowes Railway.

First Annual Sport and Leisure Report

- 3.4 The Committee received its first ever Annual Sport and Leisure report which provided an overview for Members regarding the work of the Sport and Leisure service. The report also highlighted both revenue and capital projects that had recently been completed or were in the planning and delivery process. Projects covered within this report included ActiveSunderland Board, 2012 Olympic Preparations, Tennis Development, Wellness Centres including the pricing framework and The Play Pathfinder. The report was very comprehensive and provided Members with a wealth of information regarding sport and leisure activities in and around the city.

Barnes Park Regeneration Update

- 3.5 The report updated Members on the Parks for People Big Lottery Funding Stage 2 application for Barnes Park. Members were informed that the stage 2 application would now be reviewed by the Heritage Lottery Fund over a four month period, prior to presentation to the Heritage Lottery National Panel on 24 March 2009. If successful, works would commence in Barnes Park in August 2009 (coinciding with centenary of the Park opening in 1909) and completed by spring 2011.

4. Conclusion

- 4.1 The Culture and Leisure Review Committee has delivered an ambitious work programme in 2008/09. Effective planning has enabled consideration of all issues Members wished to look at.
