AMENDMENTS TO PROCEDURES FOR APPLICANTS UNDERTAKING A KNOWLEDGE/LOCALITY TEST AND APPLICANTS FOR THE RENEWAL OF HACKNEY CARRIAGE AND PRIVATE HIRE DRIVERS' LICENCES

1.0 Purpose of the Report

1.1 To inform Members of proposed amendments in the procedures currently relating to applicants undertaking a knowledge/locality test and those applying for the renewal of licences to drive hackney carriages and/or private hire vehicles.

2.0 Description of Decision (Recommendations)

2.1 The Committee is recommended to approve the proposed amendments to the current licensing procedures in that a visual presentation will be made to all applicants undertaking a knowledge/locality test and all applicants for hackney carriage and private hire drivers' licences will be required to complete a declaration that they have read and understood Condition six of the relevant licence.

3.0 Introduction/Background

- 3.1 Members may recall that, at a previous meeting of the Regulatory Committee, a request was made that the current licensing procedures be amended to ensure that all prospective licensees and current licensees are further informed of their obligation regarding condition six attached to the grant of hackney carriage and private hire drivers' licences. Condition six states:
 - "A driver shall within seventy two hours disclose to the Council in writing details of any caution(s) or conviction(s) for any offence(s). The Council will then decide whether the licence should be suspended or revoked, having regard to the offence(s)."
- 3.2 In order to inform more emphatically prospective licensees of their responsibilities once licensed as a hackney carriage or private hire driver, a short visual presentation has been prepared to be shown to all applicants sitting a knowledge/locality test. In addition, a handout will also be given to applicants and they will also be requested to complete a declaration. A copy of the handout and declaration document are attached as Appendix 1. With regard to current licensees, a copy of the declaration which forms part of the presentation will be sent when renewal of their licence to drive hackney carriages or private hire drivers' licence is due.

4.0 Current Position

4.1 Currently, the attention of licensed drivers is drawn to Condition six by placing the following in bold type on the front of a hackney carriage and private hire drivers' licence:-

"YOUR ATTENTION IS DRAWN IN PARTICULAR TO CONDITION SIX OF THE SCHEDULE"

5.0 Reasons for the Decision

- 5.1 To ensure that all licensed drivers are fully aware of the requirement of Condition six and their responsibility to report any caution or conviction they may receive during the duration of their hackney carriage or private hire driver's licence within the time period specified.

In order to comply with this condition a licensed driver must inform the Council in writing within seventy two hours of a conviction or caution.

With reference to fixed penalty notices for motoring offences, the Council must be informed in writing within seventy two hours of your acceptance of such a penalty. It is not acceptable to inform the Council only after the return of your DVLA driving licence following endorsement.
