Minutes of the Last Meeting of the Committee held on 5th March, 2018 Part I

1. RESOLVED that the minutes of the last meeting of the Committee held on 5th March, 2018, Part I (copy circulated) be confirmed and signed as a correct record.

Local Government (Miscellaneous Provisions) Act 1982 – Application for Consent to Trade in a Designated Area – Park Lane near The Borough Public House (Summer Season)

The Executive Director of Economy and Place submitted a report (copy circulated) which sought the Committees consideration of an application for consent to trade in a designated area under Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.

Richard Reading, Trading Standards and Licensing Manager, advised that the location was within an area used as event space and that the previous traders to operate from this site had a condition on their licence to allow the Council to vary the licence to allow the events to take place.

The applicant, Mr Phillips, was in attendance to speak in support of his application. He advised that the van was fitted with solar panels and a leisure battery system so there would be no need for a generator to be used; as such there would be no noise and the energy would be green. He circulated photographs of the restored, sign written van and informed Members of the vehicle's history stating that the vehicle had been built in Paris in 1971 and he had imported it from Paris. He did not want to hinder any events which would be taking place and was happy to move to another location on days where there were events taking place.

Councillor P. Gibson commented that he was impressed by the van and expected it to attract people to Park Lane; he was concerned that there was no waste bin shown in the pictures and Mr Phillips stated that he would have a bin and also would be using biodegradable cups and at closing time he would walk around the surrounding area to ensure that no cups had been dumped.

Councillor Lawson questioned whether Mr Phillips was proposing to have seating; he advised that this was something he had looked at however it was a different consent that was required for the provision of seating.

Councillor Turner asked what snacks would be provided and Mr Phillips advised that they would all be healthy snacks including high protein snacks for gym goers. He felt that there was a lack of provision for healthy snacks in the city and wanted to help people to be able to easily get healthy snacks.

2. RESOLVED that Mr Phillips be granted street trading consent in respect of the location on Park Lane near to The Borough Public House with a condition attached to his licence to allow the Council to vary his licence on days when there were events held in Park Lane.
