To approve the development of a UK City of Culture bid for Sunderland.

Reasons for decision:

A bid for Sunderland to be UK City of Culture would have major economic, social and cultural benefits for the city. Even if the bid is not successful, the evidence from other candidate cities in the past is that the activity would help to drive forward key outcomes relevant to Sunderland seconomic ambitions. The decision will support the development of a bid at the appropriate time (subject to the timetable confirmation from DCMS).

Alternative options considered and rejected:

Do Nothing \square not to proceed with the development of a bid would represent an opportunity for the City missed. The activity involved in competitive bidding can itself generate many positive outcomes (e.g. Durham \square s bi-annual Lumiere Festival resulted from their failed bid, but attracted 175,000 visitors and an estimated £5.8m to local economy in 2013). Therefore, the alternative of not supporting a bid was rejected.
