AIMS OF THE STRATEGY

The strategy will:

- Provide a co-ordinated approach to participation.
- Provide a framework for developing the safe, effective and genuine participation of children and young people across the Children's Trust.
- Embed children and young people's participation into all aspects of the Children's Trust aiming for the highest level of children and young people's engagement.



KEY PARTICIPATION DRIVERS

- The UN Convention on the Rights of the Child
- Every Child Matters
- Statutory guidance states that it is a requirement for the Children's Trust to ensure listening and responding to children and young people becomes an integral part of everyday practice



KEY COMPONENTS

Adopting a shared definition of participation. The proposed definition is: 'Participation is the process by which children and young people influence decision making which brings about change in them, others, their communities and the services they use. It is an ongoing process of active involvement in matters which concern children and young people. Genuine participation gives children and young people the power to shape both the process and the outcome.'


Agreeing a set of HBR Standards (or their equivalent)

INCLUSION – INVOLVING ALL CHILDREN AND YOUNG PEOPLE

- Involving children and young people who are experiencing significant problems.
- Involving children and young people who need additional support
- Involving all children and young people
