- (ii) At the invitation of the Mayor, the Portfolio holder for Resources, Councillor Allan informed the meeting of the Council's recent successes in the Beacon Awards for Digital Inclusion. The Mayor formally accepted the award on behalf of the Council.

- (iv) Councillor Wakefield petition from residents of Houghton stating that they have no confidence in the consultation option appraisal and decision making processes that led to the decision to close Gillis Lane Primary School through the school place planning exercise carried out by Children's Services Director of Children's Services; and
- (v) Councillor P. Dixon petition from residents requiring full public consultation before any changes/ restrictions are implemented in the residential streets surrounding the hospital – Director of Development and Regeneration.

Apologies for Absence

The Cabinet reported as follows:-

1. Councillor Call for Action - Guidance

That they had given consideration to a joint report of the Chief Executive and the City Solicitor (copy circulated) to provide information and draft guidance on new powers for Councillors designed to help them solve problems in their wards which have now been implemented by the Government. The new powers were known as the Councillor Call for Action (CCfA). The report also highlighted how improvements promoted through the emerging Community Leadership Programme would support the Council in approaching CCfA in the most constructive and effective manner.

The report had been referred to all of the Review Committees for further comments on the Guidance.

The Environmental and Planning Review Committee had welcomed the proposals, the Health and Well Being Review Committee had welcomed and noted the report, the Children's Services, Regeneration and Community and Policy and Co-ordination Review Committees had noted the proposals and the Culture and Leisure review Committee noted the report and welcomed the arrangements to hold two workshops to accommodate all Members.

Accordingly the Cabinet had recommended the Council to endorse the amendment to the Constitution as set out in Paragraph 8.2 of the report.

2. Hetton Town Council – Request for a Town Council Charter

That they had given consideration to a report of the City Solicitor (copy circulated) to seek views on a request to enter into a Local Council Charter for Hetton Town Council. The report had also been referred to the Coalfield Area Committee which had noted the proposals.

Accordingly, the Cabinet had recommended the Council to approve and adopt a Town Council Charter for Hetton Town Council.

3. Comprehensive Performance Assessment – Use of Resources – Auditors Judgement 2007/2008

That they had given consideration to a report of the City Treasurer (copy circulated) on the outcome of the Auditors Judgement on the Comprehensive Performance Assessment – Use of Resources.

The Council had been recommended to note the outcome of the Auditors Comprehensive Performance Assessment – Use of Resources – Auditors Judgement 2007/2008.

They had also referred the report to the Policy and Co-ordination Review Committee for consideration and comment.

The policy and Co-ordination Review Committee congratulated the City Treasurer and his Team on maintaining and strengthening the level 4 assessment (performing strongly) but were still mindful of the comments made by the Auditors and endorse the Council's approach to work through them.

Action Taken on Petitions

The Council received the undermentioned report on action taken in relation to petition which had been presented to the Council: -

Petition by residents of Turnstone Drive, Ayton, Washington that the footpath between 35 and 36 Turnstone Drive and/or a diversion of a footpath to the rear of 33 to 49 Turnstone Drive should be closed off/diverted because they allegedly give rise to problems of anti-social behaviour and criminal damage in the area. The petition had been presented to Council by former Councillor Linda Williams on Wednesday 27th February 2008

The Director of Development and Regeneration, following consultation with Ward Councillors for that area, had declined the petitioners' request. However, it had been proposed that petitioners' concerns be addressed by way of mitigation measures, in the form of continuous

maintenance of the plantation area to the rear of 33 – 49 Turnstone Drive and the placement of a camera next to the play area, south of Turnstone Drive. The lead petitioner had been notified of the decision.

Furthermore, we instruct the Chief Executive to commission a permanent memorial to the City's mining heritage with an appropriate ceremony."
