- 1. Why has this report come to the Committee?
- 1.1 To seek the advice and consideration of this Committee on a number of reports considered by Cabinet on 11<sup>th</sup> February, 2009 on budget and service plans for 2009/2010.
- 1.2 Members' views will assist the Council with its service and financial planning arrangements.
- 2. Background and Current Position
- 2.1 The Cabinet, at its meeting on 11<sup>th</sup> February, 2009, gave consideration to the reports of the City Treasurer on:
  - (A) The Final Revenue Support Grant Settlement for 2009/2010
  - (B) The estimated balance of the Collection Fund for 2008/2009 together with the amounts available to the Council and its major precepting authorities for use in setting Council Tax levels for 2009/2010.

And joint reports of the Chief Executive and City Treasurer

- (C) a. The Corporate Improvement Plan 2009/2010 to 2011/2012;
  - b. Capital Programme 2009/2010 including Prudential Indicators and Treasury Management Strategy
  - c. Revenue Budget and Proposed Council Tax 2009/2010
  - d. Draft Council Tax Leaflet 2009/2010

- 2.3 In accordance with the Council's Budget and Policy Framework the reports are referred to this Committee for advice and consideration.
- 2.4 Members will recall that at their meeting on 18<sup>th</sup> September, 2008 the Review Committee endorsed the budget consultation arrangements as set out in a report to Cabinet on the 10<sup>th</sup> September, 2008 and that a programme be submitted for approval to the Review Committee setting out the proposed arrangements for each Cabinet Member to brief the Policy and Co-ordination Review Committee, at its meeting to be held on 19<sup>th</sup> February, 2009 as part of the 2009/2010 budget setting process, on the strategic priorities and corporative improvement objectives within his/her portfolio as set out in the detailed chapters of the Corporate Improvement Plan. A report on the budget planning framework for 2009/2010 was endorsed at the Review Committee meeting on 16<sup>th</sup> October, 2008.
