Apologies for absence were submitted on behalf of Councillors Mullen and Noble.

#### **Declarations of Interest**

Item 3b - Gentoo

Councillor Burnicle made an open declaration in the item as his firm had undertaken contract work for Gentoo.

#### Minutes of the Last Meeting

1. RESOLVED that the minutes of the last meeting of the Committee held on 8<sup>th</sup> December 2021 be confirmed and signed as a correct record.

#### **West Area Committee Delivery Plan 2020-2023**

Councillor Haswell, Chair of the West Area Neighbourhoods and Community Board, presented the report (copy circulated) which:-

i). Presented the West Sunderland Neighbourhood Delivery Plan 2020-2023; and

ii). Provided an update of progress against the Area Priorities associated with the Delivery Plan.

(For copy report – see original minutes)

The Chairman thanked Councillor Haswell for his report and invited questions from Members. Councillor Mann having expressed concern at the condition of the Portsmouth Road Play Area and that the promised piece of inclusive play equipment had not been installed, it was:-

#### RESOLVED that:-

- i) the progress and performance update with regard to the West Neighbourhood Investment Delivery Plan 2020/23 be noted,
- ii) approval be given to the proposals for future delivery as contained within Annex 1 of the report.
- iii). the recommendation of the Board to approve the West Highway Improvements be supported
- iv). the recommendation of the Board to approve the Neighbourhood Capital Improvements and Neighbourhood Fund Highways Improvements Project be supported.

The Committee then received and noted a short video presentation detailing the work undertaken to deliver the various components of the West Area Delivery Plan.

#### **Change in the Order of Business**

The Chairman advised that he would take Item 3d on the Agenda (Northumbria Police Report) at this juncture to allow Inspector Baker to leave the meeting thereafter to celebrate his birthday. The Committee wished Inspector Baker a happy Birthday.

#### **Report of Northumbria Police**

Inspector Baker presented a report of the Northumbria Police Force (copy circulated) which provided the Committee with a community update together with key performance information in relation to the Sunderland West area during the period December 2021 to February 2022.

(For copy report – see original minutes)

Councillor Mann offered her thanks in respect of the Dark Nights campaign which had resulted in a marked improvement in St Anne's ward. She advised that there had been major problems in the area during November which Councillor Tye had also helped to address via Youth Almighty.

Cllr Mann also thanked the Police for their dispersal operations around South Hylton Metro Station but highlighted that Anti-Social Behaviour continued to occur in the shopping area focusing on Iceland in particular. In conclusion, Councillor Mann asked if Inspector Baker could circulate contact details for the West Area Police Team to members of the Committee.

Councillor Crosby highlighted the growing issue of off road 4 wheel drives in Sandhill and asked if the Police would be able to address residents concerns. Inspector Baker advised that Gateshead, South Tyneside and Sunderland were looking at a possible initiative to tackle the problem.

Councillor Greener referred to a recent machete attack in Millfield which she believed to be drug related. Given that drugs were often a gateway to more serious crime she suggested that it was an area which the Police should give a particular focus. Inspector Baker replied that he was unable to comment on this specific case as it was an ongoing investigation however he advised that the Police always acted on intelligence. Councillor Greener further commented on the lack of a visible PCSO in Barnes and the reluctance of commercial businesses to report crime because of the amount of paperwork involved. Inspector Baker replied that currently one of the Area's PCSOs was on sick leave and that the documentation involved in reporting crime was required under Force policy.

With regard to targeting potential hotspots for the Lighter Nights Campaign, Councillor Dunn suggested Barnes Park and potentially Eden Vale.

Councillors Burnicle and Peacock referred to the ongoing issue of arson in Sterling Close and advised that incidents tended to occur within the 7pm to 8pm time frame. Councillor McDonough added that fires were a big problem in Middle Herrington play park and be believed that Youth Almighty would have a presence there this evening as a result. Inspector Baker replied that it was often the case that fires were not reported to the Police and he would raise the issue at LMAPS to find the best way to address the issue.

In response to an enquiry from Councillor Haswell, Inspector Baker confirmed that he would be happy to arrange meet and greet sessions with Ward Councillors.

There being no further comments or questions for Inspector Baker, the Chairman thanked him for his attendance, and it was:-

3. RESOLVED that the report be received and noted.

#### Report of the West Area Voluntary and Community Sector Network

The Network submitted a progress report (copy circulated) which briefed members on issues pertinent to the Committee and the Voluntary and Community Sector.

(For copy report – see original minutes)

Consideration was given to the report presented by Kelly Brougham which highlighted the following VCS Network activity undertaken since its last report to the Committee:-

- i) The receipt of presentations on Crowd Fund Sunderland
- ii) Action to address the results from the recent VCS survey which had shown that people wanted to meet in person and have a large venue with parking. Meetings would be held on Tuesday, Wednesday and Thursday and would be in different locations across the area. Dates would be set in advance and topics informative.
- iii) The receipt of an update from the Sunderland Voluntary Sector Alliance. The update included a summary of actions since their event at Bede Tower, the progress on creating an independent organisation, and Training opportunities. In addition Sarah Lattaway provide an update on the work she has been doing to support West area organisations together with a workshop which focused on the future governance of the VCS Alliance.
- iv) The invitation issued to Local VCS organisations to apply to deliver targeted activities across Sunderland during 2022, within neighbourhoods, to support older residents at risk of falling, to improve their strength and balance and reduce their social isolation and also to deliver targeted activities across the west to support older residents in reducing social isolation and loneliness.
- v) The ongoing collaborative work of organisations from the West area to provide support to vulnerable households in most need with Food, Fuel and Other Essential Needs.
- vi) the attendance of Joanne Laverick at various Strategic and operational meetings with the VCS Alliance.

The Chairman thanked Ms Brougham for her report and invited questions from Members.

In response to an enquiry from Councillor McDonough regarding the uptake of support for the elderly, Ms Brougham and Ms Peverley informed the Committee that initially support would be allocated based on already existing, targeted data. Going forward, use would be made of the Council's intelligence data eg missed bins etc. Regular meetings would be held to ensure the data was being understood correctly. A door to door newsletter drop would be undertaken to highlight the support available.

4. RESOLVED that the report be received and noted.

#### **Report of Gentoo**

Victoria Gamblin, Head of Operations, Gentoo Group presented a report, (copy circulated) which provided the Committee with an update on current Gentoo developments, projects and priorities.

(For copy report – see original minutes)

In addition to the items detailed in the report, Ms Gamblin briefed the Committee on the response to Gentoo's consultation launched in December 2021 on its proposals to build 100 new affordable homes across 3 sites in Farringdon, Grindon and Carley Hill.

The Chairman thanked Ms Gamblin for her report and invited questions from Members

Councillor O'Brien expressed his concerns and objection to the proposals to build 17 homes on the site in Grindon off Gartland Road. He questioned the purpose of the consultation if Gentoo was prepared to press on regardless of the negative feedback received. Whilst acknowledging the need for affordable homes in the city, he also expressed concern that the chosen site was publicly accessible open green space that was not earmarked for housing in the Council's Development Plan.

Councillor Mann thanked Ms Gamblin for her report and in particular welcomed the 'fantastic' developments at Chester Gate and Prestbury Road.

Councillor Peacock advised that he was constantly receiving queries from residents regarding overgrown trees and asked who was the most appropriate contact? In addition he had also received complaints from residents regarding construction vehicles at Chester Gate dragging dirt out into the street. Ms Gamblin replied that he should contact her in the first instance.

Councillor Crosby highlighted the parking problems in Lakeside which had recently caused a fire engine to become boxed in.

Councillor McDonough referred to the rising energy costs and asked if this would lead to rent rises in the future. Ms Gamblin replied that Gentoo's costs would increase in line with everyone else's. Gentoo in common with other Social Landlords reviewed their rents on an annual basis each March.

There being no further questions or comments, the Chairman thanked Ms Gamblin for her attendance and it was :-

Station Officer Nelson presented a report of the Tyne and Wear Fire and Rescue Service (TWFRS) (copy circulated) which provided the Committee with an update on the Service's performance indicators for the period 1st April, 2021 to 1st March, 2022.

The Chairman thanked Mr Nelson for his report and invited questions from Members

In response to an enquiry from Councillor P. Smith regarding the current status of the Phoenix Project, Mr Nelson advised that there was a restructure underway in the Service's Prevention and Education Section. He stated that he would establish who had responsibility for the Project and report back.

Councillor Tye having briefed the Committee on proposals in respect of the Farringdon Hall site, the Chairman thanked Station Officer Nelson for his attendance, and it was:-

## REPORT OF THE CHAIR OF WEST SUNDERLAND NEIGHBOURHOODS AND COMMUNITY BOARD

## West Area Committee Delivery Plan 2020-2023

#### 1. Purpose of Report

- 1.1 This report:
  - a. Provides an annual performance update of the West Neighbourhood Investment Delivery Plan 2020-2023
  - b. Provides an update of progress against the Area Priorities associated with the Delivery Plan, which will be the focus for the West Area Committee during 2022-2023.
  - c. Provides an update on Neighbourhood and Community Board Governance Arrangements for 2022 -2023.

### 2. Background

2.1 Following the approval of the Neighbourhood Investment Plans in March 2020, the West Area Committee has worked together to finalise their Delivery Plans. All priorities have been determined following significant resident consultation via Let's Talk Sunderland.

#### 3. Area Committee and Neighbourhood Investment Plan Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:
  - a. Influencing decisions on services delivered at a neighbourhood level; and
  - b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's City Plan at a neighbourhood level and ensuring maximum impact where necessary, through utilising its own resources.
- 3.2 The Article 10 Neighbourhood Investment Plans were approved at Cabinet in March 2020.
- 3.3 It is now the responsibility of each Area Committee to deliver their agreed priorities to support the delivery of the Neighbourhood Investment Plan. Area Committee Delivery Plans have been developed to enable this to happen.
- 3.4 The Neighbourhood and Community Board will be Chaired by the Vice-Chair of the Area Committee. Neighbourhood and Community Board meetings will be held in July, November, February and April and dates are included in the council diary. If required, the Board may convene a further meeting(s) should there be a business need to do so and essential to ensuring delivery of the Area Neighbourhood Investment Plan Delivery Plan. All Committee members are invited to attend all board meetings.
- 3.5 Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision-making body and the work / recommendations of the Board will be presented to the Area Committee for final endorsement. The Area Committee Chair and Vice-Chair were agreed at Annual Council in May 2022.
- 3.6 For information, other local groups / boards where West Area Committee has an Elected Member representation are outlined below: -

## 4. Neighbourhood Investment Delivery Plan 2020-2023- Areas of Key Action/Progress

- 4.1 The Plan, which includes an introduction from the Chair of the Area Committee, commits to a significant number of priorities, which are being delivered within the West area of Sunderland, to address the key issues raised by residents. The Plan is monitored by the Area Committee and actions will continue to be addressed up to 2023, via the West Neighbourhood and Community Board.
- 4.2 Residents will be able to review the Area Committee Delivery Plan and monitor delivery of the plan via the Council's website which is available to access at www.sunderland.gov.uk, as well as through Area Committee update reports. Funding to support delivery of the plan has been allocated and further information can be found at **Item 4 Area Budget Report**
- 4.3 Progress against the Delivery Plan has been reported regularly to Neighbourhood and Community Board and Area Committee. Good news stories and promotion of projects and local information have been posted on the West Sunderland Community facebook page. An overview of some key statistics and achievements from 2021/22 is contained in **Annex 3** year in numbers, and **Annex 4** Communications Plan.
- 4.4 Outlined below is a summary of the key areas of action/progress of the Board up to June 2022.

Parks and Open Green Spaces	The Assistant Director of Community Resilience attended the July board and provided an update on Parks and Open green spaces and the capital investment proposals. A further update was provided at the April board, all improvements are progressing. Work continues to be delivered with further improvements and updates being provided to future Board meetings.
Continue to develop ward based projects that utilise the Walk and Talk budget	The West Neighbourhood and Community Board are making a recommendation to Area Committee to allocate £120,000 of Neighbourhood Funding to Walk and Talk. This will increase each wards budget by £20,000.  The aim of this proposal is to build on the previous phases of the successful Walk and Talk which supports local Ward Councillors to find solutions to environmental issues and community-based issues at a local level.  Total NF funding requested is £120,000
Continue to receive updates from the Clean and Green Project and the	Environmental improvements/litter picks and community activities have been delivered across all wards. The steering group met in November and agreed a refreshed action plan for

Voluntary Community Sector on community litter picks and environmental projects and ensure they advertise opportunities for residents/schools etc to get involved.	2022. Work continues across the West with Volunteering opportunities being promoted across the Wards. The Clean and Green team were actively involved in the Great British Spring Clean. Over 90 Volunteers worked with Clean and Green to collect 100 bags of rubbish and fill 4 van loads. The steering group met again in June 2022 and consideration is being given to future delivery. Ward meetings will take place to help shape what is required.
Develop plans for a West wide in bloom delivery	The Neighbourhood and Community Board launched a Call for Projects for applications for The Keep Sunderland West Tidy Programme which were approved at September Area Committee. Projects are delivering across the West. Opportunities involving local residents are promoted on the West Area Facebook page, individual project Facebook pages and within each centre and local area. Since awarding the funding 60 litter picks have taken place and over 1400 volunteer hours achieved.
To understand more about the Enforcement measures and opportunities to enhance in the West to encourage more to 'Love where you live'	The West Enforcement project has begun the recruitment process and has placed the order for the CCTV cameras. The workers are now in post and updates will be provided to a future Neighbourhood and Community Board meetings. All Neighbourhood Wardens have been provided with information in relation to Community Provision for signposting including Youth activities.
Work with and support our VCS and community hubs and support and build capacity at a grassroots level.	The VCS has continued to be supported by the Area Committee. The VCS Network continues to be supported to ensure they have access to all internal and external funding opportunities. The Sunderland VCS Alliance has now been established and updates provided to members at the September Board meeting. The West Community Support worker is now in post. A task and finish group has taken place to discuss this priority. A 'taking stock' survey is being completed by the VCS with support from Sunderland VCS Alliance, with findings being reported to a Task and Finish group.
West Area Committee funded a large-scale event for 2022- delivered by Youth Almighty Project	The event is due to take place 30 <sup>th</sup> June, 1 <sup>st</sup> and 2 <sup>nd</sup> July. Over 700 school children will be attending the school only days with thousands expected on the Saturday. The theme of this year's event is Let's get Digital, with a variety of activities being planned to engage young people and families. The links to the Stephenson Trail will also form part of the activities.
Receive updates on Holiday hunger activities delivery across 2019-2022.	Youth groups from across the West have submitted expressions of interest to deliver activities that fill the gaps of other externally funded activities. These applications are detailed in Item 4 Annex 1 of the Area Committee papers.  Total NF funding requested is £29,824

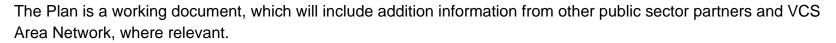

#### Neighbourhood and Community Board – Terms of Reference

The Neighbourhood and Community Board is a working Board of the Area Committee for the delivery of the Area Neighbourhood Investment Plan – Delivery Plan.

#### Membership and Role

#### Chair

- The Chair of the Neighbourhood and Community Board is also the Vice-Chair of the Area Committee. Should the Vice-Chair be unable to chair the Board, the Board will be chaired by the Area Committee Chair
- The content and order of items on the agenda and the amount of time allocated to each item will be set in consultation with the Board Chair, who will ensure that the activities of the Board are contributing to the delivery of Area Committee priorities / Neighbourhood Delivery Plan.
- The Chair will progress matters and make recommendations to the Area Committee where necessary together with regular progress reports on the work of the Neighbourhood and Community Board.
- The Chair will highlight issues and opportunities to the Neighbourhood Community Board, Area Committee and relevant Portfolio Holder.

#### **Elected Members**

- Attendance of the Neighbourhood and Community Board is open to all Ward Members
- Members will adopt a fair and equitable overview of the Area and ensure that Neighbourhood and Community Board activity is based upon evidence of need and opportunity.

#### **Support Officers**

**Relevant Council Officers** - will attend the Board as the link between their service and the business of the Board, as and when required.

**Designated Area Community Development Lead**— supports the Chair of the Neighbourhood and Community Board in delivering priorities; ensuring links are made to the Area VCS Network and wider partners where relevant.

**Governance Officers** - will provide governance advice and administrative support for all meetings of the Board, which will include arranging meeting times /venues and action points.

#### Frequency

Neighbourhood and Community Board meetings will be held in July, November, February and April and dates included in council diary. If required, the Board may

convene a further meeting(s) should there be a business need to do so and essential to ensuring delivery of the Area Neighbourhood Investment Plan Delivery Plan.

#### **Reporting Arrangements**

The Neighbourhood and Community Board will report four times per year to the Area Committee (meetings are held in June, September, December and March) through both oral and written reports presented by the Chair of the Neighbourhood and Community Board, assisted by the designated Area Community Development Lead.

## Remit of the Neighbourhood and Community Board

The remit of the Neighbourhood and Community Board is to:

- Respond to all priorities in the Area Neighbourhood Investment Plan Delivery Plan as agreed by the Area Committee
- Agree to the development / implementation of plans for each priority and make recommendations to the Area Committee based on information and research.
- Ensure that the use of Area Committee resources reflect the priorities of the Area Committee and support the delivery of the City Plan at a local level and as detailed in the Area Neighbourhood Investment Plan Delivery Plan as agreed by the Area Committee
- Work with partner agencies, particularly the VCS, to ensure the delivery of the City Plan at a local level and as detailed in the Area Neighbourhood Investment Plan Delivery Plan as agreed by the Area Committee
- Receive monitoring information in relation to expenditure from agreed funds e.g. Community Chest, Neighbourhood Fund and Neighbourhood Investment Plan Capital.
- Recommend applications for funding from the Council's Neighbourhood Fund and Neighbourhood Investment Plan Capital to the Area Committee for approval.

The Board has no formal decision-making authority on operational matters or budget expenditure but acts as an informal discussion forum making recommendations to the Area Committee. Where necessary, a majority vote will be required to carry forward any recommendation(s) to the Area Committee.

#### REPORT OF WEST AREA VOLUNTARY AND COMMUNITY SECTOR NETWORK

### 1. Purpose of the Report

1.1 The report provides an update with regards to the West Area Voluntary and Community Sector Network.

## 2. Background

- 2.1 To develop the capacity and influence of the Voluntary and Community Sector (VCS) across the City, Area Networks are in place and delegates represent each Area Network at Area Committee, taking forward issues on behalf of the whole VCS in the area, reporting on area priority delivery by the VCS, and reporting back, providing a two-way flow of communication.
- 2.2 West Area Network delegates will present a report to each Area Committee meeting informing Members of activity, progress, issues and concerns of the sector.
- 2.3 The West VCS Network is made up of over 70 local groups, as well as strategic local/national/regional partners. The network meets in the West on a regular basis to share good practice and support one another. The network feeds into a virtual network and feed into and receives weekly updates as part of an information share.

## 3. West Area Voluntary and Community Sector Network (AVCSN) Progress Report

- 3.1 The network met April 2022 and again June 2022. At the April meeting the network welcomed a presentation on the Stephenson Trail from Cultural Spring. At the June meeting the network welcomed a presentation from Actives Families on the Wellbean Machine, Sunderland City Council on the Weed Killing pilot, Youth Almighty on the Barnes Park West Area Event, and Sunderland City Council on the UK Shared Prosperity Fund: Groups also shared details on activities been delivered across the West.
- 3.2 As part of the West Neighbourhood Investment Plan the West Area Neighbourhood and Community Board are working in partnership with a variety of partners including Sunderland VS Alliance and are reviewing opportunities to utilise existing and vacant community buildings and assets to support the creation of cultural hubs, leisure activities and safe places to bring the community together. West VCS groups were asked to complete a Taking Stock Survey. The information gathered from this survey will help identify how Organisations can be supported in running their Centre, and / or Organisation, which could include: providing training, purchasing equipment, funding extra sessions, etc.
- 3.3 A Connectedness event designed by Sunderland Wellbeing Network was held at Silksworth Youth and Community Centre in April. The aim of the event was to connect local people from the area with what is happening in the West area of the city. The event was themed around the five ways for wellbeing connect, take notice, keep learning, be active and give.
- 3.4 West Area Organisations continue to work together to distribute Round 2 of the Sunderland City Council Household Support Funding. The Funding available is to cover the period June to September 2022 to help trusted partners working in communities to support vulnerable households to meet immediate needs and help those who are struggling due to further increases in the cost of living and financial pressures with food, energy, and other essentials. Immediate need does not mean that the household is in crisis or needs to be in crisis to get help.
- 3.5 West Area partner organisations have completed an EOI to continue to address holiday hunger in the West Area. Organisations would like to provide additional activities which will

complement the proposed Holiday Activities and Food funded offer and ensure all school aged children and young people have access to activities and food each school holiday period throughout Summer 2022 until May 2023

- 3.6 Bill Leach West VCS rep has decided to step down as West Rep. The network would like to thank Bill for all of his support over the years. A vacancy for West area rep was advertised to the Network. Nominations came in from 2 people. Both nominee's were asked to introduce themselves and why they felt they were the best person for the role at the network meeting. Network members were then asked to complete a voting slip. The new rep to join the existing reps is Karen Noble of Pallion Action Group.
- 3.7 Our Network representative Joanne Laverick continues to attend various Strategic and operational meetings with the Sunderland VS Alliance.
- 3.8 As part of the West VCS Network report West Area youth providers and Sunderland All Together Consortium have been invited to come along to the West Area Committee meeting and provide an update on the West Youth Activities and West ASB project

#### 3. Update on Neighbourhood Services

3.1 Gentoo achieved the following headline performance during 2021/22:

Although total arrears increased by £52K over the year this is still exceptional performance in the current environment, and this benchmarks very well against our peer group.

Relet times were impacted by Covid in terms of both customers and staff, as we were unable to push properties through as quickly as possible. We are working on this as a key area for improvement during 2022/23.

#### REPORT OF THE NORTHUMBRIA POLICE

# 1.0 Purpose of Report

The following report provides a community update and key performance information in relation to Sunderland West area between the following periods (March 22- May 22)

# 2.0 Key Updates

# **Burglary Dwelling.**

Having just reviewed all the Burglary Dwelling crimes, Sunderland West are still performing very well in this crime category. In the last 2 weeks we have experienced 3 Burglaries, this includes 1 shed or garages, 1 domestic related Burglary and 1 attempt. There are no hot spot areas, and the crimes are wide spread over Sunderland West.

The teams have been very proactive and although the numbers of offences in Sunderland West are already low, they have reduced to only 1 burglary offence in the last 7 days. Since the last period the team have arrested 4 offenders in relation to garage burglaries in the Sunderland South area which has resulted in a significant decrease.

# **Burglary Commercial**

In the last 2 weeks we have experienced 4 commercial Burglaries. There has been a change in the locations which have focussed on shops as opposed to building sites which I reported on in the last period. The teams continue to work closely with partners and have targeted suspects which appears to have had the desired result in preventing further offending. The reality is that this is a low number in comparison with other sectors,

#### Theft from Motor vehicle.

Sunderland West has experienced 2 Theft from motor vehicles in the past two weeks which is an extremely low number. This is borne out by our year-to-date figure which shows a 5.3% reduction in all vehicle crime. I am aware however that within the City Vehicle crime is increasing and as such the team are working towards keeping our numbers low. Most of this needs to be concentrated on education and ensuring people lock their cars.

#### **Anti-Social Behaviour**

Sunderland West is performing very well in this area with a reduction year to date of We are currently tracking at similar levels to 2019/2020 which is where I would expect us to be. The team are working on our lighter nights operations and will be focusing on our hotspots and we have several city-wide initiatives on going at the moment which I am heavily involved in along with a number of varied partners.

Most significantly at present is the old Farringdon Hall Police station which along with McDonalds is a major hotspot for us and the TWFRS and results in numerous complaints. I am aware that the site is subject to planning and that will solve this issue.

# **Lighter Nights Campaign**

The lighter Nights campaign is working very well, with some excellent partnership work between Police, Fire service, environmental services, Local authority and Gentoo. With the exception of North Moor lane we are seeing a reduction in disorder over this period..

#### REPORT OF THE TYNE AND WEAR FIRE SERVICE

# 1. Purpose of Report

1.1 The following report gives Performance Monitoring details in relation to the Local Indicators for Sunderland West Committee area from 1<sup>st</sup> April 2022 to 7<sup>th</sup> June 2022.

#### 2 Background

2.1 At its November 2011 meeting Area Committee agreed that regular updates on Crime and Community Safety would be presented to each Committee meeting.

# 3. Tyne and Wear Fire Service Update

#### 3.1 LI 02 Number of Deaths from all fires

No deaths were recorded during the reporting period.

# 3.2 LI 14 All Deliberate Property Fires excluding Primary road vehicles

There were 4 deliberate property fires, no change from last year. The continued partnership working with Northumbria Police, Gentoo, Sunderland city council and departments within have continued to work in partnership to reduce these incidents with some of the work carried out under the SARA project and similar localised targeting via LMAPS teams.

Some of the partnership work carried out to tackle the rise in incidents at the former police station was successful initially but the problem has raised itself once more. Work including enhancing site security, clearing and reporting refuse collection/uplifts and increased patrols at key times. Unfortunately this is still a continued problem which will only eliminate this long ongoing problem when the site is cleared. To assist in reducing the number of deliberate property fires crews continue to report unsecure premises in conjunction with ASB reporting, the crews have now all been trained in the operation of the Report-It tool.

#### 3.3 LI15 Number of primary road vehicle fires started deliberately

There were 29 incidents reported during this period compared to last year when there were 43. A decrease of 33%. St Anne's and Silksworth saw 7 and 6 vehicle fires respectively over this period. During this period 3 incidents were attended in the area between Hylton road and Portsmouth road and similarly 3 vans in and around Silksworth Lane and Warwick terrace. It is believed that they were not connected in any way, however TWFRS continue to work with Northumbria Police regarding this matter and shall continue to monitor.

# 3.4 LI16 Number of secondary fires not involving property or road vehicles started deliberately

There have been 172 deliberate secondary fires in this area over the report period compared to 48 over the same period last year. This is an increase of 258% over the same reporting period. Pandemic lock downs during some of the reporting periods last year played a part in these figures. Some problematic areas have been Silksworth Ward - 43 incidents in particular the grassed area close to Primate Road, Dr's surgery and former police station site. St Anne's ward 48 incidents - areas such as King George

playing fields rear of Hampstead road, mainly grass or loose refuse fires. Sandhill ward – 33 incidents, the areas of Tay road and Thorney close. Lots of great partner working with local authority, Gentoo, environmental services and Northumbria police. Increased patrols, Joint social media targeting and messaging. Community engagement work with youths has been carried out by crews both following incidents and during patrols. School visit and joint police and fire messaging has been arranged across schools in all of the west wards - parent mail ensuring all parents have been given the information.

# 3.5 LI33 All deliberate Fires (combination of LI14, LI15 and LI16)

There were a total of 183 deliberate fires in this reporting period. An increase of 266% on last Year. This is due to an increase in predominantly ASB activity. Grass fires and loose refuse/rubbish incidents particularly problematic. The continued fires around the former police station, Primate Road have taken up a large amount of time of fire service and partner resources.

The impact of a series of violent storms which the region has suffered is still evident as property fences which not only are being utilised as fire fuel also make property accessible (Springwell surgery). Vehicle fire incidents have decreased. TWFRS are working with Sunderland city council environmental department, Gentoo to tackle loose refuse fires across all areas. Fire crews continue to monitor and report uplifts in the "hot spot areas" the Report-It tool has gone live across the service which is assisting with a faster more stream lined collaborative mechanism. Partnership work (Northumbria police) carrying out targeted patrols and estate visits continues alongside engagement work. Any information regards any type of deliberate fire setting should be reported via the anonymous fire stoppers number.

# 3.6 Community Involvement

The Queens Jubilee celebrations – crews attended several events across the service, Veterans in Crisis celebrated the Jubilee with a Party on 2<sup>nd</sup> June at Lakeside Club. Crews attended along with other blue responders. Our veterans can often be some of our most vulnerable. Information was gathered and safe and well appointments made. Barnes Park community days shall have fire service representation over the 3 day event. Community education and safety information is being delivered alongside our chip pan demonstration unit in conjunction with partner agencies. This will be educating approximately 30 groups of children from several local schools from the west area across the 2 days. The family day (Saturday) an appliance and crew shall be in attendance to engage and educate all ages throughout the day.

Our home Safe and well delivery. Targeting our most vulnerable members of our community. Operational crews from Farringdon have already delivered 143 safe and wells visits across all wards.

TWFRS continues to be involved with the hugely successful SARA project. If there are any

All secondary schools were targeted in the build up to bonfire night with some locations having joint police and fire visits enforcing key ASB and fire safety messages. Planning for this year's activity and targeting shall be starting soon. As Covid restrictions lift, crews are available to support and attend community events.

The Princes Trust based at Farringdon Community Fire Station is now working with the second cohort of young people. Following partner support and attendance alongside our whole time fire crew recruitment campaign we currently have 10 young people from various backgrounds on the programme due to be complete end of July.

The services recruitment campaign has been busy, with personnel from Farringdon station attending several school career fairs, branching out to underrepresented members of the community to enable further representation from underrepresented groups within the fire service. The last recruit's course finished in April. 28 firefighters are now working from their posted stations. 4 of which within our wards.

# 3.7 On-going Issues

Collaboration with Northumbria police and local authority partner's continues to reduce incidents as highlighted in the report. It is essential that any fire related issues are reported to myself, (Andrew Nelson, Station Manager) or using Fire Stoppers 0800 169 5558, so I can action/address with my crews. My watches continue to work close within their respective ward areas to create community links (similar to the Police). The watches continue to deliver ASB initiatives – uplifts, premises security, and educational interaction.

The educational and engagement activities are key to reduce ASB and prevent attacks on emergency services. Over this reporting period there were 11 attacks on crews across Tyne and Wear. All of which were projectiles thrown towards firefighters and or appliances.

#### **Project Description:**

Plains Farm Youth and Community Centre are partner of Sunderland All Together Youth Consortium who are hoping to again receive funding from Together For Children Holiday Activities and Food Program to support to children in the Silksworth Ward who are receipt of free school meals through the below holiday periods.

Holidays and Activities Food (HAF) Funded Offer will be

**Summer 2022** - 4 weeks of face 2 face provision which would cover a minimum of 16 days for 4 Hours

Christmas 2022 - 1 week of face 2 face provision which should be a minimum 4 days for 4 hours Easter 2023 - 1 week of face 2 face provision which should be a minimum of 4 days for 4 hours.

The HAF funded offer is the equivalent of 6 weeks of holiday provision to eligible school aged children.

#### **Our Project**

We know that the school holidays can be pressure points for some families. For some children this can lead to a holiday experience gap, with children from low-income households being:

- less likely to access organised out-of-school activities
- more likely to experience 'unhealthy holidays' in terms of nutrition and physical health
- more likely to experience social isolation

We would like provide additional activities which will complement the proposed HAF funded offer and ensure all school aged children and young people have access to activities and food each school holiday period throughout Summer 2022 until May 2023.

The additional activities we intend to deliver activities are:

- October 2022 1 week of face 2 face provision which will be a minimum 3 days for 3 hours
- Christmas 2022 Provide food hampers to those families most vulnerable
- **February Half Term 2023** 1 week of face 2 face provision which will be a minimum 3 days for 3 hours
- Easter 2023 1 week of face 2 face provision which should be a minimum 4 days for 4 hours
- May half term 2023 1 week of face 2 face provision which will be a minimum 3 days for 3 hours

Our provision will be open to all and will not just target those on free school meals as we know that working families are struggling to with the cost of living.

We will deliver a range of activities centred around enrichment, physical and nutritional education.

#### **Enrichment activities**

We will provide fun and enriching activities that provide children with opportunities to:

- develop new skills or knowledge
- consolidate existing skills and knowledge
- try out new experiences
- have fun and socialise

This will include but is not limited to:

- physical activities, for example football, swimming, table tennis or cricket
- creative activities, for example putting on a play, junk modelling or drumming workshops
- experiences, for example a nature walk or visiting a city farm
- free play, for example fun and freedom to relax and enjoy themselves

#### **Physical activities**

We will a range of provide activities so that children and young people participating in the programme will engage in a variety of types and intensities of physical activity to develop movement skills, muscular fitness and bone strength.

As we are a Streetmarked project with trained activator coaches we will deliver and introduce children and young people to a range of physical street games activities such as smash up badminton, pop up football, dodgeball, street golf, serves tennis and street rugby. We will also deliver archery and soft archery as we have staff who are trained instructors. Introducing new physical activities will enable children and young people to develop a new hobby and develop a sporting habit for life, it will also support with exit strategy.

#### **Nutritional education**

We will include an element of nutritional education in sessions aimed at improving the knowledge and awareness of healthy eating for children.

such as:

- getting children involved in food preparation and cooking
- growing fruit and vegetables
- taste tests
- discussing food and nutrition
- including food and nutrition in other activities

The activities will be designed and delivered in consultation with the children and young people from the ward. They will be delivered on the days and at the times the children and young people most need it.

Christmas 2022 we will provide those families who are most vulnerable with hampers.

We will continue to use our current base, Farringdon Youth and Community Centre to deliver activities from. We will also utilise a number of green spaces to deliver activities such as Middle Herrington Park during the lighter nights and summer months
