

Again the indicator relies on staff turnover, a small comparative sample and people declaring themselves as having a disability. The council will shortly be carrying out a review of its monitoring information to ensure that the figures being reported remain up-to-date.

This indicator relies upon staff turnover, people declaring themselves as having a disability and changes to employees' circumstances. The review of monitoring information for employees self-declaring a disability will ensure that figures remain up-to-date.

There remains some under-representation of Black and Minority Ethnic (BME) staff across the council compared to the BME population in the City of Sunderland (2.1% - 2001 Census). The number of black and minority ethnic staff is unlikely to increase in the near future as the council is not recruiting externally (except in schools).

It was decided that this period has traditionally seen very low visitor numbers, is an expensive time of year in terms of utilities and the museum is already closed for some days due to Bank Holidays. Since the opening of the new wagon shed and sidings area at Monkwearmouth Station Museum in October the Museum has seen its visitor numbers increase every month, which is an improvement on last year. New exhibitions at both venues and an exciting programme of events and activities should attract good numbers of visitors in Q4.

At the end of December 2011, 550 households were prevented from becoming homeless, exceeding our projected target for December 2011. 89 more households have been prevented from becoming homeless in 2011/12 compared to the same period last year. Due to the strong performance in Q4 2010/11, it is unlikely that performance will continue to accelerate into the final quarter of 2011/12 compared to historical trends.

At the end of December 2011, 67 households were accepted as being unintentionally homeless and in priority need, significantly below the projected target of 120 households for December 2011. 79 fewer households have been accepted as homeless in 2011/12 compared to the same period last year.

Total number of additional homes provided (NI154).	411.00	376.00	74.00	31.00	104.00	**	The reduction in the number of net additional homes provided in 2011/12 is due to two main reasons: - Firstly, the number of new build completions across the city has declined from 536 units in the first three quarters of 2010/11 to 358 units in the first three quarters of 2011/12. The rate of new build in Sunderland has been artificially sustained primarily due to the previous Government's affordable housing policies, such as the Kickstart scheme. In 2010/11 407 out of 641 (63.5%) new build properties were developed by the social housing sector. This contrasts with only 178 in 2009/10, which only accounted for 39.9% of all new build completions. In addition, the extra care housing programme in Sunderland has created sites in Hetton, Houghton, Silksworth and Washington which has delivered additional affordable housing schemes over the last several years. Private developers during this period however have not been able to develop and deliver private schemes. The principle factor being the lack of mortgage availability as opposed to the lack of available sites that are ready to develop for housing. Secondly, the number of demolitions in the first three quarters of 2011/12 was 254, an increase of 103% from 126 in 2010/11. This is due to several large regeneration sites across the city being demolished, particularly in the Doxford Park (101 demolitions), Broom Hill (64 demolitions), Castletown (34 demolitions) and Downhill (40 demolitions) parts of the city.
