**1.0 PURPOSE OF REPORT**

- 1.1 The purpose of this report is to request Members to consider an application for street trading consent made by Mrs Celia Bernadette Smith. The location for which the consent is requested is the East side of Hay Street , 18.7m South of its junction with Brooke Street, Sunderland for football matches only. Attached as appendix 1 is a plan showing the proposed trading location.

**2.0 DESCRIPTION OF DECISION**

- 2.1 The Committee is recommended to consider the grant of street trading consent to the applicant to allow them to trade in the designated area as described in paragraph 1.1 above under the terms of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.

**3.0 INTRODUCTION/BACKGROUND**

- 3.1 The proposed site is located in an area which has been designated by the Council as a consent street for street trading purposes under Part III and Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982. The Council has discretion to grant such consent 'if it thinks fit'.

**4.0 CURRENT POSITION**

- 4.1 The application relates to an area located on East side of Hay Street, 18.7m South of its junction with Brooke Street, Sunderland. The applicant has indicated that they wish to use the site to provide hot and cold food and drinks on match days only. For Members' information the site requested has previously been granted street trading consent.
- 4.2 The applicant has applied to trade three hours before and one hour after the football match.
- 4.3 There have been no objections received in respect of this application.

## **5.0 REASONS FOR THE DECISION**

- 5.1 Paragraph 7 of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982 allows the Council to grant consent if it seem fit to do so. The Council can impose conditions upon the consent.

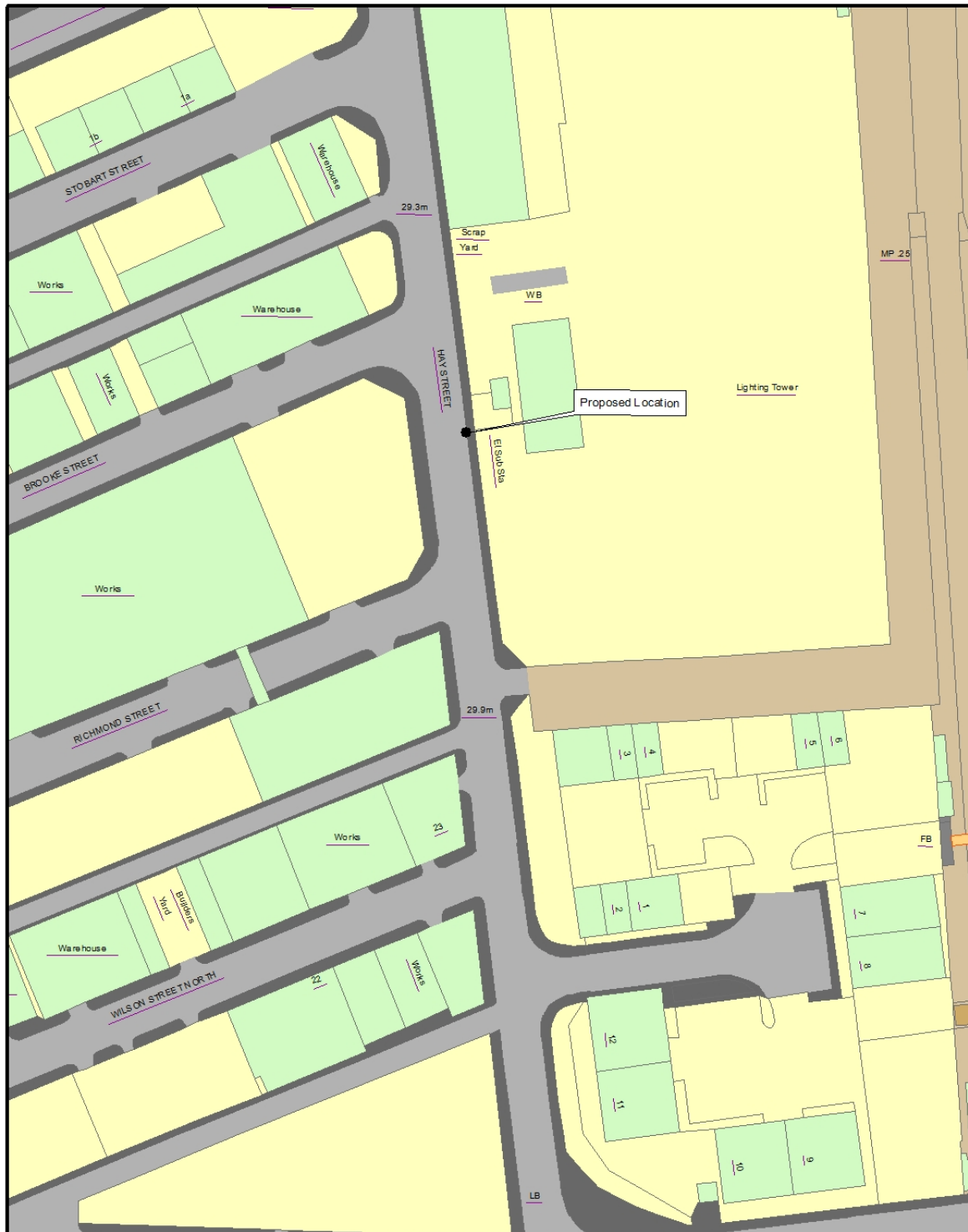
