Peter Noble, a resident of Sunderland, has submitted the following question to be put to the Council meeting on 23 June 2021.

"For over a year, Sunderland & Durham Council have housed homeless at Holiday Inn Washington. Residents have suffered appalling anti-social behaviour including fights, drug dealing, used needles, sex next to a children's park, indecent exposure and most recently a sex offender watching children leave school.

Can the leader of the council explain why sex offenders from across the North East are being housed in Washington South and how he's represented residents concerns over the last year?"

Sharon McCarthy, a resident of Sunderland has submitted the following question to be put to the Council meeting on 23 June 2021.

"Why weren't the residents living on the housing estates close to the Holiday Inn, Ayton consulted prior to sex offenders and convicted criminals being housed at the Holiday Inn by Sunderland Council then subsequently other Councils. Therefore

having their families safety, mental health and wellbeing affected for over 15 months. Can the residents have a guarantee that Councils will no longer use the Holiday Inn for the purpose of housing council referrals?"

Jill Nattrass, a resident of Sunderland has submitted the following question to be put to the Council meeting on 23 June 2021.

"When are Durham Council going to stop using the Holiday inn at Washington, Sunderland to rehouse homeless people including high risk offenders? These people are causing residents nothing but stress. Crime levels have increased significantly in the area. Why should Sunderland residents have to put up with this when Sunderland Council are stopping using this hotel?"
