Report of the Executive Director of Health, Housing and Communities

1.0 Purpose of the Report

To seek approval of the five Area Committee Area Plans for Coalfield, East, North, West and Washington.

2.0 Description of Decision (Recommendations)

- 2.1 Cabinet is recommended to:
 - 1. approve the five Area Committee Area Plans for Coalfield, East, North, West and Washington: and
 - 2. authorise the Executive Director of Health Housing and Communities, in consultation with the Area Committee Chairs to finalise and implement the detailed delivery plans for each of the five Area Plans

3.0 Background

- 3.1 The Council's Constitution (Article 10) states that Area Committees will lead the development, implementation, and effective delivery of an Area Committee Area Plan which includes all main priorities for the area, following approval by Cabinet.
- 3.2 The Council's Constitution states that the relevant Area Committee is to consult, engage and work collaboratively with local people and partners (including the voluntary and community sector, public and private sector) in the effective development, delivery, and implementation of those plans.
- 3.3 The Area Committee Area Plans are 3-year plans and are directly aligned to the themes of the City Plan and wider strategies for the city, with a focus on influencing the delivery of services and activities at a local level, which support and maximise the resilience of its residents and communities.
- 3.4 Through the delivery of the Area Committee Area Plans Sunderland has a real opportunity to transform and create more resilient communities and to influence and enable a positive community impact.

4.0 Area Plans - Development, Implementation and ensuring effective delivery

4.1 Area Committees have held several workshops to discuss and identify key local priorities. In doing so they have:

- I. reviewed previous priorities from their 2020-23 Neighbourhood Investment Plans (from 2023 to be known as Area Committee Area Plans as approved by Cabinet in July 2023) in terms of impact and whether there remains a need to continue to deliver against any of those priorities.
- II. considered current priorities through working collaboratively with services and partners (including the voluntary community sector, public and private sector), and in the context of local data and intelligence and listening to resident feedback and their lived experience; and
- III. ensured the priorities identified in Area Committee Area Plans help to influence delivery of services and activities at a local level which support the resilience of residents and communities.
- 4.2 Council services and partners (currently including Gentoo, Police, Fire, and the Voluntary Sector Alliance) are committed to working in collaboration with Area Committees.
- 4.3 Council Service leads within their Service Plans, have provided their area priorities and area-based programmes. These will form part of the Area Committee delivery schedule and align to the Area Plans. Service leads will provide quarterly updates to Area Committees on the performance and progress of area programmes and priorities. These service area plan schedules will be addendums to the Area Committee Area Plans.
- 4.4 Partners have also provided their plans for investment activity in all five areas for the coming months and years. Partners have agreed that those plans be appended to the Area Committee Area Plans and reported on a quarterly basis.
- 4.5 Area Committees will ensure the delivery of the priorities over the lifetime of the plan (2023 2026), this will include the monitoring of performance of projects funded via Area Committee resources and receiving update reports from council services and partners on a quarterly basis. Additionally, Area Committees will conduct an annual review of performance and priorities at the end of each financial year to ensure priorities remain in keeping with local need.
- 4.6 Area Plans will be monitored and reported to Area Committees on a quarterly basis to ensure that there are robust performance management arrangements in place.
- 4.7 The five Area Committee Area Plans are appended to this report at appendices 1-5 supported with an Integrated Impact Assessment at Appendix 6.

Through the delivery of the five Area Committee Area Plans the Council can develop, design and deliver programmes, services and new investments that will positively impact on crime and disorder, Anti-Social Behaviour and improve community cohesion as well as supporting wider vulnerable groups away from criminal behaviour.

8.0 Financial Implications

Financial provision to support the delivery of the five Area Committee Area Plans is included within the relevant service revenue budget (Neighbourhood Funding) approved as part of the Council's revenue budget for 2023/2024 and within the allocation for Neighbourhood Capital Investment Plan in the approved capital programme. The delivery of the Plans will be managed within this resource. Wider financial support will also be explored from partners or where partners can deliver directly.

9.0 Other Relevant Considerations / Consultations

Co-operative Values – By delivering the five Area Committee Area Plans, the Council demonstrates the values of a co-operative Council by providing better and more resilient neighbourhoods, providing support for those in greatest need and creating more mixed and sustainable communities.

Risk Analysis – The Area Committee Area Plans would sit within a financial and governance framework that would be fully monitored and assessed. All projects in terms of financial viability and risks would be scrutinised.

Legal Implications – The Assistant Director of Law and Governance has been consulted on this report and her comments have been incorporated throughout, where necessary.

Policy Implications – The Council is committed to the Area Committee Area Plans and delivery will align with existing council policy arrangements

Implications for Other Services – Council Services are required to identify Area Priorities as part of the Council's approach to developing Service Plans. Priorities relevant to each area will be appended to Area Committee Area Plans and quarterly updates on performance provided to Area Committees.

The Public / External Bodies – The Council worked extensively and closely

with partners across the city to develop the Area Committee Area Plans as well as to consult with residents. The Council will continue to collaborate closely with partners to ensure the delivery of the plans.
