LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982 APPLICATION FOR VARIATION OF CONSENT TO TRADE IN A DESIGNATED AREA – CROWTREE ROAD, 6.2 METRES EAST OF CROWTREE LEISURE CENTRE AND 32 METRES SOUTH OF THE JUNCTION WITH HIGH STREET WEST, SUNDERLAND

1.0 PURPOSE OF THE REPORT

1.1 The purpose of this report is to request the Committee to consider an application received from Mrs. Melanie Dorrian for variation of consent to trade in a designated area in respect of a site situated on Crowtree Road, 6.2 metres east of Crowtree Leisure Centre and 32 metres south of the junction with High Street West, Sunderland.

2.0 DESCRIPTION OF DECISION (RECOMMENDATION)

2.1 The Committee is recommended to give consideration to the application for variation of consent to trade in the designated area as described in paragraph 1.1 above under the terms of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.

3.0 INTRODUCTION/BACKGROUND

- 3.1 The site has been designated by the Council as a consent street for street trading purposes under Part III and Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982. The Council has discretion to grant such consent "if it thinks fit".
- 3.2 Mrs Dorrian currently holds consent for this location to sell hot and cold food and drink, every day between the hours of 08:00 and 18:00 and, from 17 November to 31 December, between the hours of 08:00 and 20:00.
- 3.3 Mrs Dorrian wishes to vary her consent to enable trading between the hours of 08:00 and 21:00 during the period commencing with the date of the Council's City Centre Christmas Lights Switch On and ending on 31 December.

4.0 CURRENT POSITION

4.1 Mrs Dorrian has held street trading consent in Sunderland City Centre since 1 November 2007. Mrs Dorrian has traded at this site since 1 January 2012. A map showing the trading location is attached as Appendix 1.


