3.4 Please Describe the project:

Over an 11-year period, we have developed the Eastwise publication into a recognised newspaper within the East regeneration area. We have solid connections across the statutory, private, community sectors and individuals, who provide regular contributions towards its contents, which translates to continuing local support for existing publications and demonstrates the desire to play an active part in producing content for local community publishing.

We are seeking SIB funding to enable us to develop skills base amongst local residents and volunteers that will contribute to and help sustain Eastwise. To facilitate the progress of local residents and volunteers into the world of publicity, we are seeking alternative funding to provide tutoring fees to deliver regular training sessions in the locality, and in addition, we have established strong working links with stakeholders such as the University, to make it possible to transfer the skills learnt by mainstream journalism students to local residents and volunteers. By us receiving student who are learning journalism on placements. Those students will be required to engage with local residents and volunteers to share skills and knowledge, thus enabling development of skills that will further develop the learning options for the residents and volunteers who want to get further involved.

If the one off capital payment of SIB is awarded it would allow us to purchase a computer and desktop publishing software (Adobe In Design), and printer/scanner, to compliment and bring additionality to the project by providing hardward for residents and volunteers.

3.5 What service does the organisation currently provide and how will this be complemented by the project?

Hendon 2000 is the publisher of Eastwise community magazine, and a member of the Community Media Partnership, and is committed to increasing the opportunities for local people to actively participate in their local magazine and their community. The project will provide specialist equipment, which will enable this increased participation through skills development, and a taster for potential further progression for interested individuals.

6.1 Describe how the project will be managed:

The project will be managed by Hendon 2000, and the current project manager and staff team will co-ordinate the day to day skills development work.

Eastwise currently is managed by an Editorial Board consisting of interested individuals/residents and representatives of stakeholder organisations in its operating area.

The role of the editorial board is to meet prior to the magazine print date to identify any problems or opportunities arising from that issue, and to discuss matters of policy (e.g. suitability of advertisers etc).

6.2 Are there any significant risks or uncertainties that may affect either the timetable of the project, or whether it achieves its objectives?

There are no significant risks relating to the project which links in with ongoing publishing activity with a well established publication. Should the applications to other funding sources for the revenue elements of the project be unsuccessful then the skills development will be scaled down and take place over a longer timescale, while other sources of funding are explored.

Funding applications have been made to the Community Foundation (£4250) and Awards for All (£8835) for revenue costs relating to extended skills training and development work for volunteers and local people, specifically tutor costs involved.
7.4 What other funding alternates have been considered and why were these not appropriate?
Back on the Map NDC – Back on the Map now funds its own publication, and has no funds available.
Advertising revenue – the generation of advertising revenue is as yet an uncertain source of funding and requires more development work.

The project will go ahead but at a much reduced scale and over an extended period, thus not realising its full potential during the next scheduled development phase of the publication.

The project will enable the development of a skills base amongst local residents and volunteers that will contribute to and help sustain Eastwise. Funding will be sought





to continue with tutoring and working links with stakeholders such as the University will enable skills transfer from mainstream journalism students and local volunteers.
