Ray Bell, a resident of Sunderland, has submitted the following question to be put to the Council meeting on 23 March 2022.

"The bowling greens in Roker Park are an important community asset and are enjoyed by two resident bowling clubs, visiting teams, individual bowlers, and also spectators.. As far as I am aware, the bowling greens in Roker Park are the only two in the city where dogs on leads are prohibited by the PSPO.

This has led to fines being handed out to spectators who knew no better.

The bowling clubs have worked with ward councillors on a petition calling on dogs on leads to be allowed to enter, as is standard in the city. This has had over 200 signatories.

We appreciate that there are legal processes to follow but can the Leader of the Council explain why it is taking so long to secure such a simple and popular change?"
