School Admissions Consultation 2008

In the Children's Plan, published in December 2007, Ministers committed to review the school application and allocation process. The Department consultation outlines proposed changes to make the admissions process for parents as fair, transparent and straightforward as possible. Children and Adoption Act 2006 - Children Act 1989 Contact Activity Directions and Conditions (Financial Assistance) (England) Regulations 2008

This consultation seeks views on the proposed subsidy arrangements to support individuals with the cost of contact activities directed or ordered by the courts. This consultation will run for 8 weeks to allow for the implementation of the regulations by December 2008.

RECENT PUBLICATIONS

Byron Review Action Plan (Published 24 June 2008)

This cross-Government action plan sets out how the recommendations of the Byron Review will be implemented to improve children's safety when they use the internet or play video games.

Young Runaways Action Plan (Published 16 June 2008)

The Department wants to kick-start long-term improvements to services for young runaways. The commitments in this action plan represent the ongoing work across Government to ensure that the needs of young people who run away from home or care are met.

The National Challenge – a toolkit for schools and local authorities (Published 10 June 2008)

The National Challenge will support schools with the lowest GCSE results, so that by 2011 in every secondary school at least 30 per cent of students will achieve five or more GCSEs at A* to C including English and mathematics. The National Challenge will focus greater attention, help and resources on schools that are currently below this benchmark. A School Improvement Strategy, *Promoting excellence for all*, is published alongside the toolkit.

Preventing violent extremism: A strategy for delivery (Published 3 June 2008)

This short booklet explains the Government's plans for countering violent extremism to protect the security of the UK in the long term.
