Mayor's Announcements

(i) Sea Change Awards

The Mayor informed the meeting that the Council had been successful in their bid to the Commission for Architecture and the Built Environment (CABE) Sea Change Fund and had been awarded £1 million.

The award would be match funded with £500,000 from the Council and would go towards the first phase of sea front improvements at Marine Walk in Roker. Members' attention was drawn to a small exhibition in the foyer which gave more information on the project.

(ii) 2009 Local Authority Building Control National Building Excellence Awards

At the invitation of the Mayor, the Portfolio Holder for Safer City, Councillor Denny Wilson, informed the meeting that the Council's Building Control Service had won "Best Healthcare Building Award" in partnership with P and HS Architects and contractor Laing O'Rourke for the development of the Washington Primary Healthcare Centre at Parkway, Washington.

The award reflected the latest recognition of the benefits of partnership between the Council and the development industry and solid working relationships with major clients to ensure the delivery of high quality design and construction both in Sunderland and across the region.

The Mayor then formally accepted the award on behalf of the Council.

Reception of Petitions

RESOLVED that the undermentioned petitions submitted by the Councillors named be received and referred for consideration to the Officers indicated below:-

- (i) Councillor G Hall petition from local residents requesting that officers and Centrepoint abandon the proposed Centrepoint project in Dundas Street, Monkwearmouth – Executive Director of Children's Services.
- (ii) Councillor Oliver petition from residents of Middle Herrington requesting that the Council take action to deal with vehicles parked at the junction of Crow Lane and the A690 Executive Director of City Services.

Apologies for Absence

Apologies for absence were submitted to the meeting on behalf of Councillors Chamberlin, P Dixon, Foster, Leadbitter, Paul Maddison, Peter Maddison, Old, Scaplehorn, J Scott, Trueman, Wake, J Walton and L Walton.

The Cabinet reported as follows:-

1. Second Capital Programme Review 2009/2010

That they had given consideration to a report of the Director of Financial Resources on the outcome of the Second Capital Programme Review 2009/2010 which set out the:-

- reprofiling of projects since the First Capital Review had been reported;
- inclusion of additional schemes and revisions to costs and resourcing for 2009/2010 since the First Capital Programme Review had been reported; and

• overall updated Capital Programme following the Second Review.

They had also referred the report to the Management Scrutiny Committee for further advice and consideration in the context of inclusion of additional schemes for 2009/2010 costing over £250,000. The Scrutiny Committee had noted and supported the proposed additional schemes.

Accordingly the Cabinet had recommended the Council to approve the inclusion of the schemes for 2009/2010 as set out in the extract.

2. FIFA World Cup[™] Bid 2018/2022

That they had given consideration to a report of the Chief Executive (copy circulated) on the City Council's involvement in Sunderland's bid to be a Host City for the FIFA World CupTM in 2018 or 2022 which sought endorsement to continue supporting the application in offering financial resource support with the bid.

Since the Cabinet had received the report, the latest World Cup Circular No. 13 released on 3 November 2009, had confirmed that the Council, if Sunderland was successful in the bid to be a Host City, would be required to contribute £250,000 in May 2010, in respect of the England 2018 Campaign and Marketing costs. It was proposed that this amount be earmarked within the Revenue Budget for 2010/2011 and was, of course, part of the overall costs already identified in the report in hosting the World Cup for Sunderland.

The report highlighted that it was not possible to be definitive regarding the cost implications, but it was clear that costs to be borne by the City would be significant and, based on the latest guidance from FIFA, the estimated costs for the City would be up to £15 million, a major proportion of which would need to be underwritten by the Council.

The Council had therefore been requested to note that much work would need to be undertaken as the competition approached to determine the final estimated cost and, in respect of the Council's contributions, it would be necessary to make provision within the Medium Term Financial Strategy in the years leading up to 2018/2022.

The Cabinet also recommended the Council to note the undermentioned Cabinet decisions to:-

- (i) note the contents of the report and to endorse the submission of the final bid to qualify as a Host City for the World Cup 2018/2022;
- (ii) approve the estimated costs involved in preparing the bid and the potential and actual financial commitments required at this stage and in the future and to approve the proposed funding;
- (iii) authorise the completion of any necessary agreements and for the Chief Executive to take all necessary action; and

(iv) note the Financial, Legal and Risk implications for the City Council.

3. Gambling Act 2005 – Approval of Amendments to the Council's Statement of Principles

That they had given consideration to a joint report of the Chief Solicitor and the Executive Director of City Services on the responsibility of the Council with regard to the adoption of a Statement of Principles under the Gambling Act 2005.

They had also sought the views of the Community and Safer City Scrutiny Committee and persons who might potentially be affected. The Scrutiny Committee had agreed the Statement of Principles and no other comments had been received.

The Cabinet had recommended that the Council approve a revised Statement of Principles in relation to the Gambling Act 2005.

The Leader moved the report of the Cabinet and this was duly seconded by Councillor Anderson.

Members of the Council unanimously expressed support for the FIFA World Cup[™] Bid 2018/2022 and having noted that it would be necessary to make provision within the Medium Term Financial Strategy in the years leading up to 2018/2022, they endorsed the decisions of the Cabinet thereon, and it was:-

RESOLVED that the report of the Cabinet be approved and adopted.
