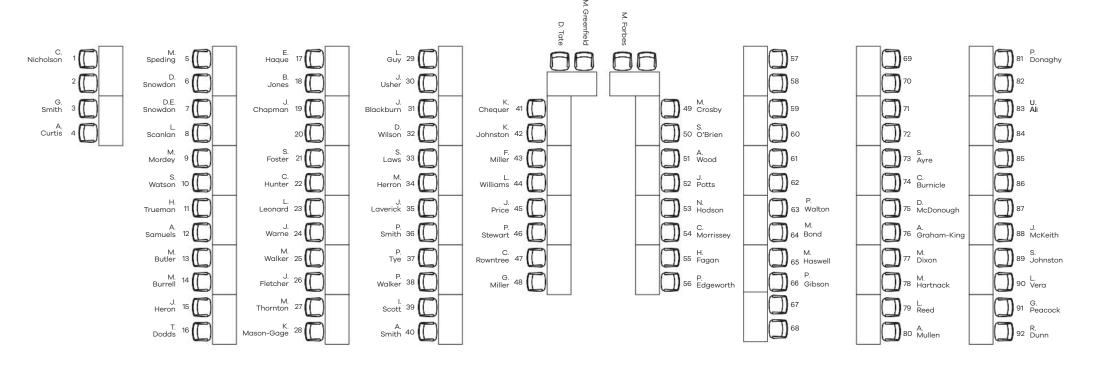

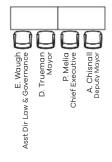

#### Announcements

#### **Former Councillor Alan Wright**

It was with sadness that the Mayor referred to the recent death of former Councillor Alan Wright.

Former Councillor Wright served as a Conservative member of the Council representing St Chad's Ward between May 2008 and May 2012. He served on a number of committees including Planning and Highways and was Vice-Chair of the Environment and Attractive City Scrutiny Committee. He was also Chair of Governors at East Herrington Primary, a governor at Barnes Juniors and Chair of the Barnes Residents' Association. Former Councillor Wright was President of Sunderland Conservatives and Election Agent for Barnes.

The Mayor invited the Council to join her in sending condolences to the family and friends of Alan Wright and in a minute's silence as a mark of respect for their former colleague.

#### Report of the Cabinet

The Cabinet reported and recommended as follows: -

That they had referred the initial proposals on the Revenue Budget to the Scrutiny Co-ordinating Committee: -

 On 12 October 2023, Scrutiny Co-ordinating Committee considered the Budget Planning Framework and Medium-Term Financial Plan 2024/2025 – 2027/2028 report which was referred from the October Cabinet meeting:

The Scrutiny Committee noted the contents of the report including the medium-term financial plan and budget planning framework and was satisfied with the information provided.

The Committee also recommended that serious consideration was once again given to limiting any rises in council tax given the current financial climate and the impact that this would have on residents of the City.

The Committee also acknowledged the work undertaken around the budget consultation and updating the Capital Strategy. The Committee remained committed to budget monitoring through further updates to the Committee and had no further comments to make at the time.

 On 7 December 2023, Scrutiny Co-ordinating Committee considered the Budget Planning Framework and Medium-Term Financial Plan 2024/2025 – 2027/2028 report which was referred from the December Cabinet meeting:

The Scrutiny Committee noted the contents of the report including the medium-term financial and budget planning framework and acknowledged the budget saving proposals as well as the remaining overall budget gap.

The Committee recognised the difficult financial situation that the Council continued to operate within and remained focused on monitoring the budget position through updates provided at the Committee and had no further comments to make at the time.

On 8 February 2024, Scrutiny Co-ordinating Committee considered Budget and Service Reports on Collection Fund (Council Tax) 2023/2024, Capital Programme 2024/2025 to 2027/2028 and Treasury Management Policy and Strategy 2024/2025, including Prudential Indicators for 2024/2025 to 2027/2028 and Revenue Budget and Proposed Council Tax for 2024/2025 and Medium-term Financial Plan 2024/2025 to 2027/2028 reports which were referred from the 31 January Cabinet meeting:

The Scrutiny Coordinating Committee noted and acknowledged the information in the various reports as was presented.

The Committee also acknowledged the financial pressures on the Council and its services as detailed throughout the report and noted the recommended Council Tax increase for 2024/25, which still needed to be approved by Council. The Committee also noted the proposed budget savings proposals within the reports and the outcome of the budget consultation that was undertaken.

Finally, the Committee recognised the work of Officers and Members in preparing the budgetary information presented to the committee and to other key stakeholders and had no further comments to make.

That they had also referred the proposals for Capital Programme Planning 2024/2025 – 2027/2028 to the Scrutiny Co-ordinating Committee: -

 On 7 December 2023, Scrutiny Co-ordinating Committee considered the Capital Programme Planning 2024/2025 – 2027/2028 and Capital Strategy report which was referred from the December Cabinet meeting:

The Scrutiny Committee noted the contents of the report including the overall capital commitments for the coming financial year, as well as the additional capital new start projects.

The Committee had nothing further to add at the time.

That they had also submitted the Treasury Management Policy and Strategy and prudential indicators within the attached report numbered 1 to the meeting of the Audit and Governance Committee: -

 On 2 February 2024, the Audit and Governance Committee was consulted specifically on the Treasury Management Policy and Strategy for 2024/2025.

The Committee noted the Treasury Management Policy and Strategy for 2024/2025 and the Prudential Treasury Management Indicators for 2024/2025 to 2027/2028.

The Committee noted the Borrowing and Investment Strategies contained within the report and that the Council continued to follow and adhere to fundamental principles in relation to the prudent investment of treasury balances. The Committee commended the work of officers in achieving a very positive treasury management performance over a number of years and were satisfied that sound arrangements were in place to enable this to continue.

The Committee noted their responsibility for ensuring effective scrutiny of the treasury management strategy and policies and that they would continue to receive quarterly performance reports.

#### Subsequently;

The following precept figures had been confirmed as those set out in the report to Cabinet on 31 January 2024:

- The precept figures of the Police and Crime Commissioner Northumbria (PCCN) would mean an increase of £13 (7.69%) at a Band D in the precept level for 2024/2025; and
- The precept figures of the Parish of Hetton Town Council would mean an increase of 2% in the precept level for 2024/2025.

The Tyne and Wear Fire and Rescue Authority had supplied its best estimate of their proposed precepts pending their meeting on 19 February 2024 and should any changes to the proposed precepts arise, a supplementary report would be prepared

and circulated. The proposed precept figures of the Tyne and Wear Fire and Rescue Authority (TWFRA) would mean an increase of 2.99% in the precept level for 2024/2025.

The position set out at Item 3 of the report as Determination of Council Tax 2024/2025 reflected the above notified 2024/2025 precept levels in respect of the Precepting Authorities.

#### NOTE:

In relation to the report numbered 2 below entitled "Revenue Budget and Proposed Council Tax for 2024/2025 and Medium-Term Financial Plan 2024/2025 to 2027/2028", Appendix F had not been printed with this item, but the recommendation, which included all of the substantive content of the report, was set out in full at item 3 overleaf.

1. Capital Programme 2024/2025 to 2027/2028 and Treasury Management Policy and Strategy 2024/2025, including Prudential Indicators for 2024/2025 to 2027/2028

That they had considered the attached report of the Director of Finance on:

- the proposed Capital Programme for 2024/2025;
- the Treasury Management Policy and Strategy for 2024/2025 (including specifically the Annual Borrowing and Investment Strategies);
- the Prudential Indicators for 2024/2025 to 2027/2028; and
- the Minimum Revenue Provision Statement for 2024/2025.

Accordingly, the Cabinet recommends the Council to approve: -

- (i) the proposed Capital Programme for 2024/202;
- (ii) the Treasury Management Policy and Strategy for 2024/2025 (including specifically the Annual Borrowing and Investment Strategies);
- (iii) the Prudential Indicators for 2024/2025 to 2027/2028; and
- (iv) the Minimum Revenue Provision Statement for 2024/2025.

## 2. Revenue Budget and Proposed Council Tax for 2024/2025 and Medium Term Financial Plan 2024/2025 to 2027/2028

That they had considered the report of the Director of Finance which was at the following link [Cabinet 31 January 2024] on:

- (a) the overall revenue budget position for 2024/2025;
- (b) the projected reserves position as at 31<sup>st</sup> March 2024 and 31<sup>st</sup> March 2025 and advise on their sufficiency;

- (c) a risk analysis of the Revenue Budget 2024/2025;
- (d) a summary of the emerging medium term financial position facing the Council from 2024/2025 to 2027/2028, and associated Council Efficiency strategy;
- (e) any views received from residents, the local Business Sector, Trade Unions, Schools Forum, Change Council and Scrutiny Coordinating Committee on the proposed budget; and
- (f) the updated City Plan 2024-2035 including the indicative timeline.

The attached report of the Director of Finance to Council set out the proposed Revenue Budget and Council Tax for 2024/2025 and Medium-Term Financial Plan 2024/2025 to 2027/2028 as recommended by Cabinet and updated to reflect the outcome of the Final Local Government Finance Settlement which was published on 5<sup>th</sup> February 2024. The Final Local Government Finance Settlement confirmed an increase in Core Spending Power for the Council of 7.8% based on the Government's assumption of a 4.99% increase in council tax with the ringfenced funding for Social Care confirmed in the Final Local Government Finance Settlement following significant lobbying to the Government through the provisional settlement consultation earmarked for that purpose within contingencies.

Accordingly, the Cabinet recommends the Council to approve: -

- (i) the proposals set out in the report including the proposed Revenue Budget for 2024/2025 set out at Appendix J;
- (ii) the Medium Term Financial Plan 2024/2025 to 2027/2028 including Efficiency Strategy as set out in Appendix G and the potential use of Capital Receipts Flexibility set out at section 9 of the report; and
- (iii) the adoption of the updated City Plan 2024-2035 including the indicative timeline.

#### 3. Determination of Council Tax 2024/2025

That they had given consideration to a report of the Director of Finance making, subject to the approval of the Revenue Budget 2024/2025 (as set out at item 2 above), recommendations with respect to Council Tax levels for 2024/2025, and advising that the Council Tax was calculated using the tax bases for the areas of the City Council and Hetton Town Council as approved by Council on 24 January 2024, and setting out a number of resolutions required to be made to determine the Council Tax, including the confirmed precepts from the Major Precepting Authorities and Hetton Town Council.

They therefore recommended to Council: -

(i) to confirm the council tax requirement for the Council for 2024/2025 for its own purposes is £128,023,844 (excluding Parish precepts) and which

- represents a 4.99% increase in council tax for 2024/2025. It should be noted that this includes the additional ringfenced social care precept of 2%.
- (ii) it be noted that at its meeting on 24 January 2024 the Council approved the following amounts for the year 2024/2025 in accordance with the amended regulations made under Section 31B(3) of the Local Government Finance Act 1992 (the 'Act'):
  - a) 74,484 being the amount calculated by the Council, in accordance with the above regulation of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 as amended by Local Authorities (Calculation of Tax Base) (England) Regulations 2012, as its council tax base for the year (Item T).
  - b) 4,267 being the amount calculated by the Council, in accordance with the regulations, as the amount of its council tax base for the year for dwellings in the area of the Parish of Hetton Town Council.
- (iii) That the following amounts be calculated by the Council for the year 2024/2025 in accordance with Sections 31 to 36 of the Local Government Finance Act 1992 as amended:
  - £806,459,315 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (2) of the Act taking into account all precepts issued to it by Parish Councils.
     b) £678,372,533 being the aggregate of the amounts which the Council estimates for the items set out in Section

31A (3) of the Act.

- c) £128,086,782 being the amount by which the aggregate at (a) above exceeds the aggregate at (iii) (b) above, calculated by the Council, in accordance with Section 31A (4) of the Act,as its Council Tax Requirement for the yearincluding Parish precepts (Item R in the formula in Section 31A(4) of the
- Act).

  d) £1,719.6550 being the amount at (iii) (c) above (Item R) all divided by Item T ((ii) (a) above), calculated by the Council, in accordance with Section 31B (1) of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).
- e) £62,938 being the precept notified by Hetton Town Council as a special item under Section 34 of the Act.

f) £1,718.8100

being the amount at (iii) (d) above less the result given by dividing the amount at (iii) (e) above by the Item T ((ii) (a) above), calculated by the Council, in accordance with Section 34 (2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Parish precept relates.

g) £1,733.5599

being the amount given by adding to the amount at (iii) (f) above, the amount at (iii) (e) divided by the amount at (ii) (b) above, calculated by the Council in accordance with Section 34 (3) of the Act as the basic amounts of its Council Tax for the year for dwellings in the area of the Parish of HettonTown Council.

# Motions on Notice Outstanding from the Last Ordinary Meeting of the Council

COUNCIL 20 MARCH 2024

### MOTIONS ON NOTICE OUTSTANDING FROM THE LAST MEETING OF THE COUNCIL

Council Members are asked to consider the under-mentioned Motions: -

#### 1. Notice of Motion – A Smart City That Doesn't Leave Anyone Behind

Council agrees to ask the Cabinet to review how council services are offered in Sunderland and to take appropriate steps to make sure that:

- (i) everyone in our city can access services even if they cannot or do not want to do so digitally
- (ii) the Council's goal is that the cost of services does not differ depending on whether you pay using cash or whether you use electronic payment methods
- (iii) nobody is put under undue pressure to access a service digitally if they are not able to do so independently and that analogue access is provided efficiently, effectively and without barriers. This should include a review of policies governing telephone calls by residents to the Council's Customer Service Network.

Proposed by Councillor Heather Fagan Seconded by Councillor Malcolm Bond

#### 2. Notice of Motion – Minimum Quality Guarantee for Road Repairs

Councillors of all parties are frustrated when roads are resurfaced to a poor standard and have to be resurfaced again within a short timeframe. Council recognises this as a false economy - and one which is resulting in a waste of taxpayers' money.

Council therefore asks the Chief Executive to instigate a review of contract terms for road and pavement repairs, to ensure that the Council receives a good quality service from subcontractors, and to explore options for instituting a regular inspection regime, so that officers are assured that a minimum quality standard has been met or otherwise take action when it has not.

#### 3. Notice of Motion – Short Term Respite Care in Sunderland

The transition from Grace House to the newly acquired Red Gables site, set to open in summer 2024, will see parents of disabled and vulnerable children go without overnight support for a number of months.

Members agree that, in future, the Council must better prepare for its provision of short-term respite care, including overnight care, as some families are now being moved from one site of provision to another for the third time in seven years.

Council therefore agrees to a package of measures designed to improve the care and support available to disabled young people, whose disabilities are not catered for by existing services, including:

- Ensuring future decisions regarding short-break respite care arrangements are discussed with members, service users and as part of the scrutiny process rather than being decided at executive level.
- That families and children displaced from Grace House are made priority for placements at Red Gables and that these should be offered on a like for like basis.
- That a wider review of respite care is undertaken to ensure that a range of support (including overnight breaks, after school, weekend and holiday, and inclusive play and support groups) is available for different types of disability and special educational need. A report, following this review, should be presented to Children, Learning and Skills Scrutiny.

Council also agrees to request the Director of Children's Services to present a report to Scrutiny on how staffing, recruitment and retention needs for the new Red Gables facility will be met, in advance of it opening.

#### 4. Notice of Motion – Rescind Ed Davey's Knighthood

The Post Office Horizon IT scandal led to the biggest miscarriage of justice in British legal history.

Subpostmasters across the country - including in Sunderland - were wrongly convicted of a crime they did not commit.

The ITV drama on this subject has ignited public anger about this case - and exposed the wrongdoing of those who declined to help.

When the Justice for Subpostmasters Alliance (JFSA) asked to meet Lib Dem Leader Ed Davey - the then Minister for Postal Affairs, who served in a government department headed by Lib Dem Vince Cable - he declined, saying that it would serve no purpose.

As Conservative MP David Davis and Labour MP Kevan Jones jointly led a campaign to help the victims of this injustice, Davey took the side of the Post Office Ltd and showed a lack of leadership in not even questioning the organisational account which he now describes as a lie.

He is undeserving of the knighthood awarded to him for public service.

Council therefore resolves to:

- Ask the Chief Executive to write to the Deputy Prime Minister, departmental head of the Cabinet Office, to inform him that this Council requests that the honours committee review the knighthood awarded to Ed Davey for public service.
- Support all subpostermasters, but particularly those who operated from Sunderland, in their case for a quicker compensation process to be introduced.

#### 5. Notice of Motion – CPMS Charges

Community Parking Management Scheme (CPMS) zones are a necessary tool of last resort to deal with parking problems in residential areas.

These parking issues are not caused by the residents who live there, but by people from out the area. Yet it is residents who have to pay to park outside of their own home - and this is unfair.

Council therefore resolves to:

- Eliminate the cost of a second parking permit entirely for all households in CPMS zones
- Remove administrative costs relating to the registration of new vehicles when a resident changes car

#### 1. Purpose of report

- 3.1 The Council is required to adopt a Members' Allowances Scheme for each financial year and to do so before the beginning of each new year. It is also required to establish and maintain an Independent Remuneration Panel to make recommendations to Council about the allowances to be paid to elected members under the Scheme.
- 3.2 The Director of Finance and Assistant Director of Law and Governance have delegated authority to appoint up to six members to a "pool" from which they may convene Panels of no less than three members. Three new members have recently been recruited to the pool, however they have not yet had the opportunity to become familiar with the Council's governance arrangements and to receive information regarding the various roles and responsibilities of members. The new panel members are therefore not in a position to consider whether or not it would be appropriate to recommend any changes, in time for the Council to adopt the Scheme for 2024/2025. In the circumstances, the Panel has recommended that the Council continue with the terms of its current Scheme for the 2024/2025 year and that a detailed review be held during 2024/2025. This would provide the opportunity for the new members to receive information regarding the Council's arrangements and be in a position to consider whether or not to recommend any changes. The Panel will be able to consider recommending changes in respect of the Scheme for the following

- year, 2025/2026, and there will also be scope for the Panel to consider whether to recommend any amendments to the Scheme for 2024/2025.
- 3.3 When making or amending a Scheme, the Council is required to have regard to the Panel's recommendations.

#### 4. Reasons for decision

4.1 The Council must make a new Scheme before the beginning of each financial year.

#### 5. Alternative Options

5.1 There are no alternative options in respect of the adoption of a Scheme for 2024/2025, as this is a statutory requirement.

#### 6. Financial Implications

6.1 The costs of the Scheme are included within the Council's revenue budget for 2024/2025.

2.1 So far as reasonably practicable, the proportion of the total number of committee seats allocated to each group should reflect each group's proportion of the membership of the authority. The outstanding changes / appointments to Committees which are required are set out in the table below:

#### 3. Washington Town Board

- 3.1 In Autumn 2023, the government launched its long-term plan for Britain's towns, as a part of the levelling up programme. Washington was pre-selected as one of the 55 towns nationally to be included as part of the programme, which is intended to support local regeneration over the next decade.
- 3.2 The guidance issued by the Department for Levelling Up, Housing and Communities (DLUHC) in December 2023 specifies that an independent chair must be appointed to the proposed Town Board, specifically a local community leader or businessperson who is a respected figure in the community and well placed to lead the Town Board. As part of its role in establishing the Town Board, the Council is expected to offer the independent chair position to a suitable candidate, in consultation with the local MP.
- 3.3 Elected representatives cannot chair the Town Board, but the local MP is required to sit on the Town Board, together with the Police and Crime Commissioner (or their representative). The Council is entitled to appoint two Councillors to the Town Board, and the wider membership is required to be made up from appropriate community and partner organisations, with a strong emphasis on community engagement.
- 3.4 The Town Board will not have legal personality, and accordingly it is expected that the Council will be the accountable body for the purpose of receiving grant funding and administering expenditure on behalf of the Town Board. The Town Board will however be community led, independent of the Council, and responsible for developing and approving its own long-term plan for priority investments in Washington.
- 3.5 The timescales presented by DLUHC for establishing the Town Board are challenging, and the detailed governance arrangements for formally convening and administering the Town Board are still to be developed. In order to ensure progress in line with DLUHC's timescales, it is likely that it will be necessary to establish an initial shadow Town Board, and any Councillor representatives and other representatives (including the chair) will first be invited to join this shadow board. It is intended that Cabinet will subsequently be invited to formally ratify the convening of the Town Board later in 2024, and also approve the detailed governance arrangements and the prospective role of the Council as accountable body.
- 3.6 Council is therefore recommended to delegate authority to the Chief Executive to nominate two Councillor appointments to the proposed Washington Town Board, and to invite a local community leader to act as chair to the Town Board.

#### 4. Together for Children Sunderland Ltd (TfC)

4.1 Further to the previous decision of Cabinet to extend the current service delivery contract with TfC up to 31st March 2027, and following a review of

- the corporate governance arrangements for the company, a refresh and streamlining of the TfC board structure is planned.
- 4.2 The term of office of a number of the existing TfC non-executive directors is due to expire at the end of March 2024. The proposals have been shaped by the future requirements of the company during the next stage of its journey up to March 2027 and the interests of proportionality.
- 4.3 With effect from 1st April 2024, it is proposed that the TfC board of directors be re-constituted as follows:
  - Ms T. Banks (Independent Chair)
  - Chief Executive of TfC
  - Governance Law Specialist, Sunderland City Council
  - Independent Non-Executive Director

#### 5. Recommendations

- 5.1 The Council is accordingly invited to consider approving the following: -
  - (i) the appointment of Councillor Tye to the Human Resources Committee;
  - (ii) the appointment of an Ungrouped Member to the Scrutiny Coordinating Committee;

  - (iv) the appointment of Councillor G Smith to the Children, Education and Skills Scrutiny Committee;
  - (v) the appointment of Councillors Guy and Mordey to the Economic Prosperity Scrutiny Committee;
  - (vi) the appointment of Councillor Curtis to the Planning and Highways Committee;
  - (vii) the appointment of an Ungrouped Member to the Licensing and Regulatory Committee;
  - (viii) the appointment of Councillor Foster to the Appeals Committee;
  - (ix) that the Chief Executive be delegated to nominated two Councillor appointments to the Washington Town Board and to invite a local community leader to act as chair of the Town Board; and

# 1. Notice of Motion – One million women and girls - A framework for women's equality

This council notes that:

#### 3. Notice of Motion – Hot Food Takeaways

Supporting local restaurants, cafes, pubs and takeaways is a priority for this Council, as the city navigates its way through the difficult economic conditions imposed by the COVID-19 pandemic and conflicts around the world.

Sunderland City Council has a responsibility to act in a way that allows these businesses to thrive and provide jobs, services and and improve the quality of life within our city.

#### Council notes:

- The recent public interest in the City's approach to granting planning permission for hot food takeaways, following the decision not to award such permission to Cole Kitchen.
- That the ruling was made on account of the fact that 21.3% of eleven year olds within the St. Peter's Ward are obese, which is 0.3% over the limit set within Policy VC4 of the Core Strategy and Development Plan.
- That the Government-appointed Planning Inspector ruled that there was 'no leeway' within this policy at present.

#### Council resolves to:

- Express its regret that a petition signed by over 5,000 residents calling for Cole Kitchen to be granted planning permission has been ignored.
- Call upon the Leader and the Chief Executive to undertake a review of policy VC4 of the Core Strategy Development Plan, considering how Sunderland City Council can create flexibility within the rules to enable businesses which either serve

- healthier hot food or serve products not targeted towards children to operate as takeaways.
- Call upon the Leader to deliver a report on the findings of this review to a full Council meeting no later than December 2024.
