Introduction


- The Council have a range of responsibilities across a number of refugee and Asylum Seeker dispersal programmes

Current programmes

- Ukrainian programmes for those fleeing War
 - 2 Schemes in operation
 - Family Reunion
 - Homes for Ukraine
- Afghanistan resettlement programmes families and individuals displaced by war
 - 2 schemes in operation
 - Afghan Relocation and Assistance Policy (ARAP)
 - Afghanistan Citizens' Resettlement Scheme (ACRS)
 - Estimated that over 12,500 Afghan refugees remain in hotels across the
- Asylum Seekers those arriving via illegal routes into the Country
 - There is a UK wide Dispersal Programme that is led by the Home Office and managed by regional contract providers, for the North East it is Mears
 - The programme is under national review and is in consultation presently
 - In the NE and Humber area there are over 3000 still in hotels



Ukrainian programmes

Family Reunion scheme

- This is a family led arrangement
- Families are expected to fund and look after family members
- No direct impact on Council....unless there is a relationship breakdown

 - Member briefing issued 22nd March 2022
 - Local Authority role Portal management, DBS (now Enhanced for all), safeguarding interventions, Pre and post arrival checks, Accommodation checks, Multi Agency response (Education, Health, GP, job centre Plus), funding and payments, welfare checks, re-matching process, homelessness duty, ESOL, VCS connectivity
 - Sponsors Thank you payment of £350 pm for up to 12 months, provision of appropriate and compliant accommodation

Homes for Ukraine – Challenges & Case Studies

- Single Parent with Autistic son was matched with single disabled male, in one bedroom bungalow. Male paid for flights in alleged exchange for free care as he didn't want to pay Social Services for care package. Ukraine family was intercepted by staff at Newcastle Airport, taken to hotel. After a lot of support and partnership working, they have their own tenancy, have benefits sorted and child into special education
- Single female evicted on a weekend by her sponsors (very vulnerable young 19-year-old), placed out of hours by resettlement team, now moved into supported accommodation with Changing Lives. Team continue to support and looking now for alternative accommodation
- Single 18-year-old female matched with a single male (team already investigating this) when
 police informed us that he was an RSO, male told Police the match was with a 34-year-old
 male, which was untrue, Police and team worked together to intercept the match. Home
 Office informed and they are now investigating situation, 18 year female matched with
 another family



Afghanistan Resettlement Programmes

- Afghan Relocation and Assistance Policy (ARAP)
- Afghanistan Citizens' Resettlement Scheme (ACRS)
- Sunderland participate in both schemes
- https://www.gov.uk/government/news/operation-warm-welcome-underway-to-support-afghan-arrivals-in-the-uk
- ARAP is aimed at current and former locally employed staff who are assessed to be under serious threat to life.
- They are offered priority relocation to the UK
- 5,000 Afghan's arrived under ARAP.
- This number is in addition to the 20,000 expected under ACRS
- Sunderland control the properties that we pledge to the scheme
- Home Office ideally want larger properties, but they will consider anything
- Funding is in place to support process of resettlement and the Council will play a significant role in this process
- Due to refusal policy lots of Afghans remain in hotels, this policy is under review and will change future accommodation matches

Asylum Seeker Dispersal Programme

- Home Office led and managed via a contract with Mears
- Limited involvement with Local Authority
- Over 70 hotels nationally being used for Asylum Seekers
- Over 3000 Asylum Seekers in hotels in the NE and the Humber region
- One hotel in use in Sunderland
- Mainly single men but there are also a high number of unaccompanied children
- Channel crossings have seen up to 1000 arrivals a day over summer months
- Nationality and Borders Act 2022
- Rwanda New Government approach
- Government consulting on new approach to Dispersal
 - All Local Authorities in future must take part in Dispersal Programme
