Report of the Deputy Chief Executive

1. Purpose of the Report

1.1 To set out the issues and material considerations in the assessment of the planning application for the SSTC (Phase 2) and the New Wear Bridge and to make a recommendation to the Committee on the determination of the planning application.

2. Background and Current Position

- 2.1 The Development Control (North Sunderland) and (South Sunderland) Sub Committees, at their meetings on 2nd February 2010, gave consideration to a report from the Deputy Chief Executive.
