CHILDREN LOOKED AFTER: PERFORMANCE

REPORT OF HEAD OF SAFEGUARDING

1. Purpose of Report

1.1 To provide the Board with information about performance against key performance indicators and targets for children looked after.

2. Background

2.1 The numbers in this report relate to the end of August 2009. Appendix 1 contains information about performance against key indicators and targets for young people in care, and provides a basis for monitoring performance over time, and for comparison with performance nationally (banding).

3. Summary of Key Points

3.1 The indicators measuring placement stability are stable as are the headline number of Children Looked After. However, this does give a complete picture of the activity within the service. Included in this report are comparisons with our nearest authorities. For both CLA and children subject of a CPP Sunderland is average. There is a continuing high levels of adoption.



4 Children Looked After


 The LAC numbers were 389 at the end of August '09. This is equates to 67 per 10,000 of children under 18. There are 50 (13.4%) children within residential care. - The following graph shows the numbers of CLA and those subject to a CPP since April 2008.
- All of our local peer group are relatively stable, with slight increases for Newcastle and Gateshead. Sunderland are mid range

5 Placement Stability

- NI 61, (CLA with 3 or more moves) 9.0% or 35/398 children, against a target of 10.5%. This has risen from 32 last month.
- NI 63, (long-term stability of CLA) of those less than 16 and in care for over 2.5 years had been in the same placement for more than 2 years at 68.9% has continued to rise. While the number in care for more that 2.5 years has fallen from 169 to 164 from the last month, within this those in the same placement remained even at 113. However, still below target of 74%. We compare well with our nearest authorities.
- The related indicator for placement stability of B79 (% of CLA (exc with parent) in family places aged between 10 and 15), 84.6 %(123/150) is stable and just above the 83% target.

6 NI 66, PAF C68 - Timeliness of reviews of Children Looked After

In the year since April 2009, 97.9% of looked after children had all of their reviews in the year to date against a target of 100%

92% (322/350) of looked after children had all of their reviews in the year end August, against a target of 100%

7 NI 148, PAF A4 – Care Leavers in Education, Employment or Training at the age of 19

- At the end of June NI 148 those in EET was 60%. This is based on small numbers (3 of 5) and based on the period ending July.
- 80% (4 from 5). Of care leaver were in suitable accommodation. Both of these indicators are below their targets although the numbers involved are small and will fluctuate.

8 NI 71 Children missing from care

The self assessment at the end of July had risen to 8 from a possible 15 as at the end of July.

9 Children subject to Private Fostering

At the end of March 2009 there were 6 children privately fostered. At the end of July 2008 there are 5.

10 PAF C63 – Participation of Looked After Children in Reviews

• 100% of children contributed to each of their reviews during the period.

11 PAF C23 - Percentage of children adopted

- In the period since April there were 14 children adopted and 2 children had a SGO, 4.9% of those in care over 6 months, if this pattern is maintained the final outturn for 2009/10 would be 11.8%. It was suggested that he growth in adoptions would begin to fall in the second half of the year, this seems to be happening. The target is 8.7% for the year.
- In the twelve months there were 36 children adopted and 10 children had a SGO, 14.1% of those in care over 6 months.
- The number of those placed for adoption is 30 children, 28 of whom are under 10. This number had fallen due to the high number of adoptions. However, it has levelled out in the last few months.
- NI 61 the percentage of children adopted who were placed for adoption within 12 months of best interest decision being made has improved from 69% at the end of March to 78.6% at the end of August, 11 children from those adopted.

12 Education

- The percentage of children with a current PEP at the end of August was 98%.
- In the year ending August 31st three children moved school as a result of a placement move.

13 Disabilities

 The percentage of children and families in receipt of direct payments at the end of July continues to rise up to 3% or 103 children.

14 Ethnicity

The following table shows the percentage of non-white children by service. The ethnic population in schools is 4.6%. The DCSF suggest that a percentage above this would reflect the needs of ethnic minorities. There has been a fall in those on with a CPP and that Looked After. This may be due to a number of records being 'not recorded' for ethnicity.
