Subject: EPU BUSINESS PLAN (PROVISIONAL) 2010 - 2011

Report of the Chief Emergency Planning Officer

1. INTRODUCTION

1.1 The purpose of this report is to inform Members of the publication of the Emergency Planning Unit (EPU) Business Plan for the period 2010-2011.

2. BACKGROUND

- 2.1 Members will be aware of the Service Level Agreement (SLA) between Tyne and Wear Fire and Rescue Authority (TWFRA) and the Tyne and Wear strategic local authorities relating to the provision of a civil contingencies service.
- 2.2 The Service Level Agreement places an obligation on TWFRA, (discharged by the Tyne and Wear Emergency Planning Unit) to develop an Annual Business Plan setting out the work programme for the EPU, for agreement with the local authorities.
- 2.3 Although the SLA formally expired in March 2010, a provisional budget has been agreed; and the SLA has been extended, with the agreement of all parties, for a six month period until the outcome of the Tyne and Wear Resilience Review is known.
- 2.4 The outcome of the review will no doubt have implications for the way in which resilience services are delivered in future across Tyne and Wear, and this years business plan will need to be reviewed once the review has been concluded.

3 BUSINESS PLANNING PROCESS

- 3.1 As previously reported to this committee, a new approach to business planning was developed last year by the Strategic Management Board (SMB), which led to a significant delay in the publication of the 2009-10 Business Plan. However the learning points identified from that process have been taken forward to inform the development of the current years Business Plan.
- 3.2 A joint TWEPU/T&W councils Business Planning Workshop was held in January 2010 which involved members of the Strategic Management

- Board (comprising the District Liaison Officers from each Tyne and Wear Council and the CEPO), council resilience officers, and officers of the EPU.
- 3.3 The main objective of the workshop was to consider the key resilience challenges for Tyne and Wear communities; to consider how these needs could be met within existing resource across Tyne and Wear, and to undertake preparatory work that would inform the development of the business plan.
- 3.4 A copy of the provisional Tyne and Wear business plan is appended to this report in Appendix A. Further work is to be completed with the Strategic Management Board (SMB) to develop the work areas further in line with dynamic priorities.
- 3.5 The SMB and TWEPU aim to keep the 2010/11 Business Plan under quarterly review in order to better address emerging priorities. For example, issues and gaps identified as a result of participation in the National Capabilities Survey can be fully addressed and included in the performance management framework of the business plan.

4 SUMMARY

4.1 This report provides details of the provisional Business Plan for Tyne and Wear. Further work is required to finalise the plan which will be undertaken once the outcome of the Tyne and Wear Resilience Review is known.

5 RECOMMENDATIONS

- 5.1 Members are asked to:
 - note the publication of the provisional Tyne and Wear Business Plan 2010 – 2011;
 - approve the further development of a more detailed plan to reflect the outcome of both the Tyne and Wear Resilience Review and the National Capabilities Survey 2010, as appropriate;
 - receive a further report providing final details of the above as soon as practicable
