## 1. Audit Commission Annual Audit and Inspection Letter

That they submit for consideration by Council a joint report of the Chief Executive and the Director of Financial Resources (copy attached) on the Audit Commission Annual Audit Letter covering the year 2008/2009 together with a copy of the Audit Letter which included issues arising from the audit of the Council's financial statements and the results of the Audit Commission's work undertaken as part of the Assessment of the Council's arrangements to securing value for money in its use of resources.
