Apologies for Absence

Apologies for absence were submitted to the meeting on behalf of Councillors Ayre, Nicholson, O'Brien and P. Smith.

Declarations of Interest

There were no declarations of interest.

Minutes of the Last Meeting

RESOLVED that the minutes of the last meeting of the Committee held on 21 September, 2022 be confirmed and signed as a correct record.

Report of Northumbria Police

Northumbria Police submitted a report (copy circulated) which provided the Committee with an update on key performance information in relation to the Sunderland West area.

(For copy report – see original minutes)

The Committee was informed that owing to a family member having Covid, the Police Officer due to prevent the report was unable to attend the meeting. Members having

any questions on the report were advised to email Ms Gilly Stanley, Area Community Development Lead who would contact Northumbria Police for a response.

Councillor Tye referred to the growth in youth anti-social behaviour in the West Sunderland area reflected in the report, noting that the largest increase was in the St Anne's Ward. He believed that this was as a direct consequence of the decrease in youth provision in the Ward and in particular following the closure of the Pennywell Youth Project which had operated from a purpose-built premises, funded from SRB finance, on land owned by the Church of England. He expressed in the strongest possible terms his disappointment at the role played by the Church of England in the closure and asked that the Chief Executive be requested to make representations to the Church that the loss of youth provision in St Anne's was satisfactorily addressed.

Councillor Watson concurred with the views expressed by Councillor Tye stating that she had been extremely disappointed with the decision of the Church as the Pennywell Youth Project not only catered for the young people of St Anne's but also those of South Hylton and Nookside.

Councillor Mullen expressed concern at the lack of notification from Northumbria Police to Ward Councillors regarding significant periods of staff absence and requested that Northumbria Police were asked to provide an explanation. Councillor Edgeworth asked that any response received was relayed to all Members of the Committee.

Councillor Dunn referred to the last paragraph of the report and asked if the Police could provide further details on the success of the Darker Nights Campaign.

There being no further questions or comments on the report, it was:-

2. RESOLVED the report be received and noted.

Report of the Tyne and Wear Fire and Rescue Service

Station Manager Andy Nelson presented a report of the Tyne and Wear Fire and Rescue Service (TWFRS) (copy circulated) which provided the Committee with an update on the Service's performance indicators for the period 1st April, 2022 to 21st November, 2022 with particular reference to the L133 Incidents (all deliberate fires).

(For copy report – see original minutes)

The Chairman thanked Mr Nelson for his report and invited questions from Members.

In response to an enquiry from Councillor Burnicle regarding the reason for the increase in the number of car fires, Mr Nelson advised that regular weekly meetings were held with Northumbria Police regarding the cause of fire. In the recent past the increase had been attributed to low level organised crime, however there was no discernible pattern to the latest increase. Often it was something as simple as an object left in a vehicle overheating.

Councillor Tye condemned the growing trend of people who believed it was alright to attack 'Blue Light' Officers attending the scene of a fire, highlighting the latest incidents

of assault in Shrewsbury Road. He stated that such behaviour was absolutely unacceptable.

In response to an enquiry from Councillor Crosby regarding the 'Safe and Well' visits referenced in the report, Mr Nelson advised that they entailed offering general fire prevention and home safety advice. This would include checks on smoke and CO2 detectors / alarms and advice on things to avoid such as overloading electrical sockets and the use of 'alternative' home heating methods in response to the cost of living crisis.

There being no further questions or comments for Mr Nelson, it was:-

Report of Gentoo

Vicky Gamblin, Head of Operations, Gentoo Group presented a report, (copy circulated) which provided the Committee with an update on current Gentoo developments, projects and priorities for the period September to December 2022.

Ms Gamblin referred to the recent coverage around the tragic impact mould and damp could have within the home and the concern this could cause tenants. She advised that the health and safety of its tenants was Gentoo's number one priority and to this end a dedicated team had been set up to deal with any concern and provide the necessary support. This included a dedicated phone line (525 5500) where tenants could report any concerns about mould or damp.

The Chairman thanked Ms Gamblin for her report and invited questions and comments from the Committee.

Councillor Haswell stated he appreciated the efforts being made regarding the prevention of damp and mould but noted that in the past it had usually taken 3 or 4 requests from a tenant or the intervention of a ward Councillor to have an issue assessed. He asked what had been done to rectify this and prevent the escalation to a local Councillor. Ms Gamblin replied that there was probably little in the way of change with regard to the approach taken, however Gentoo now had more staff to address the issue. She acknowledged that it might not always have got things right in the past, but tenants needed to continue to report issues as they occurred. The problem was made more difficult as people were understandably reluctant to leave their heating on with the windows open in the middle of a cost of living crisis.

In response to an enquiry from Councillor Greener, Ms Gamblin advised that Gentoo did not install de-humidifiers but did use damp metres to monitor condensation in homes.

Councillor Burnicle referred to the Gentoo window replacement programme and highlighted the importance of installing windows with built in ventilators. It was a growing problem that modern homes were being built with windows that made them

virtually airtight. Ms Gamblin advised that she would email Councillor Burnicle a copy of the specification of the windows being used.

In response to an enquiry from Councillor Edgeworth regarding the current position in respect of the area of green open space at Gartland Road, Ms Gamblin replied that she believed an application had been submitted to the local Planning Authority but that the matter was currently on hold.

Councillor Peacock referred to paragraph 4.2 regarding the phase 1 Pennywell Regeneration Scheme and offered his thanks to Ms Gamblin and the team at Gentoo for the work undertaken to date, particularly in relation to the asbestos removal.

Councillor Crosby referred to the damage caused by storm Arwen and asked for an update in respect of the outstanding fence repairs as some residents had raised concerns over security. In reply, Ms Gamblin stated that the appointed contractors were following a programme starting in the Coalfield area of the city where the outstanding repairs had now been completed. She asked Councillor Crosby to email her details of areas where security concerns had been raised.

There being no further questions or comments, the Chairman thanked Ms Gamblin for her attendance and it was:-

Report of the West Area Voluntary and Community Sector Network

The Network submitted a progress report (copy circulated) which briefed members on issues pertinent to the Committee and the Voluntary and Community Sector.

Consideration was given to the report presented by Karen Noble which highlighted the following VCS Network activity undertaken since its last report to the Committee:-

- The receipt of presentations from Wearside Women in Need and Yitka Graham from Sunderland University around evaluation and monitoring.
- The invitation to West area organisations who manage community buildings to apply for funding from Sunderland City Council, in partnership with Sunderland's Community Led Local Development Programme (CLLD). The funding was to support organisations to help keep their doors open and offer 'Warm Spaces' for those most in need during the autumn and winter months.
- The provision of 16 Warm Spaces in the West area of Sunderland. The Warm Spaces in Sunderland had been represented nationally on BBC Breakfast in October by Pallion Action Group who highlighted the support the Kayll Road Library Hub Warm Space provided.
- The distribution by West Area Organisations of Round 3 of the Sunderland City Council Household Support Funding.
- The receipt of funding by West Area Organisations to deliver phase 2 Positive Steps' 1-2-1 wrap around support designed around the individual and phase 3

to deliver social prescribing activity to support people with a wide range of social, emotional or practical needs.

There being no questions or comments for Ms Noble, the Chairman thanked her for report, and welcomed and introduced Sam Hunter and Harry Young of the If U Care Share organisation who provided the Committee with a Comprehensive presentation highlighting the work of the charity in respect of young peoples' emotional and mental health.

REPORT OF THE NORTHUMBRIA POLICE

1.0 Purpose of Report

The following report provides a community update and key performance information in relation to Sunderland West area between the following 8-week period (December 2022 – 28th February 2023

2.0 Key Updates

Anti-Social Behaviour

Since the last Area Committee ASB across the area has fallen by 8%. The hotspot areas for ASB are currently McDonalds and the Silksworth and Springwell areas.

Motorcycle Disorder

Since the last Area Committee Motorcycle Disorder across the area has fallen by 6%. It is expected that as the days get lighter and weather gets warmer we anticipate another seasonal rise. However, Motorcycle Disorder features heavily as part of our Seasonal Planning and the Neighbourhood Team are devising several initiatives to combat this issue.

Crime

Since the last Area Committee crime has risen across the area by 3%. However, the area has recorded the lowest recorded crime rate in Sunderland and since the last Area Committee we have seen Drug Crime fall by 30%, Vehicle Crime fall by 23% and Criminal Damage fall by 7%.

Northumbria Connected

Northumbria Connected was launched last year and is the best way for people to receive information on those matters that are important to you and the community. Northumbria Connected allows you to share your priorities, concerns and views with us directly. REPORT OF THE TYNE AND WEAR FIRE SERVICE

1. Purpose of Report

1.1 The following report gives Performance Monitoring details in relation to the Local Indicators for Sunderland West Committee area from 1st April 2022 to 28th February 2023.

2 Background

2.1 At its November 2011 meeting Area Committee agreed that regular updates on Crime and Community Safety would be presented to each Committee meeting.

3. Tyne and Wear Fire Service Update

3.1 LI 02 Number of Deaths from all fires

No deaths were recorded during the reporting period.

3.2 LI 14 All Deliberate Property Fires excluding Primary road vehicles

There were 10 deliberate property fires, compared to 6 in the same period as last year. Sandhill and St Annes wards had 3 each of the 10 incidents. 2 of which were dwelling fires and 1 outdoor storage unit. Incident of note - Meadow nursery lodge, property and contents severely destroyed by fire having devastating impact on local community as no longer able to provide support. The continued partnership working with Northumbria Police, Gentoo, Sunderland city council and departments within have continued to work collaboratively to reduce these incidents. Both ops crews and prevention and education department have carried out hot strikes and ran localised initiatives in conjunction with local intelligence from LMAPS.

Incidents at the former Farringdon police station continued to be monitored in conjunction with partners. This continues to produce positive results. Site security has been key to help alleviate some of problems posed to crews. The site is still a concern as the measures put in place may only deter for so long. The only way for this area to be removed from services radar is the regeneration of the site. To assist in reducing the number of deliberate property fires, crews continue to patrol and report unsecure premises in conjunction with ASB reporting, the crews also utilise the Report-It tool.

3.3 LI15 Number of primary road vehicle fires started deliberately

There were 56 incidents reported during this period compared to last year when there were 29. An increase of 93%. Sandhill had 18 vehicle fires 12 of which were cars. Investigations into these fires have not established if any incidents were linked. TWFRS continue to work with Northumbria Police regarding all suspected malicious vehicle fires and shall continue to monitor any patterns and trends.

3.4 LI16 Number of secondary fires not involving property or road vehicles started deliberately

There have been 505 deliberate secondary fires in this area over the report period compared to 294 over the same period last year. This is an increase of 71% over the same reporting period. Pandemic lock downs during some of the reporting periods last

year played a part in these figures. Silksworth Ward has had most incidents - 152 incidents. In the first two quarters the grassed area close to Primate Road, Dr's surgery and former police station site accounted for majority of incidents within the ward. Since site security improvements the incidents have migrated to around the lake and the area between Perth Road and Silksworth Lane.

St Anne's ward 114 incidents – Area in and including King George playing fields. Predominantly grass or loose refuse fires.

Sandhill ward –71 incidents, the areas of Tay road and Thorney close.

Continued partner working with local authority, Gentoo, environmental services and Northumbria police. Increased patrols, Joint social media targeting and messaging. Community engagement work with youths has been carried out by crews both following incidents and during patrols. Partner agencies providing opportunities during the school holidays have been supported by crews. Education and fire safety messaging has been given on all opportunities to engage.

3.5 LI33 All deliberate Fires (combination of LI14, LI15 and LI16)

There were a total of 558 deliberate fires in this reporting period. An increase of 71% on last Year. This is due to an increase in predominantly ASB activity. The remarkably hot dry weather during the earlier quarters played its part in the notable increase on the number of grass fires. Grass fires and loose refuse/rubbish incidents were particularly problematic across all wards. Incidents in the earlier quarters, prior to the multi-agency work to improve security of the former police station/Primate Road had significant impact on these figures.

Vehicle fire incidents year to date have seen a 93% increase. This will continue to be monitored by ourselves and partner agencies. TWFRS are working with Sunderland city council environmental department, Gentoo to tackle loose refuse fires across all areas. Fire crews continue to monitor and report uplifts in the "hot spot areas" the Report-It tool is now embedded across the service which is assisting with a faster more stream lined collaborative mechanism. Partnership work (Northumbria police) carrying out targeted patrols and estate visits continues alongside engagement work. Any information regards any type of deliberate fire setting should be reported via the anonymous fire stoppers number.

3.6 Community Involvement

Regular multiagency meetings which help ensure a joined up approach will continue to be key to any further success. Crews have attended several events put on by local community groups and partner agencies across the area. Several schools from across the East have been to Farringdon station where they have engaged with firefighters and learned valuable fire safety messages and the impact of deliberate fire setting and ASB. (Schools selected were data and intelligence lead) The events held or attended by crews are an opportunity to build good local community relations and a rapport with some of the youths in the area.

I will encourage any further work with youth provision groups, Youth almighty and together for children etc and have duty crews involvement where and when resources permit.

Our home Safe and well delivery. Targeting our most vulnerable members of our community. Operational crews from Farringdon continue to provide this service and have delivered 1129 safe and wells visits across all wards.

The Princes Trust based at Farringdon Community Fire Station is now running with a cohort of 9 young people. The programme is due to finish on the 12th April.

The latest Firefighter recruit's course which started on Monday 13th Feb and will finish 19th May 2023. 24 Probationary firefighters will be posted to stations across Tyne and Wear.

3.7 On-going Issues

Collaboration with Northumbria police and local authority partner's continues to reduce incidents as highlighted in the report. It is essential that any fire related issues are reported to myself, (Andrew Nelson, Station Manager) or using Fire Stoppers 0800 169 5558, so I can action/address with my crews. My watches continue to work close within their respective ward areas to create community links (similar to the Police). The watches continue to deliver ASB initiatives – uplifts, premises security, and educational interaction.

The educational and engagement activities are key to reduce ASB and prevent attacks on emergency services. Over this reporting period there were 68 attacks on crews across Tyne and Wear. 13 of which were in the Sunderland district. Predominantly these incidents were projectiles thrown towards firefighters and or appliances.

REPORT OF GENTOO

1 Purpose of Report

1.1 The following report provides an update from Gentoo for the West Area Committee from December to March 2023.

2 Background

2.1 Area Committee agreed that regular updates from Gentoo would be presented to each Committee meeting to enable members to be up to date on current Gentoo developments, projects, and priorities.

3 Update on Neighbourhood Services

3.1 Gentoo continue to work on a tenancy sustainability plan to support tenants impacted with the cost-of-living crisis, who may be facing poverty because they cannot heat their home, pay their rent, or buy the essentials they need for themselves or their children. Tenancies fail for multiple reasons of which financial resilience is only one, and often a symptom of the real cause, such as vulnerability, relationship breakdown, low incomes, and unemployment. The Gentoo support teams work with tenants to provide extra support and the Department of Levelling up Housing and Communities has held up the work of Gentoo's Positive Engagement officers, as good practice. The PEO's work with tenants who have complex needs, such as drug and alcohol issues, which impact their ability to sustain their tenancy.

A Gentoo cost-of-living survey was sent out through social media during November 2022, with tenants asked twelve questions relating to how well they thought they might cope with the cost of living. Within two weeks 1550 responses had been received. When asked 'how worried are you about the cost-of-living crisis?' 51% said extremely or very worried with only 6% saying not worried at all. When asked 'how well do you think you will be able to cope with the cost-of-living crisis?', 46.47% said either extremely or very well. With 17.78% saying not so well or not well at all. Of all respondents, 76.27% had used a food bank in the previous 6 months. In response to 'What is your biggest concern about the cost-of-living crisis?' 45.41% of respondents, stated, 'paying rent' with 'paying energy bills' at 24.59% and 'buying food' at 22.47%.

Pension Credit is one of the most underclaimed benefits in the UK and is extra money to help you cover your costs if you're over State Pension age and living on a low income. Gentoo have promoted Pension Credit eligibility through social media and the website to encourage this group of tenants to claim. To also support this age group of vulnerable tenants, Gentoo have worked in partnership with the DWP and Northumbrian Water to identify those pensionable age tenants who would qualify for water rates support, the collaborative work with the agencies has resulted in approximately 2,762 tenants being awarded a discount of between 10 and 50% of their water charges (Gentoo now have 8,629 tenants who have benefited from this support).

There continues to be poverty for families receiving universal credit, Gentoo currently has 10,683 tenants claiming universal credit. These tenants are supported monthly during the first four months of their claim by specialist officers, who ensure that access to all available services and financial support is discussed.

We continue to support initiatives such as 'Share the Warmth' campaign which distributes used coats, scarfs, and hats to individuals in need, we continue to work with utility suppliers to support tenants struggling to pay their bills and offer support through Gentoo's 'Crisis Fund'. Currently this year (up to the end of February) 774 requests have been assessed, and a spend of £28,549 has already issued to tenants to top up their gas and electricity meters. Tenants are still able to access professional Money Matters support should they find themselves in financial difficulty and demand for this service has dramatically increased in the last three months.

3.2 The Tenant Satisfaction Measures were created by the Regulator of Social Housing as a new system for assessing how well social housing landlords in England are doing at providing good quality homes and services.

From 1 April 2023, landlords must start collecting data for the tenant satisfaction measures (TSM's) ready for submission to the regulator in Summer 2024, these results will be published in Autumn 2024.

The measures are intended to enable residents to scrutinise their landlord and hold them to account. The measures will also be used as a source of intelligence to the Regulator on whether landlords are meeting the regulatory standards. TSM's will be used alongside other tools to gain assurance that housing providers are providing good quality homes and services.

The TSMs, which will be collected through tenant surveys and landlord data, will cover five main themes, including repairs, building safety, effective complaint-handling, respectful and helpful tenant engagement, and responsible neighbourhood management. The Group already have a pilot project underway to ensure readiness for the provision of

data to the Regulator. The tenant surveys are being carried out by an independent organisation to allow for honesty and transparency.

3.3 Tracey McCann, from the Office of Police and Crime Commissioner, joined colleagues from our Housing Team on an estate walk on Pennywell in February. It was a positive day and great to share the challenges our neighbourhood teams face, as well as showing Tracey the positive investment work going on in Pennywell.

4. Investment & Renewal

- 4.1 Thorney Close windows scheme is on program to complete at the end of March 2023. There are 608 properties completed and 69 left to commence at the time of writing this report.
- 4.2 Pennywell Regeneration, work continues through phase 1 in the Upper Pennywell area. There are currently two streams, one in Prestbury Rd / starting in Presthope Road and the other stream currently in Penistone Road).
- 4.3 Australia Tower roof, ground penetrating radar survey 'Topographical Survey' started in February and scaffold is planned to start 6th March for 28 weeks.

- 4.4 Funding has been secured from Sunderland City Council for an additional 5 seating benches at Lakeside Village.
- 4.5 Gillingham Road, Grindon. Following consultation with residents regarding the bushes in the street (raised by the Sandhill ward councillors) I'm happy to confirm these have now been removed.
- 4.6 Farringdon Garages, contractor MGM Construction have been approved to commence demolition of 62 garages that are no longer fit for rent (size, condition, and lack of demand).
- 4.7 External redecoration works at Hartley Wood has commenced (45 properties benefitting from this) this scheme will address the render and fencing.

REPORT OF WEST AREA VOLUNTARY AND COMMUNITY SECTOR NETWORK

1. Purpose of the Report

1.1 The report provides an update with regards to the West Area Voluntary and Community Sector Network.

2. Background

- 2.1 To develop the capacity and influence of the Voluntary and Community Sector (VCS) across the City, Area Networks are in place and delegates represent each Area Network at Area Committee, taking forward issues on behalf of the whole VCS in the area, reporting on area priority delivery by the VCS, and reporting back, providing a two-way flow of communication.
- 2.2 West Area Network delegates will present a report to each Area Committee meeting informing Members of activity, progress, issues and concerns of the sector.
- 2.3 The West VCS Network is made up of over 70 local groups, as well as strategic local/national/regional partners. The network meets in the West on a regular basis to share good practice and support one another. The network feeds into a virtual network and feed into and receives weekly updates as part of an information share.

3. West Area Voluntary and Community Sector Network (AVCSN) Progress Report

- 3.1 The West VCS Network met in person in February 2023. At the meeting the network welcomed presentations on Next door neighbour, Household Support Fund, West Area Event 2023 and the Falls Prevention programme.
- 3.2 The network echoed a common pattern that they are seeing a significant increase in the number of residents accessing the support available, particularly in relation to the availability of food. The Bread and Butter Thing will be starting at Silksworth Youth and Community Centre from March 7th. The network welcomed this news and see it as a fantastic resource and support service for local residents
- 3.3 Warm Spaces are continuing to be a success across the West with some organisations having secure additional funding to offer activities and one to one support. These are called What Matters to You and Positive Steps. The Warm Spaces funding ends April 2023 and we anticipate that other areas of support will be looked at for the VCS.
- 3.3 Household Support round 3 is currently still on offer till end of March 2023. The demand for this support has been unprecedented and the priority is those who have not received a significant cost of living payment from the Government. The VCS recognise the need for additional support through the cost-of-living crisis and will work with Sunderland City Council to support those who are struggling financially.
- 3.4 Sunderland's Strength and Balance programme is being ran by Active Families NE across the West for one year. The programme which starts w/c 13th March is free and for those people aged 55 plus that are at risk of falling or who have fallen. The programme will run across various times and venues across the West
- 3.5 Youth Almighty Project have announced they will be hosting the West Area Community Event in Barnes Park. The focus this year will be improving physical and mental wellbeing of residents. The event will take place 29th June 1st July and once again local West Area schools will be invited to attend for the first 2 days.

3.6 Holiday Hunger was delivered through the February half term and was well attended with organisations providing activities and a meal for all children participating.

REPORT OF THE CHAIR OF WEST SUNDERLAND NEIGHBOURHOODS AND COMMUNITY BOARD

West Area Committee Delivery Plan 2020-2023

1. Purpose of Report

- 1.1 This report:
 - a. Provides an annual performance update of the West Neighbourhood Investment Delivery Plan 2020-2023
 - b. Provides an update of progress against the Area Priorities associated with the Delivery Plan, which will be the focus for the West Area Committee during 2022-2023.
 - c. Provides an update on Neighbourhood and Community Board Governance Arrangements for 2022 -2023.

2. Background

2.1 Following the approval of the Neighbourhood Investment Plans in March 2020, the West Area Committee has worked together to finalise their Delivery Plans. All priorities have been determined following significant resident consultation via Let's Talk Sunderland.

3. Area Committee and Neighbourhood Investment Plan Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:
 - a. Influencing decisions on services delivered at a neighbourhood level; and
 - b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's City Plan at a neighbourhood level and ensuring maximum impact where necessary, through utilising its own resources.
- 3.2 The Article 10 Neighbourhood Investment Plans were approved at Cabinet in March 2020.
- 3.3 It is now the responsibility of each Area Committee to deliver their agreed priorities to support the delivery of the Neighbourhood Investment Plan. Area Committee Delivery Plans have been developed to enable this to happen.
- 3.4 The Neighbourhood and Community Board will be Chaired by the Vice-Chair of the Area Committee. Neighbourhood and Community Board meetings will be held in July, November, February and April and dates are included in the council diary. If required, the Board may convene a further meeting(s) should there be a business need to do so and essential to ensuring delivery of the Area Neighbourhood Investment Plan Delivery Plan. All Committee members are invited to attend all board meetings.
- 3.5 Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision-making body, and the work / recommendations of the Board will be presented to the Area Committee for final endorsement. The Area Committee Chair and Vice-Chair were agreed at Annual Council in May 2022.
- 3.6 Area Plans from 2023/24 onwards are being developed, with data/intelligence gathering underway. Members will take part in a series of workshops and discussions to recommend

priorities and actions for inclusion in these plans, which will be agreed at June 2023 Area Committee.

4. Neighbourhood Investment Delivery Plan 2020-2023- Areas of Key Action/Progress

- 4.1 The Plan, which includes an introduction from the Chair of the Area Committee, commits to a significant number of priorities, which are being delivered within the West area of Sunderland, to address the key issues raised by residents. The Plan is monitored by the Area Committee and actions will continue to be addressed up to 2023, via the West Neighbourhood and Community Board.
- 4.2 Residents will be able to review the Area Committee Delivery Plan and monitor delivery of the plan via the Council's website which is available to access at www.sunderland.gov.uk, as well as through Area Committee update reports. Funding to support delivery of the plan has been allocated and further information can be found at **Item 4 Area Budget Report**
- 4.3 Progress against the Delivery Plan has been reported regularly to Neighbourhood and Community Board and Area Committee. Good news stories and promotion of projects and local information have been posted on the West Sunderland Community Facebook page.
- 4.4 Outlined below is a summary of the key areas of action/progress of the Board up to March 2023.





REPORT OF THE ASSISTANT DIRECTOR OF INFRASTRUCTURE AND TRANSPORTATION

1. PURPOSE OF THE REPORT

1.1 The purpose of the report is for members to consider and recommend to Area Committee the list of streets for their area, to a value of £100,000 that should be included in the Highway Maintenance Capital Programme 2023-2024.

2. BACKGROUND

- 2.1 At November's Neighbourhood and Community Board members were informed of the process for developing and approving the 2023-2024 Highway Maintenance Capital Programme for works on the adopted highway network.
- 2.2 At the meeting Board members were informed that a citywide programme of priority schemes would be prepared by officers to a value of 75% of the available City Region Sustainable Transport Fund (CRSTF) Highway Maintenance budget allocation and that 25% of the Highway Maintenance Capital Programme would be allocated to the members for spend on their recommended list of maintenance schemes.
- 2.3 Subject to Cabinet approval and Council ratification the amount of CRSTF capital allocation for Highway Maintenance will be in the region of £2m. Based on this amount £500,000 in total has been allocated to the Regeneration Areas.

3.0 PROGRAMME

- 3.1 In determining the candidate streets for the proposed Highway Maintenance Programme 2023-2024, information has been analysed and considered from the following sources:
 - Machine based and manual (driven and walked) condition surveys.
 - Councillors' input throughout the year, as well as the recent submissions following October's emailed invitation.
 - Reports from residents and businesses
 - Highway inspectors' reports and engineers' inspections.
 - Officers also examine accident claim locations and consider whether scheme work would be appropriate to mitigate future claims.
- 3.2 Appended to this report is a table, which contains the candidate streets for consideration. To assist members deliberations officers have prioritised a

- list of streets (shown in bold), which totals the £100,000 (or thereabouts) area allocation and takes into account local priorities.
- 3.3 Members may wish to endorse this list or, following discussions with their Area colleagues, choose to replace some of those streets highlighted in the table with those that are not highlighted. A set of A4 plans setting out the limits of the works at each location will be distributed prior to the meeting and will be made available to the councillors to view online.

4.0 RECOMMENDATIONS

Neighbourhood and Community Board members are recommended to consider the streets listed in the table up to a value of £100,000 (or thereabouts), and confirm, the schemes to be recommended to the March West Area Committee for inclusion in the Highway Maintenance Capital Programme 2023-2024.

We will continue to use a flexible delivery model to engage with young people who may be at risk of or currently engaged in ASB.

Each wards delivery model may be different as it will be based around the needs of young people and issues within that ward.

We will work to the needs of the local areas and young people.

We will invest time to develop young people into peer workers.

Models our partners will use:

Detached Youth work

Detached youth work offers unique opportunities to engage young people in their social environments. By entering these social spheres, workers are able to slowly develop relationships with young people and public environments and ultimately improve individuals' safety within contexts that pose a risk of harm. Workers also create safe spaces in which young people can interrogate their own opinions and behaviours and try to embody healthier alternatives.

Detached youth work operates without the use of a building or activity and takes place where young people "are at" both geographically and developmentally. It delivers informal and social education and addresses whatever needs are presented to or perceived by the youth worker.

As Detached Youth Workers have no physical building or specific activity over which they have power or control, the relationship between young person and youth worker is entirely voluntary and constantly up for negotiation.

Outreach Youth Work

Outreach youth work is a form of youth work that takes place on young people's own territory such as streets, cafes, parks and retail parks at times that are appropriate to them and is a method of work that supports and compliments new and existing centre/project-based youth work. Primarily used to inform young people of services that exist in their locality and to encourage them to use such services, Outreach can also seek to identify, through consultation with young people, any gaps that exist in services aimed at meeting their needs.

Outreach is seen as an extension to centre-based work, Outreach work takes place when workers who are usually centre based go onto the streets with an agenda of their own to pursue, usually to encourage young people to attend their club, and also in this case to access the health/wellbeing services etc.

Targeted centre based provision

Targeted youth support aims to ensure that the needs of vulnerable young people are identified early and met by agencies working together effectively – in ways that are shaped by the views and experiences of young people themselves.

Street Sports in local parks

This method involves taking equipment out into identified hot spot areas and engaging with those hard to engage young people, using sport as a tool to get them in positive activities. Young people will have an opportunity to get support and have someone they can talk to who will listen.

Sport is increasingly recognised as having a role in prevention and early intervention work with children and young people at risk of, or already involved in, offending behaviour. Although sport is unlikely to stop offending by itself, it has the potential to make a positive contribution.

Pop up events in hot spot areas

Provide meaningful engagement activities such as football cage, street sports, WIFI access, BBQs, refreshments, and soft archery in or around identified hot spot areas.

Out of Centre Activities

Activities to support and inspire young people to engage with the outdoors or local facilities to learn valuable skills and make positive decisions.

Our aim of this model is to support young people to address the issues they are facing, learn coping mechanisms to support them in the future, and give them the confidence they need to make positive decisions.

Our delivery model will work on 4 levels.

- Identification
- Prevention
- Intervention
- Review / Evaluation

Identification

This is where we will work with partners and do our research

- Talk to local stakeholders (e.g. Police, shop keepers, Ward Councillors, Area Lead, ASB team, Community wardens, and community residents.
- We will look at any areas of interest, identify 'hot spots' where local young people gather, identify and note behavioural evidence e.g. graffiti, tagging, alcohol or drug usage.
- Talk to local young people and ask them what the issues are in their area in relation to them and their peers.
- Ask what local people think the issues are in their area in relation to young people.
- Map the area (what are the facilities like, are there barriers to young people engaging?
- Find out trends—e.g. seasonal areas, local events.
- Find out Crime stats etc.

Prevention

It has become increasingly important to offer services that prevent young people becoming involved in crime and behaviours that have a negative impact on their future.

All delivery partners will share their resources and use a range of engagement tools as this is a great way to get young people engaged in detached youth work whether that is a cup of hot chocolate on a cold winters night or a BBQ in the summer months. Engagement tools are a great way to start a conversation and help build trusted relationships between young people and youth workers.

Engagement tools we will use:

- Hot chocolate
- BBQ
- Music—a portable speaker
- Cooking
- Issue based workshops
- Advocacy
- Leaflets and brochures
- Sports—street football
- Portable equipment such as football cage, roll out tennis court

We will continue to develop relationships and services that empower young people; it capitalises on their strengths to build their skills and attributes, and that increases their understanding of themselves, thus allowing for better outcomes and lifestyle choice for their future.

We will continue to work with the young people to raise their awareness of the potential consequences of risk-taking behavior and provide information, guidance, and support to enable young people to make informed life choices and raise their aspirations.

We focus on areas across Sunderland West where young people have been identified as being at risk of anti-social behaviour, substance misuse, and vulnerabilities.

Intervention

Detached youth workers will continue to get to know individuals and groups, what are their views and interests, what are their concerns? this is a time to learn about young people and what they want, offer emotional support and, with their guidance, develop a programme of intervention.

Intervention programs could include:

- Visits to places such as Goals, Everyone Active, Sunderland Wall and Ford football hub
- offering education such as drug or sexual health, or creating opportunities for learning skills such as music, arts or sports.
- Co design activities in partnership with young people where ASB is caused by lack of facilities and opportunities.
- Social Action Projects
- Pop up Provision
- Street Sports activities
- Together For Children Bus
- Some individuals may require very specific support including being referred and accompanied to other agencies.
- Signposting

It is our duty to stay well-informed and to be able to provide basic information on a range of issues that routinely matter to young people. Where more support is needed, detached workers will be prepared to introduce young people to other specialists and service providers who can meet their needs.

Evaluation

- Keeping key partners up to date throughout
- Changing things from lessons learned.
- Recording changes in young people and changes in other people's perceptions of young people in the locality.
- Qualitative data will include feedback from young people carried out using a variety of methods that will include young people's comments, session evaluation and overall evaluation.
- We acknowledge the importance of self- assessment, and therefore young people will be encouraged to take part in this process of self- identification of progression.

Additional Delivery Information

- The project will run over 18 months.
- Each ward will have 1 weekly session 2.5 hours long, where they will target young people who are at risk of anti-social behaviour.
- We will work to the needs of the local areas and young people,
- We will invest time to develop young people into peer workers.
- We will work closely with; and have clear communication channels to the police, LMAPS, ward councillors, area officers so that we have a joined-up approach to tackling ASB and we can use a combined intelligence to identify ASB hotspots. We will develop a clear referral process at the start of the project which will be shared with all partners.
- Delivery partners will meet with their 3 local ward councillors every quarter to update on the project and to discuss any concerns.
- During school summer holidays we will provide weekly a park event in each of the wards
 where all partners will deliver events and bring along resources to engage with young
 people these will include food/BBQ, DJ, speed football, outdoor sports, the new Wear
 Here 4 You bus.

We understand that not all young people want to attend a youth centre, we will refer into alternative provision such as the everyone active centres, scout's groups, etc – where we can negotiate reduced rates, we will also use a detached youth work presence and take provision to the streets and spaces where young people choose to gather.

Project benefits delivered by our youth workers.

- Providing support to access activities or provision in local areas and informing young people of pathways for growth and personal development.
- Providing young people with access to informal learning opportunities, information and resources.
- Stimulating, positively challenging and empowering young people to make right life choices.
- Getting young people back into education, employment or training.
- Offering careers advice and guidance.
- Offering tailored support to vulnerable groups.
- Reducing further risk of serious youth violence.
- Supporting young people to become more resilient in their communities.
- Supporting community cohesion
- The ASB funding has allowed us to deliver additional sessions when requested, including
 weekends, especially in the St Anne's ward where we worked alongside the police to
 resolve issues with young people and public transport.

If funding is approved this project will allow us to also contribute toward funding introductory and level 2 youth work courses. Participants will be recruited through current volunteers and assistants, the young people that use the youth work organisations in the west and those interested from the surrounding neighbourhoods.

The youth work courses that we will deliver are accredited and approved by the National Youth Agency and they that learners meet the professional standards in youth work and are able to fully understand and meet the many diverse needs that young people present.

Including a training element will ensure that there are workers to deliver services and activities in Sunderland West; workers who understand the needs of young people, understand their issues and understand how to ensure young people have a voice and a role within shaping services.

Because the project will recruit from existing services for young people, then it is likely that the users of the organisations themselves will take part; it means that young people will become role models and peer advocates in their community.

Project Description (verbatim from application)

Over the years of running the Sunderland SAFE programme, SafetyWorks! has welcomed all of the West area schools to the centre for the Year 6 programme. Schools are always keen to make a booking when approached, however the cost of transport can be a barrier. This is a problem that is increasing in the current climate as the cost of transport has increased significantly for schools. Being able to provide the transport to get the young people to and from the centre will allow us to hit the maximum number possible and provide important safety messages to these key target audiences.

SafetyWorks is a fun and interactive way to educate children and young people. The centre will provide sessions free of charge, to deliver an education programme around keeping safe and avoiding risks. This will be offered to all of the Year 6 from the 16 Primary Schools within the West area, the 4 Secondary School Year 8's, as well as the Link schools and youth groups within school holidays.

The SAFE programme targets Year 6 (age 10-11) children to help raise their awareness in different aspects of fire safety, personal safety and home safety; as they are at a key age when they will be going through the transition from Primary to Secondary school, and therefore may have more freedom and independence. We aim to improve the home and personal safety of Year 6 pupils, increase their risk awareness and give them the skills to avoid accidents and increase their confidence in how to deal with challenging situations

For Year 8 (age 13-14) pupils and older youth groups we provide important information about fire safety and the consequences of deliberate fires. Officers from Northumbria Police will facilitate a session around drugs/knife crime, the RNLI cover water safety and Nexus rail safety and antisocial behaviour around the Metro.

We try to ensure that the information provided in our sessions is relevant and reflects current and emerging issues in our society. The workshops are interactive and exciting for the pupils and whilst the aim of the projects is to raise safety awareness of young people, we also aim to increase their knowledge on what impact their actions can have on themselves and their communities, resulting in a reduction of antisocial behaviour. Last academic year, 13 Primary schools from the West area visited SafetyWorks! with 623 Year 6 pupils receiving important information about how to keep themselves and others safe.
