The electronic votes were subsequently checked, and the system indicated that Councillor Doyle had abstained.

Declarations of Interest

There were no declarations of interest.

Announcements

(i) Terrence Higgins Trust T-Shirts

The Mayor informed Council that a number of Councillors were wearing T-shirts designed by Phillip Normal, to raise funds for the very worthy cause, the Terrence Higgins Trust. The T-shirts were produced following the success of the television programme "It's a Sin" and to date, the sale of the T-shirts had raised over £250,000 for the Trust.

(ii) Retiring Councillors

The Mayor advised that Councillors Davison, Francis, Hunt, Jackson, Kelly, Lawson, Marshall, Oliver, Scaplehorn and A. Wilson would be retiring from office and not standing in the municipal elections in May. As this would be their last Council meeting, he expressed his gratitude for their past service and wished them well for the future.

The Mayor having thanked all those retiring from the Council for their contribution, individual speeches and tributes were paid by Members.

(iii) Marie Curie's Day of Reflection

The Mayor advised that it was the anniversary of the first UK lockdown due to the Covid-19 pandemic and across the Council, Members and officers had supported the Marie Curie's Day of Reflection on 23 March 2021. He invited Members and officers to also observe a minute's silence during the Council meeting following the Leader of the Councils verbal update on Covid-19.

Apologies

Apologies for absence were submitted to the meeting on behalf of Councillors Bewick, Kelly, Scaplehorn, Turner and A. Wilson together with Aldermen Forbes, Greenfield and Tate.

Covid-19 – Verbal Update by the Leader of the Council

The Mayor invited the Leader to provide a verbal update on the Covid-19 pandemic.

The Leader provided a further update to Council on the Covid-19 emergency and how the Council continued to support the city and its residents through this challenging time. The Leader referred to the anniversary of the first UK lockdown and commented that this had been a poignant and important day of national reflection and that our thoughts were with everyone in the city who had lost a loved one during this past year.

The Leader advised that there were countless superheroes throughout this city, from the caring neighbours and community volunteers to the army of key workers putting themselves, selflessly at risk to keep vital services going every day in incredibly difficult circumstances, to essential shop employees, teachers and school staff, delivery and public transport drivers, our NHS and Care sector workforces and many more. These people had kept the city going and supported residents when they've needed it the most.

The Leader wished to pay tribute to the Council Team who had been unswerving in their commitment to support the City and its residents, as they had been quite simply, exemplary public servants and he was proud of, and grateful for the tireless efforts of teams right across the Council. Efforts which included

- Providing almost 29,000 free school meal lunches
- Responding to 24,500 calls to our telecare service
- Recruiting and working alongside 1,120 volunteers
- Taking 706,000 calls from residents and customers through the customer Service Network
- Carrying out 1,082 Track and Trace calls since January
- Undertaking over 2,000 alterations and delivering and installing 28,500 items of essential equipment into people's homes
- Delivering almost 3,000 litres of hand sanitiser and 640,000 face masks to organisations and service providers across the city
- Paying out close to £72 million worth of grants to businesses, alongside £42 million worth of Business Rates relief.

The Leader paid tribute to these key workers and remarked that, at the same time as this outstanding response effort, fantastic progress had been made with the social and economic regeneration plans for Sunderland. These gave Sunderland and its residents every chance of emerging from this pandemic in a strong and competitive position with developments such as Riverside Sunderland creating significant new jobs, facilities and communities in the City Centre. The Leader referred to the rollout of our 5G networks and other pioneering new technologies leading us to be named Smart City of the Year in October 2020, and new housing developments right across the City, including the creation of vital affordable homes and safe clean vibrant neighbourhoods.

Whilst the Leader could not list everything that has been done and delivered in the recovery effort in the time provided, everyone's contribution was massively appreciated. It had been incredibly hard for everyone but once again, the Leader was very proud of the selflessness demonstrated and the acts of kindness and compassion shown helping our residents' day be that little bit brighter and easier. This was why it was so important to keep going and not to throw away all the hard work and sacrifices made.

The Leader remarked that we could and would get through this by working together and doing our bit to protect our friends, families and communities. The Council would continue to do all it could, for however long it took to support people through the emergency at the same time as working on the development of a fantastic, thriving City with opportunities for all.

At this juncture, Members and officers joined the Mayor in observing a minute's silence to reflect on the anniversary of the first UK lockdown due to the Covid-19 pandemic and for those residents in the city who had lost a loved one during this past year.

Citywide Approach to Carbon Reduction – Verbal Update by the Deputy Leader of the Council

The Deputy Leader provided an update on the ongoing progress being made in relation to the city's goal of becoming carbon neutral by 2030 and reducing its carbon emissions.

The Deputy Leader advised that the 2030 Shadow Board had met the previous week and the progress being made by our partners had considerably increased since the adoption of the Low Carbon framework last December.

Many Partners were busy developing their own individual action plans and the list of ongoing projects relating to energy efficiency measures, sustainable transport and agile working and waste reduction was significant. Projects included the rolling out of electric vehicles, rationalising property estates, introducing solar panels and better building insulation and the elimination of single use plastics.

The 2030 Board also was very supporting of the proposal to create a Youth Advisory Group, and once established this group would meet regularly to exchange ideas on how carbon and climate topics could be fed back to the 2030 Shadow Board as part of an ongoing two-way dialogue. Crucially the group would amplify young persons' voices across the city and allow them to have a say in their own future and to drive our low carbon framework forward.

Alongside the partnership activity, the Council's 2030 Task Group had been very active to work on initiatives to drive forward carbon reduction and to achieve the strategic priorities of the draft Low Carbon Framework. Examples of recent work included: -

- A successful bid to the Public Sector Decarbonisation Scheme to obtain grant funding of up to £2.3 million to install air source heat pumps to decarbonise heating. All physical works would be complete by September 2021 involving eight Council operational buildings and carbon savings of 190 tonnes.
- The Council, together with Gentoo, had a bid awarded of £1.3 million funding as part of a social housing decarbonisation fund demonstration programme which would support the retrofitting of 46 properties in the Washington area
- We had also been successful with our submission for the Green Homes Grant and had been allocated £1.6 million of funding to spend by the end of December 2021 and upwards of 300 homes would be retrofitted;
- Working with Small and Medium Enterprises (SMEs) through the BEST and BREEZ projects to deliver energy efficiency measures. The projects had now engaged with over 83 SMEs which equated to 84 tonnes of carbon set to be saved each year;
- The Council has ordered 12 new electric vehicles for its fleet and would include our first new econnect refuse collection vehicle which was due to arrive in May
- A new electric vehicle rapid charger had been installed in Houghton Le Spring Town Centre for taxis and was now fully operational.

- Support of a bid for a new North East Community forest which would include the whole of the Sunderland area with a decision expected in July of this year. If successful this would unlock trees for climate funding and funds to further recruit a woodland officer
- The Sunderland East Area's Clean and Green Team has been awarded an additional £100,000 funding, awarded to April 2022 to deliver local environmental improvements

The Deputy Leader advised that he would continue to provide updates to Council as appropriate going forward, and accordingly it was:-

Action on Petitions

The Council received and noted the report below which detailed the action taken in relation to the following petitions which had been presented to the Council.

(i) Petition from residents requesting the Council to consider introducing traffic calming to Briar Lea and Bowes Lea

Officers considered the prioritisation of traffic management schemes using the following criteria which were being reviewed:-

- Number of road traffic accidents/collisions on the road or area in question resulting in personal injury, in the past 3 years (using Police generated information). This includes an analysis of the cause and a detailed assessment of the incident to determine if the accident/collision could have been avoided using engineering measures.
- Proximity of schools in relation to the route of concern. Exposure
 of vulnerable road users to significant levels of vehicular traffic
 and a high level of potential conflict between pedestrians and
 vehicles on the route.
- The level of vehicle speeds in relation to the route's speed limit
- Improving access and reducing congestion especially in the commercial and industrial areas of the City

After consideration by Council Officers, the outcome of the petition was as follows:-

Briar Lea and Bowes Lea would be included in the list for investigation when the new prioritisation criteria was introduced.

The Ward Councillors and lead petitioner had been advised of the outcome.

(ii) Petition requesting the shortening the bus stop clearway at 3 – 10 Smith's Terrace, Easington Lane

Following investigation by officers it was agreed that this bus stop clearway be reduced in length by 14 metres and this would still enable buses to manoeuvre in and out of the stop while creating parking provision for customers of the shop and residential properties. The relining costs to be taken from the road marking budget.

The Ward Councillors and lead petitioner had been advised of the outcome.

(iii) Petition requesting the installation of traffic calming on Ramsgate Road, Red House and further correspondence for measures on the ring road including Redcar Road, Redhill Road and Rhodesia Road

The Council has plans to improve the area of the Willowfields Primary School development. This part of the scheme was located on Redcar Road between Ramsgate Road / Beechwood Crescent and comprises a school safety zone, a humped zebra crossing, speed cushions, no stopping on school keep clear and bus stop clearway road markings, no waiting at any time restrictions and road narrowings with priority / give way shuttle working.

In addition, there was an established 20 mph zone in the area with accompanying signs and traffic calming. It was deemed appropriate to look at the entire area to discuss if any further measures could be introduced.

Officers would continue to work with Councillors to establish the appropriate solutions for this petition. Any proposals would be reported to residents via the consultation process.

(iv) Petition requesting the Council to make Tunstall Hope Road safer for Local Residents

Following receipt of the petition, a detailed investigation had been carried out.

The existing 40mph speed limit begins to the south of Harperley Drive. Consideration had been given to reducing the speed limit partially on the northern section of road as you enter the rural surroundings.

Speed surveys had been undertaken at northern and southern points along Tunstall Hope Road at locations where speeds would be at a maximum. Both surveys indicated that most drivers were travelling within the existing 40mph speed limit.

It was therefore concluded that it may be beneficial to partially reduce the existing 40mph speed limit to 30mph on the northern section of Tunstall Hope Road to the access road of the first property at Tunstall Hope Lodge. This could have a downward influence on vehicle speeds through this section of road. There was vehicle access on either side of this section which also has double white line road markings. Works would be funded from the programme of minor works scheme budget.

The Ward Councillors and lead petitioner had been advised of the outcome.

(v) Petition from residents requesting the upgrade of the Chester Road / Holborn Road Junction

The petition called on the Department for Transport to approve the Transforming Cities Fund application to upgrade Chester Road / Holborn Road to make it a fully signalised junction.

A bid had been submitted by the Council to the Transforming Cities Fund to the Department for Transport. The fund was to be used on improvements to productivity and to spread prosperity through investment in public and sustainable transport in some of the largest English city regions.

The petition had been forwarded to the Department for Transport as supplementary evidence in support of the funding application. If unsuccessful, the Council would continue to actively seek suitable funding to deliver a scheme to deliver improvements to this junction.

The Ward Councillors and lead petitioner had been advised of the outcome.

(vi) Petition from residents requesting the introduction of a pedestrian crossing island on Fordfield Road

The area of road stated in the petition was outside Dovecote Meadows, which provides retirement housing and extra care for older people. The road was subject to a 20mph speed limit and there had recently been dropped crossing points with tactile paving installed outside this housing facility. Additionally, there had been warning signs installed to indicate that vulnerable pedestrians may be crossing.

The measures above were introduced in response to a petition submitted in 2019.

Officers had investigated the possibility of installing pedestrian refuge, however the road was under 7.5 metres which was too narrow to safely accommodate a refuge.

Due to the number of vulnerable pedestrians likely to use this crossing, the road width prevents an acceptable sized refuge to accommodate wheelchair users and their accompanying carer from being installed.

Consideration must also be given to larger vehicles such as HGVs, ambulances etc to ensure that their turning and movement is not impeded by the installation of such crossings. This would also create a safety concern for any pedestrians using this type of crossing facility.

Given the reasons outlined above, the petition was declined.

The Ward Councillors and lead petitioner had been advised of the outcome.

Councillor Stewart welcomed that officers would continue to work with Ward Councillors to establish the appropriate solutions for the petition on traffic calming measures at Red House and highlighted that consultation with residents was about to commence on some proposals to resolve the matter.

In relation to the petition in respect of traffic calming to Briar Lea and Bowes Lea, Councillor Lawson advised that the petition was initially submitted to Council on 29 January 2020 and not 2021 as stated in the report. She thanked officers and appreciated that consultation had been difficult during the pandemic, however the proposed outcome had taken some time. She therefore requested that residents be reassured and given more clarity in respect of the proposed new prioritisation criteria that the traffic calming measure would be addressed as this was her last meeting of the Council.

59. RESOLVED that the report detailing action on petitions be noted.

Notices of Motion

(i) Vaccines for All

Councillor K Chequer, duly seconded by Councillor K Johnston moved the following motion:-

"This Council notes that in order to address the coronavirus pandemic and strengthen public health efforts, the coronavirus vaccine must be safely accessible to everyone, regardless of immigration status, ID or proof of address.

The Government has stated that everyone is able to access the coronavirus vaccine, but in practice, people are being asked for ID, are unable to register with a GP, and are afraid to access services because of longstanding and entrenched barriers to healthcare.

Without further action, the pandemic will continue to have a disproportionate impact on all marginalised groups, including migrant communities, people experiencing or at-risk of homelessness and BME communities.

This Council therefore agrees to sign up to the Vaccine for All campaign calling on the Department of Health and Social Care to ensure the vaccine programme works for everyone, and seeks to address the specific barriers faced by these communities"

Councillor Dr A Mullen, duly seconded by Councillor S Leadbitter, moved the following amendment:-

Add the following text to the end:-

"However, Council also recognises that all necessary safety measures should be in place when administering a vaccine. This Council's endorsement of Vaccines for All shall be immediately withdrawn in the event that the Nursing and Midwifery Council or an equivalent professional body expresses objection to its aims"

PART 2, ARTICLE 12.02 AND PART 4, SECTION 6, PARAGRAPH 3

In addition to the changes to the membership of the Health and Wellbeing Board set out in the Committee Lists report earlier on the agenda, it is proposed that Paragraph 3 of the Health and Wellbeing Board Terms of Reference and Procedure Rules is updated to reflect the current role of the Board in overseeing the delivery of the Healthy City Plan. (The proposed changes are to the bullet points on how the Board fulfils its responsibilities.)

Accordingly, it is proposed that in addition to the change to Article 12.02, Paragraph 3 of Part 4, Section 6 is amended to appear as set out below:

"Sunderland Health and Wellbeing Board additional locally agreed functions In addition to the statutory functions outlined above the Board is one of three main city-wide delivery vehicles that drive the three main strands of the Sunderland City Plan (Dynamic, Healthy, and Vibrant Smart City).

The Board will oversee the delivery of the 'Healthy Smart City' key theme of Sunderland's City Plan (although accountability for the delivery of the overarching City Plan will be with the Sunderland Partnership Board). These responsibilities include:

- a. Everyone will have access to the same opportunities and life chances no matter where they are born or live
- b. More people living healthier longer lives
- c. More people living independently
- d. Cleaner and more attractive city and neighbourhoods
- e. A city with great transport links where it is easier to walk, cycle and access public transport

In fulfilling these responsibilities, the Board will:

- Be assured of place-based arrangements.
- Provide the leadership to ensure effective partnership working to deliver the ambitions of the Healthy City Plan (the JHWS) and reduce health inequalities.
- Understand 'lived experiences' and use this insight to champion and advocate for tackling health inequalities through assets-based approaches.
- Delegate accountability for the implementation plan workstreams to responsible groups and ensure governance arrangements are in place for all activity.
 Receive regular updates on the Healthy City Plan workstreams, monitor their workplans and performance.
- Have oversight of the appropriate elements of the Sunderland Covid-19 Health Inequalities Strategy and take every opportunity to mitigate the impact that Covid-19 has had on our communities.
- Be assured that activity being delivered through the Vibrant Smart City and Dynamic Smart City elements of the City Plan are maximizing opportunities to reduce health inequalities and address the social determinants of health, provide challenge and support where appropriate.
- Ensure that the work of the Board promotes a positive image of the city."
