#### Report of the Assistant Director of Law and Governance

#### 1. Purpose of Report

- c. ask Council to delegate authority to the Executive Director of City Development, in consultation with the Clean, Green City Portfolio Holder, to update the Plan during its three-year term, on the basis referred to at paragraph 4.6 of the report.
- 3.2 The report was referred to the Economic Prosperity Scrutiny Committee for advice and consideration.
