Place Board Progress Report

The Chairman of the West Sunderland Area Place Board submitted a report (copy circulated) which provided an update of progress against the 2016/17 work plan.

Councillor Essl presented the report drawing Members' attention to the initiation of action towards achieving key priorities as detailed in Appendix 1 of the report together with a summary of key areas of influence and achievements of the Place Board in relation to Highway Maintenance Capital Programme, Business Support, Tall Ships 2018, Maximising Greenspace and Improving Derelict Land, West Community Energy Programme and Mobilising Communities to take sustainable action to support environmental improvements as at 5th December, 2016.

Councillor Tye referred to the huge success of the Road to Rio Event 2016 and informed the Committee that Youth Almighty supported by the Area Officers had been successful in securing a grant of approximately £10,000 from the Big Lottery Celebrate Fund towards the provision of the Area Committee's 2017 Event. Councillor Tye cited the award as an example of successful partnership working between the Local Authority and the Voluntary Sector. The Committee thanked Councillor Tye and all concerned at Youth Almighty for their work to achieve the funding.

Councillor Gofton paid tribute to the contribution made by the Parker Trust and the other local community groups in working with the Pallion Traders to develop their Christmas Festival Programme. The Christmas Illuminations Switch On had been an especially impressive event.

Report of the West Area Voluntary and Community Sector Network (AVCSN)

The AVCS Network submitted a progress report (copy circulated) which briefed members on issues pertinent to the Committee and the Voluntary and Community Sector.

Consideration was given to the report presented by Andrea Lanaghan which highlighted the following feedback and input arising from the two Voluntary and Community Sector Network meetings held since the Area Committee last met in October:-

i) The receipt of information relating to Sunderland City Council's budget consultation and the work of the Network to encourage their groups and clients to be involved and feed their views into the consultation process.

ii) The invitation to VCS members to attend the Health and Wellbeing Mental Health training relating to 'supporting our young people', delivered by Washington

MIND and funded by the West Area Committee. The training was held over 3 days and over 40 members of the VCS attended, a follow up workshop was carried out to support the development of the future call for projects, facilitated by the West Area Arrangements team.

iii) The work of the VCS to plan local environmental campaigns, including litter picks as well as preparing their 2017 plans to enhance and develop the West's 'in bloom' projects, developing new 'in bloom' activities, following the success at the RHS It's your Neighbourhood Awards and the Sunderland In Bloom Awards 2016.

iv) The continued utilisation of GRANT finder opportunities with over £40k in funding secured in the West to date.

Councillor Gofton paid tribute to the outcomes being delivered by the VCS for residents since the formalisation of links to the Area Committee and in particular welcomed the fantastic news in respect of the funding achieved via grant finder. She also highlighted the success of the mental health training event which had attracted a huge attendance.

Councillor G. Galbraith referred to item iii) above and informed the Committee of the intention of a group of residents and dog walkers in the Lakeside, Premier Road area to organise a litter pick.

The Chairman having thanked Ms Lanaghan for her report, it was:-

Report of the Northumbria Police – Sunderland West

Inspector Carty of Northumbria Police presented a report (copy circulated) which provided the Committee with an update on the Force's most recent performance indicators for the period 19th October 2016 to 4th December 2016.

Particular reference was paid to crime levels in relation to violent crime, vehicle crime, burglary from dwelling, burglary other than dwelling, criminal damage, shoplifting, youth ASB, Non Youth ASB and drug crime.

(For copy report – see original minutes)

In addition Inspector Carty briefed members on:-

i) the levelling off of overall crime in the south of the area compared to the west of the area where crime continued to rise overall. This was mainly because there were a greater number of public order type incidents occurring which would have previously been closed as anti-social behaviour,

ii) a reduction in burglary dwelling in the West – for the third month running the police had recorded fewer burglaries,

iii) Burglary to sheds, garages and commercial premises – this was an issue with no particular pattern across both the South and West of the Area. The arrest and

imprisonment of commercial burglars in the Pallion area had stopped the issues that were occurring around St Luke's Terrace.

iv) the reduction in Vehicle crime – the police aimed to keep this reduction going by targeting the Barnes and Eden Vale areas.

v) Anti-Social Behaviour – King George playing fields was the main ASB hotspot during October and November. The Police, Fire brigade and partners had put a considerable amount of work into stopping the fire related incidents. This culminated with a presentation at Farringdon community fire station which was attended by some of the children involved who were accompanied by their parents. They were shown video evidence of youths setting fire to wheelie bins and were also given a presentation by the Fire brigade concerning the danger and cost involved.

vi) the approach taken in respect of the darker nights campaign and the lack of major incidents over Bonfire night.

vii) the approach being adopted by the Police in relation to shoplifting

Councillor Tye referred to the King George playing fields and the development of a potential scheme to provide lighting to the area of the skate park. Councillor Essl advised that he would be more than happy for Councillor Tye to submit details of his proposal for consideration at the next meeting of the West Area Place Board.

Councillor Gofton thanked the Police for their assistance in the recent Pallion illuminations.

The Chairman having thanked Inspector Carty for his report, it was:-

Report of the Tyne and Wear Fire and Rescue Service

The report of the Tyne and Wear Fire and Rescue Service (TWFRS) (copy circulated) was submitted which provided the Committee with an update on the Service's performance indicators for the period 1st October, 2016 to 22nd November 2016, with particular reference to:-

- i) the number of deaths from all fires (none),
- ii) deliberate property fires (none),
- iii) deliberate vehicle fires (8), and
- iv) secondary fires not involving property or road vehicles (37).

Station Manager Steve Burdis, presented the report informing members of the partnership approach taken in respect of the anti-social behaviour occurring in King

George playing fields, the increase in vehicle fires for which there was no discernible pattern and his hope to bring the analysis of the darker nights campaign to the next meeting.

Members having welcomed that it had now been three years since a death caused through fire it was:-

REPORT OF THE HEAD OF EVENTS

THE TALL SHIPS RACES 2018

1. PURPOSE OF THE REPORT

1.1 The purpose of the report is to present to Elected Members options to consider in relation to community engagement as part of the Tall Ships Races event in 2018. The paper provides information on how residents in the West Area can participate in, contribute to and benefit from the event.

2. BACKGROUND

- 2.1 The Tall Ships Races Sunderland 2018 gives the city a unique opportunity to strengthen its position in the North East as a visitor destination, generate significant economic impact and pride for the City, and a superb opportunity to bring Sunderland's physical and cultural regeneration to a local, regional and international audience.
- 2.2 Moreover, The Tall Ships Races Sunderland 2018 will be a keystone in the City's ambition to become UK City of Culture in 2021, and allows the city to continue to celebrate its maritime heritage and showcase its natural and physical assets.

3.0 INVOLVEMENT IN THE SAIL TRAINEE PROGRAMME

- 3.1 The main aim of The Tall Ships Races series is to provide an opportunity for young people to develop their personal skills in a challenging and memorable sail-training environment and hence at least 50% of a Tall Ship's crew must be aged 15-25. As part of the contract with Sail Training International, Sunderland needs to provide opportunities for 100 sail trainees. To date there are 70 opportunities still remaining.
- 3.2 30 local young people have already had the opportunity to take part in a sail training voyage in summer 2016 via the Sail Training Ambassador programme, some mixed funding and sponsorship.
- 3.3 Each sail training voyage, which includes the berth on board a Tall Ship and travel, can be a life changing experience for some young people. There is also the requirement for each young person to have suitable equipment and clothing to take with them, e.g. warm clothes, waterproof jacket etc. In order for the young people to be committed to the opportunity, the young people are encouraged to raise funds to cover these latter costs.
- 3.4 The young trainees will be expected to engage with social media and be involved in marketing and PR activities before and after the event and act as positive ambassadors for the event.

4.0 ENTERTAINMENT/CULTURAL PROGRAMME

- 4.1 As part of the Tall Ships event there will be a cultural programme in the months leading up to the event and a continuous programme of public activity and entertainment throughout the 4 days of the event. Both provide a great opportunity for the West Area residents to be part of this extraordinary occasion.
- 4.2 Bids are being submitted to various external funding streams, for example Arts Council England and Heritage Lottery Fund, to fund this programme which will include large scale activities and smaller community projects.
- 4.3 Area VCS Networks will be approached to support this element of the Tall Ships cultural programme for smaller community projects in the West Area. These projects might be delivered in the run-up to the event and / or during the 4 day festival.
- 4.4 Moreover, the Tall Ships Team are working with The Cultural Spring to deliver a "Set the Sails" project involving four groups of young people from Hendon, Hetton, St Peters and Washington areas who will work with local artists and craftspeople to learn artisan skills and make a small flotilla of working scale-model ships. These ships will then be launched and sailed at a special event as part of the City's Tall Ships celebrations. It is intended to extend discussions with The Cultural Spring to develop opportunities for the West of Sunderland.

Place Board Progress Report

1 Purpose of Report

1.1 To provide an update of progress against the current year's (2016/17) Place Board Work Plan.

2. Background

2.1 Earlier last year the Local Area Plan's priorities associated with Place were referred to the West Place Board to action on behalf of the Area Committee. The Place Board continue to initiate action on those priorities and **Item 3 Annex 1** outlines progress to date.

3 Area Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:-
- a. Influencing decisions on services delivered at a local level; and
- b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's Corporate Outcomes Framework at a local level and ensures maximum impact where necessary through utilizing its own resources.
- 3.2 Area Place and People Boards were set up to support the Area Committee in identifying areas of priority and ensure action in line with those priorities.
- 3.3 Each ward has one elected member representative, whose role it is to liaise with their ward colleagues in between meetings and feedback collective views into the Board meetings. Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision making body and the work / recommendations of the Board will be presented to the Area Committees for final endorsement. 4. Key Areas of Influence/Achievements up to 28 February 2017

4.1 Outlined below is a summary of the key areas of influence / achievements of the West Place Board up to 28 February 2017.

Influence: Local Services, Place Management

Following the presentation of the Local Services Area Delivery Plan to the extraordinary Area Committee in May 2016, as agreed, Place Board continue to oversee the development and delivery of the 2016/2017 Delivery Plan.

Members have reviewed the performance data presented by the Place Management Service at Place Boards in September 2016 and January 2017, and discussed opportunities to engage further with communities.

The delivery plan for Local Services moving forward into 2017/2018 continues to be discussed extensively at the Place Board. Local area delivery plans are currently being developed for future Area Committee approval.

Place Board asked for a matrix of weed spraying activity for the 2017 season, to ensure Members can keep their communities advised of weed treatments in their wards. Place Board also asked for assurances that any further planned shrub maintenance works were shared with Members prior to works taking place.

Influence: Highways Maintenance Programme 2017/2018

The board received information on the highways requiring capital maintenance works across the West area. The proposed areas were prioritised into high, medium and low priority to assist members.

Members were asked to consult with ward colleagues to agree which of the proposed programmes should be recommended to Area Committee for completion up to a value of £101,000 for the West area.

At the February Board members agreed recommendations to Area Committee for the completion of capital maintenance programmes in the West, as described at **Item 3 Annex 2.**

Area Priority: Sho	
Business Support	Pallion Traders – Following the successful Christmas illuminations and activities the traders are now preparing for Easter as well as planning for Christmas 2017. The traders are also working hard to towards their 2017 In-bloom 'It's your Neighbourhood application'.
	Barnes are working with various local Traders to make improvements to paving as well as replacement litter bins and painting bollards.
	St Chad's are working with local traders and have made improvements to paving as well as replacement litter bins. Organised litter picks are now being planned and Councillors are working closely with schools to ensure litter is not dropped at local shopping centres during busy lunch periods.
	Silksworth continue to encourage local traders to utilise the advertising litter bins they installed into the area and are currently working with Silksworth Cricket Club on the development of a large-scale event.
	St Anne's continue to develop their It's your Neighbourhood in bloom route and plans are being developed to further enhance the route around the ward, looking at additional hanging baskets, flower beds and planters.
	Sandhill have arranged additional cleansing, litter bin installations and are working with local community organisations to improve planted areas throughout the ward.

REPORT OF THE CHAIR OF THE PEOPLE BOARD

People Board Progress Report

1 Purpose of Report

1.1 To provide an update of progress against the current year's (2016/17) People Board Work Plan.

2. Background

2.1 Earlier last year the Local Area Plan's priorities associated with People were referred to the West People Board to action on behalf of the Area Committee. The People Board continue to initiate action on those priorities and **Item 4 Annex 1** outlines progress to date.

3 Area Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:-
- a. Influencing decisions on services delivered at a local level; and
- b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's Corporate Outcomes Framework at a local level and ensures maximum impact where necessary through utilising its own resources.
- 3.2 Area Place and People Boards were set up to support the Area Committee in identifying areas' of priority and ensure action taken in line with those priorities.
- 3.3 Each ward has one elected member representative, whose role it is to liaise with their ward colleagues in between meetings and feedback collective views into the Board meetings. Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision making body and the work / recommendations of the Board will be presented to the Area Committees for final endorsement. 4. Key Areas of Influence/Achievements up to 28 February 2017

4.1 Outlined below is a summary of the key areas of influence / achievements of the West People Board up to 28th February 2017.

Influence: Health and Wellbeing

Clinical Commissioning Group (CCG) Joint Working

The Senior Commissioning Manager from the CCG attended the People Board in February to discuss the forward view for General Practice in Sunderland, following concerns raised by the Committee in relation to lack of GP's and increasing pressures on GP practices. Pressures on general practice are caused by increasing population, additional consultations, complexity of cases due to ageing population and increased costs. The CCG are working hard to free-up time within general practice by reducing bureaucracy and avoidable consultations, managing the interface with hospitals and exploring new ways of working.

They are looking to invest to increase the workforce, distribute the workload effectively, review practice infrastructure and redesign care pathways to ensure efficiency.

The general practice development programme is being implemented which involves leadership training, training for reception and clerical staff, practice manager development, online consultation systems and developing technology to further improve and streamline pathways.

People Board considered the presentation and shared their own views based on their personal experience to-date. The Senior Commissioning Manager considered all views and endeavoured to take action, where applicable.

Influence: Design, delivery and review of People based services devolved to Area Committee

Sport and Leisure Partnership – Everyone Active update for the third quarter was presented to the February People Board. Swimming lesson growth continues with 4428 children currently enrolled on Everyone Active swimming lessons across Sunderland. At the Silksworth pool, 667 children are taking part in the swim scheme (compared to 309 at June 2015). For health and fitness, there are 11,151 Everyone Active health and fitness members. At Silksworth there are 2602 members (compared to 1572 at June 2015).

The 3G pitches are now fully open with 1700 participants per week. Quarterly meetings booked in with the Tennis Club to continue to improve services. There has been an increase of Ski participants through a new management structure – increase by 120 a week (club growth). The plans for quarter 4 include the introduction of new Tennis and Fitness memberships to increase participants; Refurbishment of the Ski Centre and Increase 3G usage to 2000 participants a week.

Area Priority: Reducing mental health issues in young people

Following approval at October Area Committee to deliver the Mental Health for Young People Programme; West VCS organisations working with young people, alongside the Community Helpers and the Healthy Lifestyle Co-ordinator have been trained by Washington MIND to become Mental Health Champions, to recognise signs and enable early intervention to be adopted for our young people across the West.

A workshop was then facilitated by Area Arrangements with the newly trained West Mental Health Champions to develop a full proposal which was relevant to the West; not duplicating activity and support already available and which has the potential to make a real difference for young people. The delivery of projects must achieve partnership/collaborative working and lessons learnt must be shared.

14 bespoke applications were received **Item 6 Annex 6**, to deliver projects across the West, to support young people to improve their mental health and wellbeing, linking directly with the West Healthy Lifestyles Co-ordinator and all schools across the West. The People Board in February approved all applications and they were impressed with the quality of the applications and the focus on the target age-group.

The projects will now commence their delivery with an open event on 9th and 10th March, which invites all West Schools to come along and meet the projects/organisations and encourage sign-posting from schools to the provision. The signposting will then continue with the schools via the West Healthy Lifestyles Co-ordinator. The Senior Commissioning Manager from the CCG, who also attended the People Board, agreed that she would ensure GP's within the West signpost clients to the support, where appropriate.

Area Priority: Jo	b Prospects, Skills and reducing social isolation
Community Helpers	The Community Helpers continue to deliver across the six wards within the West. They are all working incredibly hard to engage with communities and those most in need. The Community Helpers have shared case studies with their ward Councillors The Community Helpers are currently working alongside the Area Arrangements team to develop an external funding application to enable them to continue delivery and support communities across the area
Community Led Local Delivery EU Funding (CLLD)	 Community Led Local Delivery (CLLD) funding overview report was presented to January People Board. The report was discussed in detail. The final application for European CLLD funding was submitted on 31st January 2017. The CLLD application seeks support to deliver the Sunderland CLLD strategy from April 2017- March 2022, requesting £3.05m of European funds:- £2.15m for European Social Fund (ESF) and £900k from the European Regional Development Fund (ERDF). A further £2.75m would need to be secured as match funding from non-European funding sources, bringing the total value of the Local Development Strategy to £5.8m. Full approval for CLLD funding is anticipated in April/May 2017, after which time the programme will be in a position to launch its first call for projects. At the West People Board in February, members agreed to recommend to Area Committee the alignment of an initial £60k SIB funding, to ensure match-funding was in place, to support West projects who wish to deliver CLLD activities, but who are unable to secure match-funding from other sources. West Intensive Recruitment Employment Support (WIRES 2)	 WIRES 2 continue to work with young people aged 16+ signposting to training, practical work experience and sustainable progression routes. One young person who had complex needs has accessed the WIRES 2 project and has successfully gained qualifications in First Aid, Food Safety Level 2, Personal and Social Development and also gained his Literacy and Numeracy Level 1. The young person has an interview with Home Group in March and is continuing to volunteer at Parker Trust. WIRES 2 are working very effectively with the Link School in Pallion, they are particularly interested in their pupils accessing the practical works experience that Parker Trust can offer. WIRES 2 has been working with pupils from Farringdon Academy and Barbara Priestman School, the pupils have been accessing the project on a Wednesday morning and have been creating benches for their schools through up-cycling. WIRES 2 worked with Morethan who delivered a "Great to Good Session" for a group of 16 to 18 West area young people. Three of the young people successfully went on to have interviews for the ACES Project and secured apprenticeships at Age UK, Washington MIND and FISCUS.
	Whilst delivering the WIRES 2 Project, a high percentage of young

	All 18 schools in the West also continue to deliver their Change4Life Clubs and the Change4Life Clubs will be attending the West Event in Barnes Park later this year, alongside other class groups from across the schools in the West of Sunderland.

Holiday Hunger	Following approval at December Area Committee, the remaining funds from the Summer Holiday Hunger project were used to support families, in receipt of Free School meals, over the Christmas period. Further activities were held during the February school half-term holidays and ward councillors continue to be updated with ward activities and plans for the Easter holidays.		

Activities for Young People	People Board in February discussed the importance of further activities for young people across the West area, particularly in relation to community cohesion and reducing ASB. The People Board agreed to make a recommendation to March Area Committee to align SIB funding to support activities for young people, which would be subject to a full call for projects. Item 6 .
Leaving Care – Enhancing outcomes in the West of	Whilst delivering the WIRES 2 Project, a high percentage of young people who are at risk of becoming NEET come from similar backgrounds - looked after children and children leaving care.
Sunderland	These young people have multiple barriers and evidence is proving that a bespoke approach to engage, support and sustain a positive relationship throughout the WIRES 2 Project is starting to make a difference. During delivery of the WIRES 2 Project, Parker Trust has learned that they need more time to offer pastoral support, before trying to engage a young person on any type of education/training process.
	Parker Trust presented a report to West People Board in February, to support the West Area Committee to deliver its priority regarding support for young people, and has developed a proposal based upon local intelligence and lessons learnt to-date.
	Parker Trust would work alongside several organisations, to offer an additional bespoke resource to up to 45 young people who have additional needs, which does not duplicate statutory provision via the Sunderland provider framework (Gateway Team, Sunderland Leaving Care Team, but enhances their journey to live independently.
	 Parker Trust would offer the following activities within the package: Practical skills such as cooking, budgeting and decorating where they can obtain "hands on experience" including up-cycling their own furniture for trainer flats or their own tenancy;
	 Access to Counselling Services within 24hours; On-site benefit advisor; Personal coaching to raise aspirations
	Timescales for the project for 18 months would commence 1 June 2017 up to and including, 31 December 2018.
	Monthly meetings would be held between Parker Trust and the West Area Co-ordinator. These meetings would measure delivery, achievement of outcomes and enable the chance to share immediate lessons learnt, emerging issues and opportunities to further strengthen partnerships. The meetings would permit the gathering of intelligence and data about the actual usage of the project which in turn allows appropriate monitoring of patterns and trends for demand. This monitoring would continue to underpin Contract and Commissioning arrangements between Sunderland City Council and other Partners.

- 3.2 The VCS network met in January and discussed the West Enterprise project and how to refer individuals into the project. The network also had the opportunity to understand the services offered by Access to Counselling, which is based in the West.
- 3.3 During the March meeting the network discussed the West Area Event and opportunities to participate within the theme of Science, Engineering and the Environment.
- 3.4 The VCS discussed the projects recently approved for Young People's Mental Health and Wellbeing. Details were provided to groups to ensure the whole network could signpost where required. The network were also reminded of the opportunity and support available to further identify Mental Health training requirements, to support staff and volunteers within their organisations.
- 3.5 The VCS are working together to plan how they can help and support each other through sharing of skills, knowledge and resources.
- 3.6 The network continues to receive GRANTfinder opportunities and so far over £70k has been secured in the West.

REPORT OF THE NORTHUMBRIA POLICE – SUNDERLAND WEST

1. Purpose of Report

1.1 The following report provides performance information in relation to the Sunderland West Committee area from 1st December 2016 – 28th February 2017.

2. Background

2.1 At its November 2011 meeting Area Committee agreed that regular updates on Crime and Community Safety would be presented to each Committee meeting.

3. Events and Updates

- 3.1 During December the Neighbourhood Police team ran a burglary operation in the Barnes and Pallion area. Officers patrolled in plain clothes and a "leave the light on" leaflet campaign was conducted in the streets where there had been a recent burglary. There were only two burglary dwelling reported in these areas during December.
- 3.2 During the last reporting period Crime levelled off in the West and rose slightly in the South. We are coming to the end of the year for recorded crime and Northumbria Police is likely to record a 30 % increase in overall crime. Sunderland South + 28% and Sunderland West +26% are therefore below the force average.
- 3.3 Burglary dwelling shows an overall rise in the South but the number of offences is low (average of 1 burglary a week over the course of the year). In the West the news is even better with a 19% reduction likely to be recorded. Recently there was a period of 22 days when not one burglary dwelling was reported in any of the wards.

On the 25th January 2017 there was a burglary to a home on West Park, East Herrington. The team identified the male responsible from a neighbours CCTV. The CCTV only showed the male leaving the street however when we caught him he still had a car key belonging to the victim in his pocket. He is one of our most prolific burglars, who was also responsible for the rise in burglaries to shed and garages across the area. He is now looking at a long prison sentence which is good news.

- 3.4 Burglary to sheds, garages and commercial premises is an issue with no particular pattern across both the South and West. We have had an average rise of 8 offences a month since the start of the financial year. Since the male mentioned in 3.3 has been remanded in custody the number of offences has slowed down.
- 3.5 Vehicle crime has at last begun to slow down across the South and West. The Barnes area has one of the highest levels of car crime in the City mainly because residents are not locking their cars overnight. There is a campaign planned shortly to try and address this issue.
- 3.6 During the reporting period there were two incidents which received significant media attention. The armed robbery at Ford Post office on 17 January 2017 was particularly worrying as a shotgun was discharged. Both the males responsible are from the Ford Estate area. One of the males was charged and remanded the next day. Evidentially

the second offender was more challenging however he was remanded in custody on 22nd February. Two very dangerous individuals we no longer have to worry about.

There was also the suspicious death in Bishopwearmouth Cemetery which was eventually, sadly, proved to be a suicide.

- 3.7 Anti-Social Behaviour remains a priority. The team are currently concentrating their efforts around Belsay House/Castle mews. It is a difficult long standing issue mainly because the area was poorly designed. St Chad's ward Councillors have been proactive in this area, in partnership with Farringdon Community Academy and have recently funded the reduction of shrubs to allow more daylight into the walkway, removing potential hiding places and litter traps and therefore reducing anti-social behaviour in the area. The area will continue to be monitored.
- 3.8 Forward Planning:

As mentioned at 3.5 the Neighbourhood teams will be doing crime prevention work for car crime in the Barnes area. We will no doubt also see a rise in Motorbike disorder in the coming months. We are planning a leaflet campaign targeting people who use our open spaces on a daily basis, for example Dog Walkers asking for their help in identifying offenders.

4. Update – Area Information

- 4.1 The ward updates below are a selection of appropriate offence types of interest and not all crime (e.g. minor fraud or harassment type offences etc. are not included).
- 4.2 Figures are from the 1st April 2016 as the computer programme would not allow comparisons spanning different financial years.

1.1 The following report provides an update from Gentoo for the West Area of Sunderland from December 2016 to March 2017.

2 Background

2.1 Area Committee agreed that regular updates from Gentoo would be presented to each Committee meeting to enable members to be up-to-date on current Gentoo developments, projects and priorities.

3. Neighbourhood Services Update

- 3.1 A fundamental service review of our Repairs & Maintenance service is on going and a number of changes to the service have recently been communicated to customers. These include the clarification of customers' rights and responsibilities, such as the replacement of toilet seats, lock changes and lost keys and the provision of flooring. Changes will continue to be communicated via a new Tenant's Handbook planned later this year and the updating of our website and social media channels.
- 3.2 Gentoo continues to track the actual and potential impacts of Welfare Reforms on our customers. These include the Local Housing Allowance Cap, changes to the Local Housing Allowance for supported housing and the removal of automatic Housing Benefit entitlement for 18 – 21 year olds. To date the actual impacts of changes already in place, such as the Bedroom Tax and the introduction of Universal Credit, have been far less than the potential maximum exposure for Gentoo and we are confident we have the appropriate support in place to assist our customers.

4. Community Partnership Coordinator Activity

4.1 A recent meeting of our Community Partnerships Operations Manager and the City Council's Area Coordinator has clarified joint concerns and how we can jointly support communities in the West Area. Each local Community Partnership Coordinator has now been tasked with local priorities and our Operations Manager will pick up any overarching issues citywide.

5. Investment & Renewal

5.1 New build activity is ongoing in High Ford where the Hillcrag development will provide 132 new homes, all for affordable rent. To date 32 new homes have been let. On Doxford Park the Thurcroft development is providing 155 new homes, all for sale.

5.2 We are continuing the stock condition survey of all of our homes and the results of this will inform future Investment Plan activity from 2017/18.

REPORT OF THE HEAD OF MEMBER SUPPORT AND COMMUNITY PARTNERSHIPS

Strategic Initiative Budget (SIB), Community Chest – Financial Statement and proposals for further allocation of resources

1. Purpose of Report

1.1 Area Committee has delegated budgets to allocate to specific strategic priorities identified in the Local Area Plan, with the overall aim to benefit the wider community and to attract other funding into the area. The report provides a financial statement as an update position on progress in relation to allocating SIB and Community Chest and presents proposals for further funding requests.

2 Strategic Initiatives Budget (SIB)

2.1 The table below shows the financial position of SIB for 2016/2017:

- 2.2 The People Boards have made the following recommendations for SIB funding to Area Committee for consideration.
- 2.3 At the West People Board in February, members agreed to recommend to Area Committee the alignment of an initial £60,000 SIB funding, to ensure match-funding was in place, to support West projects who wish to deliver CLLD activities, but who are unable to secure match-funding from other sources. **Item 6 Annex 1**.

- 2.4 At the West People Board in February, members received a presentation on a project to support young people leaving care in the West of Sunderland. The People Board have made the recommendation to Area Committee to approve and support Parker Trust to deliver the West Leaving Care Project for £45,000 SIB. **Item 6 Annex 2**.
- 2.5 Following a discussion at the People Board in February, members agreed to recommend to Area Committee the alignment of £40,000 SIB to support a call for projects, to deliver additional youth activities within the West of Sunderland, to promote community cohesion and to reduce Anti-social behaviour. **Item 4**
- 2.6 The Place Board have made the following recommendations for SIB funding to Area Committee for consideration.
- 2.7 During the Area Committee meeting in December, following the Police and Fire reports in relation to ASB and fires at King George Playing Fields, the Committee agreed to refer to the Place Board, a potential project to support the installation of lighting to reduce ASB and enable communities to use the outdoor space during the darker nights. The Place board considered the issues during the January and February boards, site visits were undertaken and a proposal was presented to the February Place Board to fund the installation of lighting. Place Board agreed to recommend to Area Committee the allocation of £12,925 SIB for lighting at King George Playing Fields **Item 6 Annex 3**.
- 2.8 The February Place board considered the findings from the recent energy audits carried out on Community facilities in the West. The Place Board recommends the full allocation, as detailed within **Item 6 Annex 4.**
- 2.9 The total SIB budget requested for approval for the above projects totals £157,925, if approved the balance of SIB funding remaining for 2016/2017, would be £0.

3 Maximising Green Spaces Funding

3.1 There were 3 maximising green spaces approvals between January 2017 and February 2017. **Item 6 Annex 5** details the approvals to-date as part of the maximising green spaces to improve health within the West, leaving a balance of zero.

4. West Health Programme

The People Board in February reviewed all applications and they were impressed with the quality of the applications and the focus on the target age-group. The Projects are due to deliver from March to July 2017.

Community Led Local Development (CLLD) – Next steps for the West

1. Introduction

- 1.1 CLLD overview report was presented to January People Board. The report was discussed in detail.
- 1.2 The People Board agreed to receive a further report, developing a proposal to potentially recommend to Area Committee, to align funding to support west VCS organisations who apply for CLLD funding in the future, who in turn would require match-funding to secure the CLLD grant.

2. Supporting the West

- 2.1 The final application for CLLD funding was submitted on 31st January 2017. The CLLD application seeks support to deliver the Sunderland CLLD strategy from April 2017- March 2022, requesting £3.05m of European funds:-
 - £2.15m for European Social Fund (ESF) and
 - £900k from the European Regional Development Fund (ERDF).
- 2.2 A further £2.75m will need to be secured as match funding form non-European funding sources, bringing the total value of the Local Development Strategy to £5.8m.
- 2.3 Approval for CLLD funding is anticipated in April/May 2017, after which time the programme will be in a position to launch its first call for projects.
- 2.4 At the West People Board in January, members considered the possibility of aligning £100k SIB funding, to ensure match-funding was in place, to support West projects who wish to deliver CLLD activities, but who are unable to secure match-funding from other sources.

3. Type of activity to be delivered for CLLD Funding

- 3.1 Following Government approval of the CLLD funding, the CLLD funding will be launched within Sunderland. West VCS organisations will then be offered the opportunity to apply for CLLD funding, to deliver projects which focus upon the three CLLD objectives:
 - Objective 1 Enhance employment and skills provision
 - Action 1.1 Projects /initiatives which support effective engagement, finding and signposting of clients missing out on employability and skills support (ESF £250k/£250k match required)
 - Action 1.2 Projects/initiatives which provide beneficiaries with pre-employability support and their transition into work (ESF £900k / £900k match required)
 - Objective 2 Boost enterprise and entrepreneurship
 - **Action 2.1** Projects/initiatives which support enterprise awareness and develop a stronger enterprise culture (ERDF £300k/£200k match required)

- Action 2.2 Projects/initiatives which promote community enterprise development including pre-start and start-up support (ERDF £600k/£400k match required)
- Objective 3 Improve community capacity, partnership working and social innovation
- Action 3.1 Projects that promote leadership development, volunteering, active inclusion and citizenship, and that support the sustainability of VCSE organisations (ESF -£350k/£350k match required)
- Action 3.2 Projects which stimulate innovation and investigate, develop and implement new opportunities, services and models, including social investment activity. (ESF £350k/£350k match required).
- 3.2 Projects/initiatives must address ways to fill gaps in local employment and skills provision, stimulate pilot projects and build the capacity of specific client groups, organisations, potential entrepreneurs and local enterprises.

4. Who will benefit from the West?

4.1 Our West VCS organisations who apply for CLLD funding. Their applications would be submitted, following a call for projects via the CLLD Local Action Group (LAG). The applications will be assessed by the CLLD Local Action Group and funding approved, following a robust process.

5. Match Funding

- 5.1 For every pound secured from CLLD funding, a pound of match-funding must be secured, prior to the CLLD funds being handed-over. To ensure the organisations with the West stand the best possible chance of securing the CLLD funding, Area Committee may wish to consider aligning £60,000 SIB funding, to enable those organisations who successfully received CLLD funding, to utilise SIB as match subject to full Area Committee approval for each application.
- 5.2 For example if a West VCS organisation submitted an application to the CLLD LAG to deliver an employment project, they would need to secure the match funding before submission. The project, if successful, would then be required to submit all relevant evaluations for project delivery, to both the CLLD LAG and the West Area Committee/People Board respectively.

6. Recommendations

- 6.1 Consider the report and make a recommendation to West Area Committee in relation to the potential alignment of SIB to support match-funding requirements for West CLLD projects.
- 6.2 Continue to ensure the West Area Committee is fully involved in the delivery of the CLLD Strategy and that West residents benefit from this funding opportunity.

Leaving Care – Enhancing outcomes in the West of Sunderland

West People Board – 13 February 2017

1. Purpose of report

1.1 To present the current support available for young people leaving care in Sunderland and review how a new proposal could be delivered within the West of Sunderland, to offer enhanced opportunities for those young people on their journey to leave care, who would benefit from additional bespoke activities, designed to improve their personal aspirations. A key outcome from the proposal is to ensure that lessons learnt and opportunities are shared through a structured process to continue to strengthen partnerships to ensure the very best outcomes for our young people.

2. Background

2.1 One third of young people leave care before their 18th birthday. This is in stark contrast to the general population where 50% are still living with their parents at 24. National research has shown that a half of care-leavers believe they are made to leave care too early and say they receive little preparation and support for the challenges of adult life. They too often find themselves lonely and isolated without people to turn to. Systems that are intended to help with the transition may not always work as effectively as they could, particularly if a young person has multiple needs – the result, is that care-leavers make up a hugely disproportionate percentage of people suffering mental and physical health problems, experiencing homelessness and serving prison sentences.

3. Parker Trust Charity – Kayll Road, Sunderland

- 3.1 Parker Trust is becoming a beacon in the community, building a reputation for quality provision for young people and community members in Sunderland. Parker Trust offers more people the chance to get into employment, improve their skills, raise aspirations, encourage personal empowerment and ultimately reduce the impact of the continuing need for diminishing public services. Parker Trust shares the West Area Committee priority to empower people to change their own lives, creating stronger local communities and improve the local economy.
- 3.2 Parker Trust, based in Pallion, empower people and communities they create an alternative learning environment concentrating on developing 'hands on' trades and skills not just gaining an accreditation or qualification (which is often unreachable for some). They have developed and sustained strong partnerships with statutory, voluntary and public sector as they firmly believe that working together can create a positive change.

3.3 Parker Trust considers every organisation as a potential partner. They are creating a trusting, warm, relaxed environment where services delivered are based on trust, strong principled values and a positive culture, not just around outputs being designed and delivered.

4. Parker Trust – what they are learning about young people leaving care

- 4.1 Whilst delivering the WIRES 2 Project, a high percentage of young people who are at risk of becoming NEET come from similar backgrounds looked after children and children leaving care. Currently referrals from leaving care come through a young person's allocated keyworkers,
- 4.2 These young people have multiple barriers and evidence is proving that a bespoke approach to engage, support and sustain a positive relationship throughout the WIRES 2 Project is starting to make a difference. During delivery of the WIRES 2 Project, Parker Trust has learned that they need more time to offer pastoral support, before trying to engage a young person on any type of education/training process.
- 4.3 Parker Trust has also learned that creating a strong consistent relationship with an individual, implementing robust boundaries and clear pathways yielded a better result, with young people wanting to access Parker Trust and looking forward to doing any work, tasks, training, volunteering and works experience. In fact the young people wanted to access Parker Trust more than they had originally planned for, as they felt comfortable with the services and developed a trust with the worker.
- 4.4 The young people often benefit from signposting to volunteering/ training opportunities, a space for practical work experience, advice on PIP forms etc. Having support agencies connecting through one place such as Parker Trust could continue to support the development of more efficient and effective pathways.
- 4.5 Parker Trust endeavours to find bespoke training opportunities for a young person but the young person may not be able to attend due to certain barriers including paranoia or there may be no staff from statutory organisations or allocated key workers who can take the young person to the training, (as the training is not statutory). Quite often the training can be 'small steps on a journey' and not a college/formal education course, so it is often not a requirement for key workers to ensure the young person attends.
- 4.6 Parker Trust is viewed by the young people as a trusting environment, it has a homely feel and young people want to access provision there. Parker Trust can complement other statutory provision and offer opportunities in a bespoke way, using the knowledge and expertise they have due to the grassroots level they consistently deliver at. Parker Trust wishes to support Care Leavers to

feel emotionally stable and be financially secure, ultimately making a successful transition to independence and a positive future.

- 4.7 Parker Trust understands that all agencies work tirelessly to help a young person reach their full potential and to be self-reliant but they have found that those with more complex needs, have additional challenges and are not as ready to access provision offered by a statutory system.
- 4.8 Parker Trust, working alongside Sunderland City Council want all young people to receive a consistently high standard of statutory support that continues to be developed, utilising feedback from new interventions and ways of working resulting in care leavers easily able to form healthy relationships, which enable them to make a successful transition to adulthood.

5. Proposal

- 5.1 Parker Trust would like to support the West Area Committee to deliver its priority regarding support for young people, and has developed a proposal based upon local intelligence and lessons learnt to-date.
- 5.2 Parker Trust would work alongside several organisations, to offer an additional bespoke resource to up to 45 young people who have additional needs, which does not duplicate statutory provision via the Sunderland provider framework (Gateway Team, Sunderland Leaving Care Team, but enhances their journey to live independently. The organisations may include:
 - Bell House, Centrepoint
 - Harbour View, Centrepoint
 - Lewis Crescent, Centrepoint
 - Dundas Street, Centrepoint
 - Swan lodge, Salvation Army
 - Toward Road, Salvation Army
 - Holmewood, Gentoo
 - Burlington Close, Sunderland Council
- 5.3 Parker Trust would offer the following activities within the package:
 - Practical skills such as cooking, budgeting and decorating where they can obtain "hands on experience" including up-cycling their own furniture for trainer flats or their own tenancy;
 - Access to Counselling Services within 24hours;
 - On-site benefit advisor;
 - Personal coaching to raise aspirations

- 5.4 Parker would create long lasting positive relationships with an individual and nurture and develop relationships with significant adults such as teachers, police, and youth workers.
- 5.5 Parker Trust would involve care leavers in decisions about their own lives and in the design of services, in order that they are able to influence the structures and processes that govern how they are treated. They would offer one to one support creating a bespoke, personalised, wrap-around support pathway based at Parker Trust - understanding that all young people are different and a one stop approach may not suit all.
- 5.6 This support would be initiated by developing an individualised pen picture and then agreeing the pathway plan of that person's needs, goals and aspirations in a non-judgmental way. Gaining trust is the essential element as experience has shown, it is crucial to achieve positive outcomes. Parker Trust would provide a safe, warm environment so that young people feel comfortable and not overwhelmed.
- 5.7 'Enabling a young person' is the principal of Parker Trust's approach and accepting also that a pathway plan requires flexibility, to suit an individuals' personal development journey. Parker Trust would utilise resources within the City to ensure value for money including the use of training providers to offer accreditation including FACL providers who are OFSTED approved. Parker Trust would manage and co-ordinate the delivery of a specialist support model that is aligned to and compliments statutory care planning for young people.

6. Finance

- 6.1 To make an impact and create this longer-term legacy Parker Trust would require funding for 18 months. Work would be delivered predominately from Parker Trust's premises but can and will be offered outreach to other venues within the West, if required.
- 6.2 Parker Trust has up-cycled/recycle materials donated from the local community and Dulux including furniture, paint, brushes and tools. Parker Trust has a fully fitted kitchen with equipment and qualified volunteers who can facilitate cooking sessions.
- 6.3 Parker Trust works closely with Rose Training who offer FACL funded oneday courses relevant to individuals who wish to progress in education/training. They also work in partnership with Access Counselling who are based oneday per week in Parker Trust's premises. Parker Trust work in partnership with Sunderland West Advice Project and ACES project who would offer benefit/debt/money advice.


- 6.4 Cost for Parker Trust to deliver this project for 18 months is £60,000 to support 45 young people with a bespoke individual package, working in partnership with statutory providers to enhance delivery for those young people who would benefit from one-to-one support, guidance and direction.
- 6.5 Timescales for the project for 18 months would commence 1 June 2017 up to and including, 31 December 2018.
- 6.6 Parker Trust has secured match-funding from ESF Community Grant. Parker would also utilise FREE training from providers to maximise added value for money to support activity costs.
- 6.7 Funding required is therefore £45,000.

7. Sharing lessons learnt

- 7.1 Monthly meetings would be held between Parker Trust and the West Area Coordinator. These meetings would measure delivery, achievement of outcomes and enable the chance to share immediate lessons learnt, emerging issues and opportunities to further strengthen partnerships. The meetings would permit the gathering of intelligence and data about the actual usage of the project which in turn allows appropriate monitoring of patterns and trends for demand.
- 7.2 This monitoring would continue to underpin Contract and Commissioning arrangements between Sunderland City Council and other Partners.

8. Recommendations

- 8.1 Note the content of the report.
- 8.2 Consider and agree a recommendation for Area Committee in relation to:
 - a) Delivery of a 'Leaving Care Enhancing outcomes in the West of Sunderland project', developing a unique local offer for our young people
 - b) Approach to sharing lessons learnt and opportunities to continue to strengthen partnerships to ensure the very best outcomes for our young people

West Area Committee Energy Efficiency Improvements for Community Buildings

West Place Board Report – 16 February 2017

Introduction

Energy Surveys have been carried out a various community buildings within the West Area Committee boundary. West Area committee allocated £15,000 per ward for energy efficiency measures along with £10,000 for surveys and management of the scheme. The surveys have been undertaken by the Council's Energy Conservation Team and the priority energy efficiency measures have been identified with budget costs provided or where indicated a quotation obtained by the relevant community group.

The implementation of these measures will save energy, carbon emissions and reduce the operating costs (energy and maintenance) of the various community groups. Utility costs are a significant financial pressure to community organisation but are to some degree controllable with investment in energy efficiency measures and through improved energy awareness and good housekeeping. Some measures (predominantly lighting) will also improve the appearance of the internal environment whilst other measures (heating related) will improve comfort levels in buildings. Improvements in aesthetic appearance and comfort levels will also potentially increase use at the various Centres.

The completed audit for each building will be provided to the relevant organisation and members by 31/03/17.

Programme Conditions

A summary of measures by building for each ward within the constraints of the budget allocation are attached to this executive summary. As well as the implementations of these measures it is recommended that members agree to the following conditions being implemented to maximise energy savings and ensure value for money.

1) The scope of works and specification/designs are approved by mechanical and electrical building services engineers from within the Council. This process will be co-ordinated by the Council's Energy Manager who also has management responsibility for the building services engineers. The Energy Manager will thoroughly review all quotations to ensure best value for money and that all energy savings are maximised.

2) All heating controls which are not recommended for replacement (i.e. those to be retained) are recommissioned to suit occupancy patterns in buildings. This work can be arranged by the Council's Energy Conservation Team.

3) The Energy Conservation Team will arrange an energy awareness training session for 2 representatives from each organisation. Attendance at this event is a necessary condition of receiving any grant funding.

4) No works shall proceed without an appropriate asbestos survey being in place. There will be a contribution of £500 to each group if an asbestos survey is required. The cost of asbestos removal should be borne by the community group and if this is not possible or is prohibitive then the works will not proceed.

5) Any underspend from the initial funding allocation should be reinvested in other energy efficiency measures highlighted in the summary of measures, where currently only a partial contribution or no contribution has been awarded.

It is recognised that funding is limited under this programme however the cost of conditions 1-4 will be met from the initial funding allocation for surveys.

The Council's Energy Manager and the West Area Community Development Lead will advise Lambton Street Youth Centre and Pennywell Young People's Project in relation to funding opportunities at these sites. The capital cost of implementing energy efficiency measures in full at these sites is greater than this programme can meet.

Overall Recommendations

Members are asked to note the findings of this summary report and agree to the summary of measures identified with suggested grant contribution levels.

Following approval at October Area Committee to deliver the Mental Health for Young People Programme; West VCS working with young people, alongside the Community Helpers and the Healthy Lifestyle Co-ordinator have been trained by Washington MIND to become Mental Health Champions, to recognise signs and enable early intervention to be adopted for our young people across the West. A workshop was then facilitated by Area Arrangements with the West Mental Health Champions to develop a collaborative approach to ensure no duplicating of activity and making use of support already available and which has the potential to make a real difference for young people. The projects will be delivered between March and July 2017 with a launch to primary school on the 9th and 10th March facilitated by the Healthy Lifestyles Co-ordinator.
