#### **SAC80       Feedback from Primary CPD**

Mrs Forbes updated the group on the feedback from the Primary CPD and commented that it had been disappointing that only 14 out of the 83 schools invited had attended. It was also disappointing that only one response had been received in relation to the survey circulated afterwards however, Mrs Forbes did advise that the verbal feedback on the event had been very positive from the attendees.

The Chairman suggested that the issue be put on the Headteachers agenda.

Councillor Marshall enquired if the schools were doing their own thing. Ms Fountain advised that her school followed the agreed syllabus from the Local Authority and felt this presented a broad and balanced curriculum.

Mrs Forbes advised of the difficulties in getting people to sign up to their Network when they were already paying for use of the one in Durham, which was already an extensive network.

Councillor Williams commented that she felt the Council had dropped the ball in this regard and it was difficult to pull this back. Mrs Forbes advised that they could continue to put expressions of interest out.

Ms Fountain commented that there was still good practices to be shared and rolled out but the difficulty in setting up a Network was not just an issue for religious education, but for all subjects and strong R.E leadership was in short supply.
