### 1. INTRODUCTION

1.1 The purpose of this report is to provide members with a progress report on the analysis of performance against targets for the first quarter (April-June 2008) as detailed in the EPU Business Plan 2008/10.


### 2. BACKGROUND

- Progress reports relating to the performance of the EPU are produced five times per year: i.e. one report is produced at the end of each quarter relating to the preceding quarters targets; and a final summary report is produced at the year end on the overall delivery outputs relating to stated business plan commitments. These reports are tabled and discussed at the regular quarterly meetings between the Chief Emergency Planning Officer (CEPO) and the District Liaison Officers (DLO) from each of the five Tyne and Wear councils. These officers comprise the Strategic Management Board.
- 2.2 However quarterly performance against targets has not, to date, been routinely reported to members of the Civil Contingencies Committee. Members are therefore asked to consider the contents of this report and the continued receipt of regular quarterly performance reports in order to form a general overview of the EPU's performance.

### 3. ANALYSIS OF THE OUTCOMES OF THE TARGETS

- 3.1 The first quarter progress report is completed in terms of:
  - Number of targets met;
  - Number of targets reprioritised;
  - Update of reprioritized targets from previous quarter
  - Number of local authority staff trained.






The following charts provide the numbers of local authority staff trained by EPU staff who attended modules held at the unit during 1<sup>st</sup> quarter 2008/09.
