The following options have been considered and are recommended to be rejected;

Reuse the Elemore Golf Club site as a golf course. This option is not recommended as the Council previously readvertised the site for this use and there were no expressions of interest.

There are no other economically viable alternatives to achieve the desired outcome, which after significant resident consultation, it is clear that residents wish to see the site brought back into use as an open country park, garden centre, visitor centre and community space.

## **Reasons for decision:**

The proposal to continue to contribute to FRESH and BALANCE aims to help ensure a joined-up approach between Sunderland and the other six contributing North East Councils to provide comprehensive and evidencebased ways to control tobacco and reduce alcohol harms.

## Alternative options considered and rejected:

There are two potential alternative option as follows:

- (i) Do not extend the Council's participation in the regional Fresh and Balance arrangements for the period 01 April 2022 to 30 September 2024 (i.e., do nothing). This would result in the service being discontinued on 31 March 2022 and as a result, a comprehensive evidence-based approach to reduce the harms of tobacco and alcohol would not be in place in Sunderland.
- (ii) Re-procure the identified services for Sunderland alone, outside of the regional commissioning arrangements. This is not recommended as the current contracting arrangement offers economies of scale and would be significantly more expensive for an individual council.
