FEEDBACK FROM SUNDERLAND ADULTS PARTNERSHIP BOARD

Report of the Chair of the Adults Partnership Board

The Adults Partnership Board met on the 23rd July. **ITEM**

4. Urgent Care & Care Homes Task and Finish Group Update

A verbal update on the task and finish group was provided by Graham King. The group had identified three key themes and applied for CCG funding for 1 year pilot projects; podiatry(with City Hospitals Sunderland), enhanced GP services within care homes and specialist nursing support within care homes(with STFT). All 3 have been successful. Reports will be produced for the CCG as funders and also brought to the Adults Board.

5. Winterbourne View Stock Take

Alan Cormack provided an update on the Winterbourne View Hospital Report. The Board noted the following four recommendations in the report:

- The deadline of the 1st June was met;
- There were no individuals 'inappropriately placed' in hospital;
- The required stock take was completed and returned;
- Further progress reports will be made to this Board and the Health and Wellbeing Board if required.

6. Health & Wellbeing Board

- Agenda

Karen Graham provided details on the Health & Wellbeing Agenda for July. The Board noted the role of the Adults Partnership Board in overseeing performance against the 3 outcomes frameworks and agreed to receive a report to its next meeting on mechanisms to do this.

7. The Role of Pharmacies in Delivering Health and Wellbeing

A presentation was given by Mukarrom Hussain and Professor Jim Smith from Sunderland Local Pharmaceutical Society with regard to an integrated approach to healthcare. The presentation showed 71% of pharmacies are based in local areas, with 6m prescriptions issued per year. All community pharmacies are required to provide essential services but can also provide advanced services and locally commissioned enhanced services. The report gave details on the Minor Aliments Service and how the pressure could be lifted from A & E. A difference between the ability to advertise this service in Newcastle and Sunderland – Graham King to follow up why.

It was noted how pharmacists in the City could contribute to delivering the HWBB programme and particularly objectives 2, 3, 4, and 6.

8. Domestic Violence Needs Assessment Update

Glen Wilson presented a report on the Domestic Violence Needs Assessment. The aim of the report is to identify the scale of the issue, describe the existing services, map the need for services, develop the service and review the impacts of partnership working. Currently around 6,000 incidents are reported each year with an estimated annual cost of domestic violence in Sunderland of £79.6m. It is estimated that another 6000 cases are going unreported. Reported incidents for the over 50's (per 1000) is 6.7%. GW gave an overall view of all the recommendations for each of the partners, Adults, Safer Sunderland, Public Health, Children's Trust, Commissioners and Providers. The Board agreed to the recommendations.

9. Any Other Business

Alan Patchett noted a national report on the priority given to Fuel Poverty in HWB Strategies. KG reported that the Sunderland HWB Strategy does not go into this level of detail but this would be included at action planning stage and through the JSNA. The Chair agreed this work would be reported back to the Board.
