Gateshead Council consider their appointments to the Fire Authority at the first Cabinet Meeting of the Municipal Year. This meeting will not take place until Tuesday 24th June, however the effect of sections 31 and 32 of the Local Government Act 1985 is that a Member of the Authority who has continued to be a member of the constituent council will remain a Member of the Fire Authority until receipt of notification of any change.



APPOINTMENT OF COMMITTEES AND APPOINTMENT OF SPOKESMEN

The present political balance of 12.2.2 gives a distribution of seats as per Appendix 1 attached.

A copy of the 2013/14 composition of the Authority's Committees and Sub-Committees together with a list of the Authority's spokesmen for 2013/14 is appended at Appendix 2 for information only.

The Authority is reminded of the duty, under the Local Government and Housing Act 1989, to maintain political balance on the Committees and Sub-Committees or to approve "alternative arrangements" pursuant to Section 17 of the 1989 Act. A resolution to approve "alternative arrangements" requires a unanimous decision of the Authority.

On 17 September 2012 the Authority appointed Anthony Atkinson and Sheba Joseph to act as Independent Persons for the Authority, in accordance with the requirements of the Localism Act 2011. The appointments were for two years with an option to extend for a further three years. Anthony Atkinson has advised that he does not wish his office to be extended. In view of the fact that no complaints have been received, it is proposed that at the present time the Authority retains only one Independent Person, namely Sheba Joseph, whose appointment will be extended until midnight 16 September 2017 on the same terms as currently apply (annual allowance £200 plus reasonable expenses).

In addition, members may recall that the Standards Committee was established when the new arrangements under the Localism Act 2011 were introduced, at which time there was some uncertainty as to how the new arrangements would operate. It is now proposed that this Committee be disestablished and the Authority revert to the previous arrangement under which matters relating to ethical standards were included within the remit of the Governance Committee. If the Authority approves this proposal, it is also recommended that it approves the amendment of the terms of reference of the Governance Committee to enable it to undertake those functions currently delegated to the Standards Committee and authorises the Clerk to the Authority, in consultation with the Chairman, to amend the Standing Orders / Terms of Reference accordingly.

Attached at Appendix 3 is the annotated list with appropriate Political balance requirements for 2014/2015 for consideration by Members.

The Authority is recommended to:-

- (i) note the membership of the Authority for 2014/2015;
- (ii) consider the appointment of Members to the Authority's Committees and Sub-Committees:
- (iii) consider the appointment of Chairman and Vice Chairman to each of the Authority's Sub-Committees
- (iv) agree the retention of only one Independent Person, namely Sheba Joseph, whose appointment will be extended until midnight 16 September 2017 on the same terms as currently apply (annual allowance £200 plus reasonable expenses).
- (v) disestablish the Standards Committee and revert to the previous arrangement under which matters relating to ethical standards were included within the remit of the Governance Committee. If the Authority approves this proposal, it is also recommended that it approves the amendment of the terms of reference of the Governance Committee to enable it to undertake those functions currently delegated to the Standards Committee and authorises the Clerk to the Authority, in consultation with the Chairman, to amend the Standing Orders / Terms of Reference accordingly.
- (vi) appoint the Spokesmen for Constituent Councils for the purpose of answering questions from Members of those Councils on the discharge of its functions;
- (vii) appoint Lead and Support Member roles;
- (viii) appoint two Members as the Authority's representatives on the Local Government Association;
- (ix) appoint a Member to the Local Government Association Urban Commission;
