#### **Apologies for Absence**

Apologies for absence were submitted to the meeting on behalf of Councillors Haswell, O'Brien and Watson.

#### **Declarations of Interest**

Item 2b Report of the Tyne and Wear Fire and Rescue Service.

Councillor Tye made an open declaration in the item as Chair of the Tyne and Wear Fire and Rescue Service.

#### Minutes of the Last Meeting

1. RESOLVED that the minutes of the last meeting of the Committee held on 14<sup>th</sup> March, 2023 be confirmed and signed as a correct record.

#### **Report of Northumbria Police**

Inspector Passey provided the Committee with a verbal report on behalf of Northumbria Police which updated members on key performance information in relation to the Sunderland West area.

Inspector Passey informed the Committee that there had been a 34% increase in antisocial behaviour compared to the previous reporting period. This was largely down to the onset of the lighter nights and when compared to the same reporting period for last year represented only an 8% increase. Hotspots included Thorney Close, Eden Vale, Ford Estate and Pennywell. Motorcycle disorder had increased by 54% with hotspots in Thorney Close, Ford Estate and Pennywell. There had been no significant rise or fall in figures for general crime with rates remaining fairly constant. A 13% decrease in theft and a 22% decrease in vehicle crime being balanced out by rises in other crime categories. Priorities for the summer included tackling motorcycle disorder, shoplifting in Pennywell and ASB in King George's Park.

In response to an enquiry from Councillor Mullen regarding his definition of 'Eden Vale', Insp. Passey replied that he was referring to the corner of the West Area that bordered Ashbrooke. The ASB had taken the form of congregations of adults and young people and instances of drug dealing. The issue had been tackled but there was always the prospect that it had been simply displaced elsewhere.

Councillor Tye highlighted issues in respect of garages at Cambridge Road and Hill Street which he had referred to LMAPS with a view to seeking a partnership approach in developing a solution.

Councillor Peacock welcomed that the Police had identified King George's Playing Fields as a priority moving forward. He placed on record that local Councillors had historically been active in looking for solutions to the problems in the park, seeking to make improvements to security gates and the installation of CCTV but progress had been slowed through the time taken to receive quotes back from Council Officers.

There being no further questions or comments, the Chair thanked Inspector Passey for his report and it was:-

2. RESOLVED the report be received and noted.

#### Report of the Tyne and Wear Fire and Rescue Service

Station Manager Scott Wilson presented a report of the Tyne and Wear Fire and Rescue Service (TWFRS) (copy circulated) which provided the Committee with an update on the Service's performance indicators for the period 1st April, 2023 to 4<sup>th</sup> June 2023 with particular reference to the L133 Incidents (all deliberate fires).

(For copy report – see original minutes)

The Chair thanked Mr Wilson for his report and invited questions from Members.

In response to an enquiry from Councillor P. Smith regarding which street in Silksworth had been the location for the recent attack on Fire Officers, Mr Wilson advised that he would investigate following the meeting and report back.

Councillor Tye stated that it would be remiss of him not to mention the work undertaken on behalf of the Committee by Mr Wilson's predecessor Station Manager Andy Nelson and asked that a letter of thanks was sent to Andy on behalf of the Committee. With regard to the issue of attacks on Fire Fighters, he suggested that the use of peer

pressure could help address the issue and cited the successful use of the tactic in tackling ASB in the skate park.

Councillor Ayre referred to the Ward Breakdowns detailed in paragraphs 3.2 and 3.3 and stated that the figures in relation to St Chad's appeared to be missing.

Councillor Peacock referred to discussions at previous meetings regarding the site of the former Farringdon Hall Police Station and advised that the Council's Planning and Highways Committee had recently approved proposals to develop the site.

In response to an enquiry from Councillor Haque, Mr Wilson confirmed that Members could contact him via the contact details outlined at the foot of the report.

There being no further questions or comments for Mr Wilson, it was:-

#### **Report of Gentoo**

Vicky Gamblin, Head of Operations, Gentoo Group presented a report, (copy circulated) which provided the Committee with an update on current Gentoo developments, projects and priorities for the period April 2023 to June 2023 together with a schedule of the planned property development programme for 2023/24

The Chairman thanked Ms Gamblin for her report and invited questions and comments from the Committee.

In response to enquiries from Councillor Crosby Ms Gamblin described the upgrade to the Gentoo fire alarm systems and explained the operation of the waiting list in respect of the allocation of bungalows with adaptations for the disabled.

Councillor P. Smith welcomed the work of the Gentoo Money Matters Team as described in paragraph 3.3 of the report and commended the Team for the support they provided for families in crisis.

There being no further questions or comments, the Chairman thanked Ms Gamblin for her attendance and it was:-

#### West Area Committee Delivery Plan 2020-2023

Ms Gilly Stanley, Partnership & and Community Resilience Manager, presented a report of the Assistant Director of Housing and Communities, (copy circulated) which presented for the Committee's consideration and approval, the West Area Committee Area Plan for 2023-26 together with an update on the Area Committee Area Plan Governance arrangements and the terms of reference for the Neighbourhood and Community Board.

Councillor Edgeworth referred to the final bullet point on page 10 of the Area Plan ("Receive updates on Walk and Talk Projects and consider opportunities for multi ward working") and moved a minor amendment to the wording so it would now read "Delivering a Walk and Talk programme and consider opportunities for multi ward working." This was agreed accordingly.

The Chairman having thanked Ms Stanley for her report, it was:-

- iv) collaboration be continued with key partners (currently including Gentoo, Police, TWFR, West VCS Network and the Voluntary Sector Alliance) to provide their plans for future activity in the West area (and to be appended to the Area Committee Area Plan) and that arrangements are made for quarterly updates; and
- v) the Terms of Reference for the Neighbourhood and Community Board as detailed in Annex 2 of the report be noted.

#### <u>Area Committee Report – September 2023</u>

#### 1. Anti-Social Behaviour

1.1. Since the last Area Committee Anti-Social across Sunderland West has decreased by 13%, which is also a 10 % decrease when compared to the same period in 2022. The current hotspot areas according to the latest data are Thorney Close, Eden Vale and South Hylton.

#### 2. Motorcycle Disorder

2.1. Motorcycle Disorder accounts for 25% of the total ASB calls within Sunderland West and receives the highest number of motorcycle-related calls in Sunderland. However, since the last Area Committee Motorcycle Disorder across Sunderland West has decreased by 33%.

#### 3. Crime

3.1. Since the last Area Committee overall crime has fallen by 7%, which is also a decreased when compared to the same period in 2022. There have been notable reductions in the following crime types; Criminal Damage (-15%), Theft (-18%) and Public Order (-22%).

#### 4. Seasonal Planning

- 4.1. The Sunderland West Summer Seasonal Plan focussed on Motorcycle Disorder, Shoplifting and the area of Pennywell. The Sunderland West Neighbourhood Team have worked in collaboration with a range of partners including Sunderland City Council, Gentoo, Together For Children and BTP to deliver a variety of multi-agency operations.
- 4.2. Operation IMPACT took place in July and focused on the area of Pennywell. The operation focussed on engaging the community and targeting those engaged in criminality and anti-social behaviour. The results of the operation were communicated in local press.
- 4.3. Over the School Holidays the Summer Serious Violence and ASB Initiative took place and came to Sunderland West in mid-August. The initiative saw the co-deployment of local authority and Police resources mainly in the area of Pennywell in addition to the deployment of the Together For Children's prevention bus.

5.1. Northumbria Connected is our new tool to ensure that we are delivering on the issues that affect all our communities across the North East. #### REPORT OF THE TYNE AND WEAR FIRE SERVICE

#### 1. Purpose of Report

1.1 The following report gives Performance Monitoring details in relation to the Local Indicators for Sunderland West Committee area from 04<sup>th</sup> June - to 22<sup>th</sup> August 2023.

#### 2 Background

2.1 At its November 2011 meeting, Area Committee agreed that regular updates on Crime and Community Safety would be presented to each Committee meeting.

#### 3. Tyne and Wear Fire Service Update

#### 3.1 LI 02 Number of Deaths from all fires

0 deaths were recorded during the reporting period.

3 deliberate property fires, compared to 4 in the same period last year (25% decrease). Hot strikes from operational crews and Safe and Well targeting has been conducted by the TWFRS Prevention and Education department. Partnership work with the Police, Gentoo and Sunderland city council continues where appropriate to reduce repeat incidents using a joint approach.

#### 3.3 LI15 Number of primary road vehicle fires started deliberately



9 vehicle fires reported during this period compared to 16 last year. A decrease of 44%. Out of the 9, 2 occurred in close proximity to each other.

TWFRS continue to work with Northumbria Police and report all suspected malicious vehicle fires and shall continue to monitor any patterns identified.

# 3.4 LI16 Number of secondary fires not involving property or road vehicles started deliberately



There have been 100 deliberate secondary fires over this period compared to 233 in the same period last year, a decrease of 57%. Large Improvements across all wards seeing a 40 - 80% reduction with the exception of Pallion ward, which has seen an 82% increase, this is due to a spike in wheelie bin fires over this period compared to last year.

#### 3.5 LI33 All deliberate Fires (combination of LI14, LI15 and LI16)

There were a total of 112 deliberate fires in this reporting period, down from 253 last year, a decrease of 56%. The weather this year has been a contributing factor in the reduced number of incidents, the extended periods of rainfall over the summer has assisted with reducing the numbers. All wards with the exception of Pallion ward have seen a decrease of over 50%. 35 fires involved loose refuse and 22 fires involved grassland.

#### Pallion ward 55% increase



A fire Stoppers leaflet drop and a Safe and Well Check initaitive has been complete by WM Errington's G/W around Palermo Street and adjoining streets. Youth engagement has been attempted whilst conducting ASB patrols and rubbish uplifts but youth were not willing to engage. There has been a rise in wheelie bin fires across the Pallion ward.

Silksworth ward 71% reduction




There has been an increase in incidents at the former Farringdon police station. 13 incidents have occurred within the reporting period. Otis security have revisited the site with the police on the 23/08/2023 to board up access into the building as this had been damaged following ASB. Nathan Stonehouse (TWFRS Arson Liaison Officer) is on standby to work with Sunderland Council to apply further pressure to the site owners, should the security measures fail. Fire crews continue to monitor this site when travelling to and from Farrington Station and continue to report uplifts within their allocated wards using the Report-It tool.

#### St Annes ward 52% reduction

No identified hotspot areas to report.

#### Sandhill ward 51% reduction



A mixture of 5 grassland and wheelie bin fires to the west of Tay Road. WM Davison's R/W have been conducting Fire Stoppers leaflet drops in this area and Safe and Well Visits.

#### St Chads ward 63% reduction

No identified hotspot areas to report. No concerns.

#### Barnes ward 85% reduction

No identified hotspot areas to report. No concerns.

#### 3.6 Community Involvement

Throughout the summer period, crews have attended several events put on by local community groups. Barnes Park Community fun day had fire service representation for the duration of the 3 days. Community education and fire safety information was delivered alongside our chip pan demonstration unit. TWFRS representatives educated hundreds of children over the course of this event and an operational appliance also attended on the Saturday to conduct youth engagement at all ages.

The TWFRS Diversionary Activities Manager, John Anderson still has intentions of collaborating with youth provision groups, Youth almighty and together for children, during the summer months he has been operating at full capacity delivering sessions aligned with the TWFRS targeting strategy. Operational crews will attend and support all activities providing the resources are available at the time of the engagement.

Our Safe and Well targeting system has recently been updated and improved, ensuring we target our most vulnerable members of the community. Operational crews from Farringdon continue to provide this service and will aim to deliver 1200 Safe and Wells visits across all wards before April 2024. Hot strikes continue to proactively reduce fires and support the delivery of fire safety in the home across the Sunderland West area.

Early planning has started for our darker nights campaign 2023 and TWFRS are in the process of identifying specific schools.

The next cohort of the Prince's Trust based at Farrington Community Fire station is due to start on the 18<sup>th</sup> September.

TWFRS Recruitment is also currently open and positive action events have been running throughout the summer at the TWFRS headquarters to recruit underrepresented groups from the community.

#### 3.7 On-going Issues

Collaboration with Northumbria police and local authority partner's continues to reduce hotspot incidents such as the derelict Farrington Police station as highlighted in the report. It is essential that any fire related issues are reported to myself, (Scott Wilson, Station Manager) or using Fire Stoppers 0800 169 5558, so I can action/address with my crews. My watches continue to work close within their respective Ward areas to create links through community engagements. The watches continue to deliver ASB initiatives – uplifts, premises security, and educational interaction.

The educational and engagement activities are key to reduce ASB and prevent attacks on emergency services.

Over this reporting period there were 0 attacks on crews in the West area.

#### **REPORT OF GENTOO**

#### 1 Purpose of Report

1.1 The following report provides an update from Gentoo for the West Area Committee for the period June to September 2023.

#### 2 Background

- 2.1 Area Committee agreed that regular updates from Gentoo would be provided to each Committee meeting to enable members to be up to date on current Gentoo developments, projects, and priorities and to ensure members are fully aware of their opportunities to work collaboratively with Gentoo.
- 3 Update on Neighbourhood Services
- 3.1 An Invitation from Louise Bassett, CEO of Gentoo Group. The relationship between Gentoo and Sunderland City Council is very important to Gentoo's CEO and she would welcome the opportunity to further strengthen this and has arranged dates (which you should have received), to meet with you in each of the City's localities. The dates for West ward councillors are:

**Tues 26 September** City Hall, Plater Way, Sunderland, SR1 3AD

**Tues 17 October** Emperor House, 2 Emperor Way, Doxford International

Business Park, Sunderland, SR3 3XR

3.2 **Estate walks** are now all arranged within the wards, and invitations sent to you all should you wish to attend. The dates for the wards are as follows:

Sandhill ward Thorney Close & Springwell, 25 October 2023

St Chads ward Farringdon, 27 September 2023
Barnes ward Humbledon, 28 September 2023
Pallion ward Low Ford, 21 September 2023

Millfield ward as above

Silksworth ward 28 September 2023 St Annes ward 27 September 2023

3.3 **Tenancy Sustainment Fund**. In July 2023, Gentoo Board approved several measures to support tenancy sustainability. These measures include interventions such as, providing carpets for new customers who have been housed with us on a priority basis and below the age of 25. Supporting this group of customers to have their water rates paid if they are really struggling financially (for a limited period). We also identified measures such as the provision of Ring Doorbells for victims of domestic abuse or antisocial behaviour, and a small budget to support these customers with house removals for those who need to move in an emergency and can't afford to pay for it.

In addition to these measures, we have increased resource in the Money Matters Team and now have four Support Coordinators working with our customers who have complex financial needs across the city. We will also be recruiting for two 'Pre-Tenancy Coordinators', who will work with new applicants to the Gentoo housing register, their aim will be to provide support and advice across a range of issues, these include assessing any priority needs, identifying vulnerability issues, offering money management and the costs of

running a home support advice, income maximisation, energy advice and signposting to low-cost furniture and fittings, to ensure we prepare and support applicants to have the best possible start to tenancies.

3.4 **Recruitment Activity**. In the coming months, we will be looking for passionate, engaged tenants to join a brand-new paid Tenant Committee. The Committee will be made up of 6 Gentoo customers and it will form an important part of our governance structure. It will be chaired by Group Chair – Emily Cox - and it will fulfil a critical role, advising Group Board on all tenant-related matters.

The Committee will help us to better understand the challenges facing tenants and it will drive purposeful, positive change across the Group.

3.5 **Springwell Secret Garden**. Gentoo have been working with the sandhill Ward Councillors and residents backing onto a large area of land to the rear of Simonside Road. Over years many of the residents have extended their rear gardens into this space and the area has become unmaintainable due to pockets being created. Consultation has now been completed and a meeting at Emperor House has been arranged for the residents to come along and discuss the next steps to legally transfer the land.

#### **4. Investment & Renewal** – see attached report

Roof Repairs (Australia Tower)

Hodgson & Sayers (contractor) have now erected the system scaffold to the full external of the building and are now on carrying out the repairs to the upper roof.

#### Pennywell Regen

Regen is the contractor on site carrying out external works including roof replacements, windows, canopies, outbuilding upgrades, external decoration, and replacement boundaries to over 1000 Gentoo properties, the scheme currently programmed to complete September 2024.

#### **City Wide Schemes**

Windows (City Wide)

Sekura is on site in various locations carrying out window replacements.

Low Rise Fire Alarm Removals (City Wide)

Isoler are currently carrying out the removal of fire alarms from 80+ low rise blocks scattered city wide. At last committee Councillors questioned why we were removing them and what safety measure where in its place. The fire alarms in the communal areas of several low-rise blocks are being removed and replaced with individual smoke detection within the flats themselves.

Loft Insulation Top Ups (City Wide)

Regen Solutions are due to start next month on a scheme of over 1000 properties where we are providing loft insulation or loft insulation top ups.

#### REPORT OF WEST AREA VOLUNTARY AND COMMUNITY SECTOR NETWORK

#### 1. Purpose of the Report

1.1 The report provides an update with regard to the West Area Voluntary and Community Sector Network

#### 2. Background

- 2.1 To develop the capacity and influence of the Voluntary and Community Sector (VCS) across the City, Area Networks have been established and delegates represent each Area Network at Area Committee taking forward issues on behalf of the whole VCS in the area, reporting on area priority delivery by the VCS, and reporting back, providing a two-way flow of communication.
- 2.2 West Area Network delegates will present a report to each Area Committee meeting informing Members of activity, progress, issues and concerns of the sector.
- 2.3 The West VCS Network is made up of over 70 local groups and strategic local/national/regional partners. The network meets on a regular basis to share good practice, support one another and receives regularly updates as part of an information share e bulletin distributed via the Sunderland VS Alliance.

#### 3. West Voluntary and Community Sector Network (VCSN) Progress Report

- 3.1 The West VCS Network met in person in September
- 3.2 The meeting included the following agenda items:
  - Health Screening Programmes
  - Financial Wellbeing
  - Royal Society for the Blind
  - Network and Information Share Opportunities
- 3.3 Members of the Network joined Sunderland Council and the Sunderland Integrated Care Board (Health) for breakfast on Thursday 15th June 2023, to discuss future opportunities to work together in the city, developing community hubs and our community support offer for residents. The following themes were consistently discussed at each table with a high amount of consensus over the challenges or opportunities associated with the themes. Members of the network were asked to sign the pledge for Links for Life

#### In summary they were:

- Funding,
- Opportunities to network and collaborate,
- Potential and challenges of Links for Life,
- Capacity in the sector
- Attitudes to the NEPO portal.

- 3.4 Moving forward from the Warm and Welcoming spaces, we are working closely with the sector to extend and co-produce the 'welcoming warm spaces'. Members of the network have been informed there will be launch for a new call for projects in September, to enable the community support offer to move into 'Links for Life' Sunderland's social prescribing community support programme. The programme will build on the learning from the warm and welcoming spaces, ensuring we are able to offer services and support within our communities support and activities which bring residents together, enable active engagement and improve health, wellbeing and financial resilience.
- 3.5 The West Area Event in Barnes Park funded by West Area Committee delivered by Youth Almighty Project took place 29<sup>th</sup> June 23 1<sup>st</sup> July 23. 735 School Children attended from 14 West area schools. On the Saturday over 9000 people attended the family fun day. Various organisations had stalls to fundraise or promote their services.
- 3.6 At the September meeting the network will consider the nominees for the 2 vacant roles of West VCS Network Rep. Area Committee will be updated at the meeting.
- 3.7 Members of the network continue to welcome funding opportunities and social value opportunities from SVSA. The Area Arrangements team are working in collaboration with the Sunderland VCS Alliance (SVSA) and wider Council services and partners to bring forward social value from investments and from businesses delivering in the city, to support the voluntary and community sector. The Area Arrangements team and the SVSA are also working together to understand where local community services are currently being delivered within the area, to support resident community resilience and wellbeing.
- 3.8 The Network representatives regularly consult with the Network to ensure that the agenda items reflect their requirements.

#### 4. Sunderland Voluntary Sector Alliance (SVSA) update August 2023

- 4.1 Since securing charitable status in April, the Sunderland VS Alliance asked the sector across Sunderland for a view on current needs and gaps in service offer. Following the completion of the surveys and further work with the Alliance Strategic and Operational Boards, funding priorities have been agreed which will inform future funding applications as follows:
  - Older peoples' services
  - People with disabilities
  - Young people (the need for more youth services)
  - Veterans
  - People affected by the cost-of-living crisis
  - People furthest from the job market,
  - Refugees
  - Mental health services
- 4.2 The Alliance has secured £45,000 ICB funding via VONNE to employ a Capacity Mapping Officer as part of a regional piece of work to review social prescribing and look at best practise for Sunderland and the Northeast region. The Alliance are working hand in hand with the Links for Life programme team to provide recommendations which will improve communities and prevent escalation of specialist services, to benefit the outcomes for local people.
- 4.3 The Alliance is part of the Community Foundations Participatory Grant process developing funding opportunities for grass roots voluntary and community groups. Launch date to be confirmed.

4.4 The Alliance will launch their membership scheme in October and will be promoting to all of the voluntary, community and social enterprise sector organisations in Sunderland, asking them to register.

The Alliance will also be:

- · Recruiting, inducting, and training new staff
- Re-launching their website (with a membership hub)
- 4.5 The Alliance working hard to secure the following members for the Alliance:
  - A Treasurer
  - Trustees
  - Operational Board members

The purpose of the report is to update on progress in relation to the delivery of the Area Plan in addition to making any recommendations of the Board to the Area Committee for final approval. #### **West Sunderland Area Budget Report**

#### 1. Purpose of Report

1.1 Area Committee has delegated budgets to allocate to specific strategic priorities identified in the Area Plan, with the overall aim to respond to the needs of residents and ensure the delivery of activities and projects to support matters which affect residents and enable them to be resilient.
