Audit Committee Arrangements

Report of the Chief Executive, City Treasurer and City Solicitor

1. Purpose of the Report

1.1 The purpose of this report is to propose revised arrangements for the Council's audit committee function.

2. Description of Decision

- 2.1 That Council be recommended to:
 - (a) Establish an Audit and Governance Committee on the basis set out in paragraph 5 below and Appendix 1;
 - (b) Approve a new Internal Audit Charter, set out in Appendix 2;
 - (c) Authorise the City Solicitor to make any necessary amendments to the Council's Constitution required to reflect the establishment of the new Audit and Governance Committee;
 - (d) Make appointments to the new Committee at the Annual Council meeting in May 2006.

3. Introduction/Background

- 3.1 Audit committees are an essential element of good governance. Although audit committees have been a feature of the public sector for some time, there has been a lack of clarity about how they should operate in local government. Following a review of the Council's Constitution the Council has had an Audit Committee since May, 2002.
- 3.2 Part 2 of the Council's Constitution, Article 6 sets out the Terms of Reference of the Overview and Scrutiny Committees. Under these terms of reference, the Policy and Co-ordination Review Committee has hitherto been designated to act as the Council's Audit Committee. The current Terms of Reference are attached at Appendix 3.
- 3.3 In addition, the Council's Constitution provides for an Accounts Committee, the purpose of which is to approve the Council's Statement of Accounts. The Accounts Committee was set up in order to give detailed scrutiny of the Council's accounts and provide flexibility in terms of the timing of the approval of the Statement of Accounts (given the progressively earlier deadlines for completion and publication now required of the Council).
- 3.4 The Local Government Act 2000 introduced new ways of governing local authorities. All Councils were required to adopt one of a number of models. The model adopted within Sunderland Council is a Cabinet with a Leader. The role of scrutiny is to review policy and challenge whether the executive has made the right decisions to deliver agreed policy goals. This is different to the

role of an audit committee – audit committees are an important source of assurance about an organisation's arrangements for managing risk, maintaining an effective control environment, and reporting on financial performance as well as providing a forum for the discussion of issues raised by internal and external auditors.

- 3.5 Good corporate governance requires independent, effective assurance about the adequacy of financial management and reporting. The Chartered Institute of Public Finance and Accountancy's (CIPFA) position is that the audit committee should be organisationally separate from the executive and scrutiny and should be chaired by a person who is not part of the executive. The principles of the CIPFA guidance are reflected in the Comprehensive Performance Assessment Key Lines of Enquiry.
- 3.6 Although legislation does not require audit committees, a council is required "to ensure that its financial management is adequate and effective and that it has a sound system of internal control which facilitates the effective exercise of its functions". Further, Section 151 of the Local Government Act 1972 requires councils to "make arrangements for the proper administration of its financial affairs". CIPFA advises that the role of the Chief Finance Officer (in Sunderland's case the City Treasurer) is key to discharging these requirements but also recommends that an effective audit committee is necessary.
- 3.7 Given the content of the latest guidance received and the wider remit now expected of an audit committee, it is considered necessary to review the existing arrangements to ensure compliance with the latest CIPFA guidance which is accepted as best practice.

4. Assessment of Current Arrangements

- 4.1 The current arrangements have been assessed against the recent guidance issued by CIPFA. This analysis highlights that although a number of the elements being advocated by CIPFA are incorporated in the current arrangements there are some key areas which need to be considered further including:
 - the wider remit of an audit committee e.g. approval of the Statement of Accounts, risk management, the wider internal control environment, consideration of internal and external audit plans etc.;
 - the Chairmanship of the audit committee i.e. that it should not be chaired by a member of the executive;
 - the membership of the audit committee i.e. no more than one member of the executive and consideration of external input;
 - the training and development of members recognizing the specialist and technical knowledge required.
- 4.2 Accordingly this report proposes revised arrangements for the Council's audit committee function.

5. Revised Terms of Reference and Annual Work Programme

- 5.1 It is clear that although the existing arrangements have worked well they do not meet the new best practice guidance and there is some scope for improvement.
- 5.2 It is therefore proposed to create a new committee titled the Audit and Governance Committee which would replace the existing role performed by the Policy and Co-ordination Review Committee and the Accounts Committee. It is proposed that the Committee should report to full Council. In order to remain effective and efficient CIPFA also recommend that the committee remains small.
- 5.3 A proposed Terms of Reference for an Audit and Governance Committee is shown at Appendix 1. It is considered that these Terms of Reference would build on the current arrangements and would further enhance the Council's corporate governance arrangements. The Terms of Reference will be reviewed on an annual basis to ensure that they remain up to date and continue to reflect recommended good practice.
- In order to reflect these proposals and the requirements of the CIPFA Code of Practice on Internal Audit in Local Government, the Council's Internal Audit Charter will also need to be updated. A revised Internal Audit Charter is attached at Appendix 2.

6. Reasons for the Decision

6.1. To ensure that the Council's arrangements for an audit committee reflect recommended good practice.

7. Alternative Options

7.1. The existing arrangements could remain in place but this is not recommended as it would not be in line with recommended best practice which could impact upon the Council's CPA assessment.

8. Relevant Consultations

8.1. Consultation has taken place with the Council's External Auditors who have not raised any objections to this proposal.

Proposed Terms of Reference – Audit and Governance Committee

Composition

Membership

The Audit and Governance Committee will be composed of 7 Members as follows:

5 elected Members on a political balance basis;

2 Co-opted Members.

There will be no more than one Member of the Cabinet on the Committee.

The Quorum will be four Members with at least three elected members.

Chairing the Committee

The Chairman will be one of the Co-opted Members.

Statement of Purpose

The Audit and Governance Committee is a key component in the Council's Corporate Governance Arrangements. Its main objectives are to:

- provide independent assurance of the adequacy of the risk management framework and the associated control environment;
- independent scrutiny of the authority's financial and other performance to the extent that it reflects the authority's exposure to risk and weakens the control environment:
- oversee the financial reporting process.

Functions

To carry out the following delegated functions from Council:

a) to approve the Authority's Statement of Accounts, income and expenditure, and balance sheet or record of receipts and payments (as the case may be).

In relation to the following functions to undertake the assurance and advisory role to:

 consider the effectiveness of the authority's corporate governance arrangements, risk management arrangements, the control environment and associated anti-fraud and anti-corruption arrangements and seek assurance that action is being taken on risk-related issues identified by auditors and inspectors;

- be satisfied that the authority's assurance statements, including the Statement on Internal Control, properly reflect the risk environment and any actions required to improve it;
- d) to receive and consider (but not direct) internal audit's strategy, plan and monitor performance;
- e) receive and consider the external audit plan;
- f) review a summary of internal audits, the main issues arising, and seek assurance that action has been taken where necessary;
- g) receive and consider the annual report of internal audit;
- h) consider the reports of external audit and inspection agencies, including the Annual Audit and Inspection Letter;
- ensure that there are effective relationships between external and internal audit, inspection agencies and other relevant bodies, and that the value of the audit process is actively promoted;
- j) review the external auditor's opinion and reports to members, and monitor management action in response to the issues raised by external audit;

and make recommendations or comments to Cabinet or Council as appropriate.

Features of the Committee

- a) The Committee will exercise delegated powers from Council in relation to item
 a) above and in relation to the remaining functions act as an advisory committee.
- b) The Committee will treat the auditors, the executive and management equally.
- c) The Committee can call any officer or agency of the Council as required.
- d) The Committee will meet regularly, at least four times per year.
- e) The City Treasurer, Assistant City Treasurer (Audit and Procurement) and the External Auditor will be regular attendees. Other attendees may include the City Solicitor and the Chief Executive. These officers all have access to the Committee, or the Chair, as required.

INTERNAL AUDIT CHARTER

Statutory Role / Objectives and Responsibilities

Internal Audit Services (IAS) is an independent appraisal function established by the Council under the requirements of the Accounts and Audit Regulations 2003. The prime objective of Internal Audit Services is to provide assurance to the Council in relation to its internal control environment and assist management in delivering the objectives of the Council and its associated bodies through assessing exposure to risk and recommending, where appropriate, practical improvements to the control environment. To this end it is the responsibility of IAS to review, appraise and report upon:

- whether operations are being carried out as planned and objectives and goals are being met;
- the adequacy of systems established to ensure compliance with policies, plans, procedures, laws and regulations, i.e. rules established by the management of the organisation, or externally;
- the completeness, reliability and integrity of information, both financial and operational;
- the extent to which the Council's assets, data and interests are properly accounted for and safeguarded from losses of all kinds, including fraud, corruption, waste, extravagance, abuse, ineffective management and poor value for money; and
- the economy, efficiency and effectiveness with which resources are employed.

Other Responsibilities

Internal Audit Services will produce an Internal Audit Plan, agreed by the City Treasurer and considered and reviewed by the Audit and Governance Committee. In producing the plan the head of internal audit will have the freedom to determine the priorities for internal audit in consultation with the City Treasurer and chief officers, and will have an unrestricted range of coverage of the Council's operations. In general, but not exclusively, a process of risk assessment will determine the priorities for internal audit.

IAS will perform the audit work to the professional standards set out in the Code of Practice for Internal Audit in Local Government. In addition IAS will seek to respond to requests for investigation into matters of fraud, probity and compliance that are client's responsibility. Furthermore, IAS shall have no responsibilities over the operations that it audits beyond the furnishing of recommendations and advice to management on risks and controls.

Internal Audit Services may also provide independent and objective advice and guidance in response to requests from management.

Reports

All material findings will be communicated to the relevant departmental management and once agreed a final report will be sent to the Chief Officer and, where appropriate, the City Treasurer. Management is expected to implement all agreed audit recommendations within a reasonable timeframe and each audit will be followed up to assess the extent to which this has happened. In addition, the overall results of audit work will be reported regularly to the City Treasurer and bi-annually to the Audit and Governance Committee. The bi-annual reports will contain a view on the soundness of the Council's system of internal controls based on the work carried out by Internal Audit Services.

Access

IAS shall have access to all officers, buildings, information, explanations and documentation required to discharge the audit role.

This includes not only the City Council, but also:

- organisations to whom the Council has given grants;
- organisations with which the Council contracts; and
- partner organisations in any schemes for which the Council has responsibility as lead body.

Such rights of access shall be written into the appropriate agreements with these organisations.

Independence

Internal audit is required to provide an objective audit service in line with professional auditing standards. To this end IAS will have no executive responsibilities and the head of internal audit will report directly to the City Treasurer and have direct access to, and freedom to report to, all senior management including the Chief Executive, Audit and Governance Committee and Members.

Current Audit Committee Terms of Reference

The Committee is charged with overseeing the maintenance of an effective system of internal control within the Council and associated bodies. In undertaking this role the Committee will receive reports upon and:

- review the adequacy of Council's internal control framework;
- review the adequacy of plans, procedures and practices to ensure compliance with statutory and other guidance;
- monitor the performance of the Council's internal audit function; and
- consider the external audit plan.

The Committee will act in an advisory capacity only and has no executive powers.

In undertaking this role the Committee will:

- consider and endorse the proposed Annual Internal Audit Plan;
- consider and review Internal Audit's key performance measures and receive reports on their achievement;
- receive and consider Internal Audit's Annual Report;
- receive and consider reports on major issues concerning the role, scope and delivery of the internal audit function.
- receive and consider the External Auditor's Annual Audit Plan and Annual Audit Letter.

In addition the Committee will provide a forum to discuss any major issues raised by both internal and external audit and their implications for internal control.

The Committee may be attended by the City Treasurer, Assistant City Treasurer (Audit and Procurement) and External Auditor. The Assistant City Treasurer (Audit and Procurement) may report direct to the chair of the Committee if deemed necessary.
