1. INTRODUCTION

1.1 The purpose of this report is to provide members with a progress report on the analysis of performance against targets for the fourth quarter (January - March 2009) as detailed in the EPU Business Plan 2008/09.

2. BACKGROUND


- 2.1 Progress reports relating to the performance of the EPU are produced five times per year: i.e. one report is produced at the end of each quarter relating to the preceding quarters targets; and a final summary report is produced at the year end on the overall delivery outputs relating to stated business plan commitments. These reports are tabled and discussed at the regular quarterly meetings between the Chief Emergency Planning Officer (CEPO) and the District Liaison Officers (DLO) from each of the five Tyne and Wear councils. These officers comprise the Strategic Management Board. The report is also presented to the FRA Civil Contingencies Committee
- 2.2 Unfortunately, due to other planning commitments, namely the significant levels of activity around Influenza A (H1N1) swine flu pandemic (see separate report) a final end of year report has not been prepared for this meeting. Members can be assured that the report will be tabled at the earliest opportunity.

4 Unscheduled work completed this quarter

- 4.1 In addition to the planned work programmes, the following additional work has been completed this quarter.
 - Further developmental work on the implementation documents for the Community Resilience Strategy for South Tyneside Council. This is a significant piece of work that is being developed for wider application with the intention that all councils in Tyne and Wear can benefit.
 - Further assistance given to Gateshead Council to develop local arrangements relating to evacuation planning.
 - Work with the LRF Communications sub group.
 - Drafting a fundamentally new and restructured work plan for consideration by the Strategic Management Board.
 - Significant planning, training and exercising work on behalf of the five councils in Tyne and Wear and the LRF to address issues relating to the onset of pandemic influenza.

5 SUMMARY

- 5.1 Appendix A contains an extract from the EPU Business Plan 2008-10, showing the agreed, prioritised EPU work plan targets for Quarter 4. Targets not met are highlighted in paragraph 3.5 above, together with the reasons for their non-completion. As can be seen, all of these were due to circumstances beyond EPU control, with the exception of the actions which could not be progressed due to staffing shortages.. However Members will also note the additional work completed in lieu of these items, some of which have been significant, which are set out in paragraph 3.8 above.
- 5.2 Items that have been deferred or rescheduled will be incorporated into future work plans and an update of progress provided to this committee in due course.
