REPORT OF THE DEPUTY CHIEF EXECUTIVE

LICENSING COMMITTEE – 20 JUNE 2013

LICENSING ACT 2003 – DECISIONS OF LICENSING SUB-COMMITTEE HEARINGS HELD IN APRIL, MAY AND JUNE 2013

1.0 PURPOSE OF REPORT

1.1 To advise the Committee of the outcomes of Licensing Sub-Committee hearings held in April, May and June 2013.

2.0 DESCRIPTION OF DECISION

2.1 The Committee is requested to note the contents of the report.

3.0 INTRODUCTION/BACKGROUND

- 3.1 Under the Licensing Act 2003, Sunderland City Council has responsibility for licensing the sale of alcohol, regulated entertainment and late night refreshment within its area. This encompasses the determination, grant, administration and enforcement of premises licences, club premises certificates, personal licences and temporary event notices.
- 3.2 In April 2013 a Licensing Sub-Committee considered an application for a new premises licence.
- 3.3 In May 2013 a Licensing Sub-Committee considered an application to review a premises licence.
- 3.4 In June 2013 a Licensing Sub-Committee considered an application to transfer a premises licence.

4.0 CURRENT POSITION

- 4.1 On 22 April 2013, a Licensing Sub-Committee consisting of Councillors P Gibson, D. Richardson and A. Emerson considered an application for the grant of a premises licence in respect of Londis, 2 The Green, Southwick, Sunderland. Representations had been received from two local residents objecting to the granting of this licence on the grounds that there were already enough premises selling alcohol in the area. Neither objector attended the hearing.
- 4.2 After hearing representations from the licensee, the decision of the Sub-Committee was to grant the application.
- 4.3 On 2 May 2013, a Licensing Sub-Committee consisting of Councillors D. MacKnight, D. Richardson and R. review of the premises licence in respect of Bhangu Store, 19 Johnson Terrace, Sulgrave, Washington. Northumbria Police applied for the review on the grounds of prevention of crime and disorder and the protection of children from harm due to under age sales taking place at the premises.

- 4.5 After hearing representations from both the licensee and Northumbria Police, the Sub-Committee decided to add conditions partaking to CCTV and the prevention of under age sales to the licence.
- 4.6 On 5 June 2013, a Licensing Sub-Committee consisting of Councillors P. Gibson, S. Bonallie and R. Bell considered an application for the transfer of a premises licence in respect of Rye and Dry, 19 Ryhope Street South, Sunderland.
- 4.7 Objections to the application were received from Northumbria Police, on the grounds of the prevention of crime and disorder as the premises licence had previously been revoked following a review of the licence (for the Committee's information, this matter is currently subject to an appeal which is due to be heard at Sunderland Magistrates Court) and they had reason to believe that the applicant was connected to the current licence holder and that this application was an attempt to circumvent the decision of a previous Licensing Sub-Committee to revoke the premises licence .
- 4.8 After hearing representations from both the licensee and Northumbria Police, the decision of the Sub-Committee was that the application to transfer the premises licence be allowed and that the Council will not contest the appeal which is due to be heard in the Magistrates Court subject to the applicant asking the Court to attach conditions to the licence relating to CCTV systems, staff training, and age verification.
