"The Committee acknowledges that the Council continues to operate in very challenging circumstances and the current pandemic has put additional pressures on all council services. Therefore the Committee are satisfied with the contents of the report and acknowledge that a number of funding uncertainties remain and that the continued response to the pandemic only adds to these uncertainties.

The Committee also acknowledges the revised version of the City Plan in light of the Covid-19 pandemic and requests that updates on progress are provided to the Scrutiny Coordinating Committee as and when appropriate. The Committee would finally like to put on record its appreciation to all Members and Officers who continue to work extremely hard on budget planning and development of the Council's financial plans."
