1. INTRODUCTION

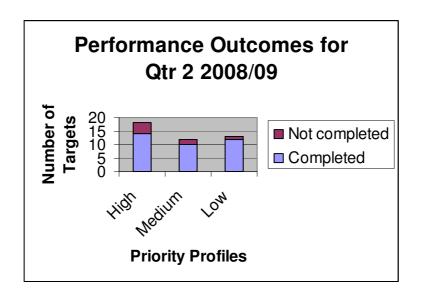
1.1 The purpose of this report is to provide members with a progress report on the analysis of performance against targets for the second quarter (July - September 2008) as detailed in the EPU Business Plan 2008/10.

2. BACKGROUND

2.1 Progress reports relating to the performance of the EPU are produced five times per year: i.e. one report is produced at the end of each quarter relating to the preceding quarters targets; and a final summary report is produced at the year end on the overall delivery outputs relating to stated business plan commitments. These reports are tabled and discussed at the regular quarterly meetings between the Chief Emergency Planning Officer (CEPO) and the District Liaison Officers (DLO) from each of the five Tyne and Wear councils. These officers comprise the Strategic Management Board. The report is also presented to the FRA Civil Contingencies Committee

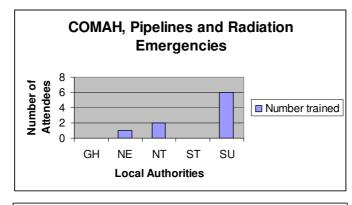

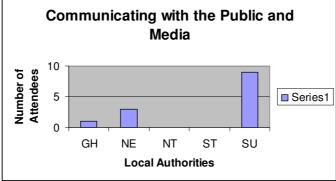
3.4 Update on Targets Reprioritised from 1st Qtr 2008/09 to 2nd Qtr 2008/09
