Chairman's Welcome

The Chairman welcomed everyone to the meeting and introductions were made.

North Sunderland Area Neighbourhood Delivery Plan 2020 – 2023

The Chairman of the North Sunderland Area Committee Neighbourhood and Community Board submitted a report (copy circulated) which presented the North Sunderland Neighbourhood Delivery Plan 2020-2023 and provided an update of progress against the Area Priorities associated with the Delivery Plan.

The Chairman advised that the November Board had undertook a full discussion on the planned improvements for Roker Park following a presentation from Officers who could provide feedback to the Councillor on any planned repairs.

Mr. Curtis, Area Network Representative took Members through the report advising that the network had met in October and December via Microsoft Teams since the last meeting of the Area Committee and shared the agenda items that had been covered.

Members of the Committee were advised that the pandemic had brought providers together over the five wards to help provide support to the North Sunderland Area and that they continued to work together and plan ahead for future programmes and support work in the community.

Mr. Curtis advised that the food drive had proved successful and many of the issues they were hearing from residents as they visited were the concerns over their deteriorating health and mental health issues given that some of them had been at home for almost two years due to the pandemic. He had reals concerns over the stresses some of the housebound in the area had suffered during the pandemic and felt that it was going to prove difficult to kickstart them reintegrating in society.

Members praised the work of the VCS Network throughout the pandemic and appreciated all that had been carried out in supporting some of the most vulnerable in the community.

REPORT OF THE CHAIR OF NORTH SUNDERLAND NEIGHBOURHOOD AND COMMUNITY BOARD

North Sunderland Area Neighbourhood Delivery Plan 2020-2023

1. Purpose of Report

- 1.1 This report:
 - a. Presents the North Sunderland Neighbourhood Delivery Plan 2020-2023; and
 - b. Provides an update of progress against the Area Priorities associated with the Delivery Plan.

2. Background

2.1 Following the approval of the Neighbourhood Investment Plans in March 2020, the North Sunderland Area Committee has worked together to finalise their Delivery Plans. All priorities have been determined following significant resident consultation via Let's Talk Sunderland. The Council also undertook further consultation with residents, during June 2020, to ensure the priorities were still relevant post COVID-19.

3. Area Committee and Neighbourhood Investment Plan Governance Arrangements

- 3.1 The Area Committees are part of the Council's Executive Function and have two key roles:
 - a. Influencing decisions on services delivered at a neighbourhood level; and
 - b. Identification of key priorities for their areas, in the context of supporting the delivery of the Council's City Plan at a neighbourhood level and ensuring maximum impact where necessary, through utilising its own resources.
- 3.2 The Article 10 Neighbourhood Investment Plans were approved at Cabinet in March 2020.
- 3.3 It is now the responsibility of each Area Committee to deliver their agreed priorities to support the delivery of the Neighbourhood Investment Plan. Area Committee Delivery Plans have been developed to enable this to happen.
- 3.4 The Neighbourhood and Community Board will be the working group for the Area Committee and the Board will be Chaired by the Vice-Chair of the Area Committee. All Committee members are invited to attend all Board meetings.
- 3.5 Members will work alongside key officers in what will be practical action orientated groups. It should be noted that the Board is not a decision-making body and the work and recommendations of the Board will be presented to the Area Committee for final endorsement. The Area Committee Chair and Vice-Chair were agreed at Annual Council in June 2021.

Project Description – taken verbatim from Application:

Installing and external defibrillator will help address the Area Committee's priority of Social Prescribing – Developing Local offer to Improve Health & Wellbeing - as well as Public Health priorities as agreed in full council in November 2021 regarding access to defibrillators for health emergencies. Within 500m of Southwick Community Centre is Southwick Green – a vibrant shopping area which attracts shoppers in from across the north area. The location of this defibrillator would also be easily accessible to all residents, should there be any emergencies on Southwick Green or in the local residential community.

The nearest Defibrillator is in Sea Road, Fulwell over 1.5 miles away, Farmborough Court, Town End Farm (which is for internal use in the nursing home – not for public use, and AR controls in Castletown which has limited access during office hours both of which are over 4 miles away. There is a clear need for a defibrillator in the Southwick green village.

If a defib can help save a life then it is worth investing in one in Southwick as statistics show that the life expectancy of a male living in Southwick is 75.1 years compared to a male in Fulwell (82.5 years). A Female life expectancy of a female in Southwick is 79.1 compared to a female in Fulwell being 85.4 years.

Smoking is high risk for affecting life expectancy and in Southwick 24.8% of the population smoke, compared to only 7.4% in Fuwell.

Folk in Southwick are deemed less fit and active with 31.9% of the population being active (5 days plus) compared to Fulwell 41.6% active.

This is evidence that the residents of Southwick need a defibrillator in the area as it may actually save lives. The community centre is the ideal location situated on the perimeter of Southwick green, in the vicinity of sheltered schemes, residential areas, and a vibrant shopping centre. It will be accessible to all residents.

The building is leased from Sunderland Council, initial enquiries show that written permission will be granted for us to have a defibrillator fitted to the wall of the community centre. Planning permission is not required.

We will work with SNYP and Southwick Village Green Preservation Society to raise awareness of the defibrillator and also to promote access to the awareness raising and community training – Red Sky Foundation have agreed to support this.

We would provide the community space within the community centre for this and encourage community centre members and users to also attend as well as the wider community.

We would also like to work with local schools, local councillors and the wider VCS network to encourage attendance at these events and raise awareness.

We will notify the ambulance service of the new defib and its location, registering it with the Circuit and Heartsafe.

We will also share data with all stakeholders, including Heartsafe to record the location and accessibility details for the public's knowledge, and the resuscitation Council, Circuit to allow call handlers to know where a defib is in the area.

We are a registered charity who work with local community groups. We are committed to improving the health and wellbeing of Southwick Residents and are an active member of the VCS network.

We have a Facebook page with 871 followers plus access to numerous local Southwick and North Area community groups on social media where we would publicly acknowledge funding. We would also include the Sunderland City Council Logo on all signage and any promotional material. We would aim to get publicity in the local press also.

We will publicise on our facebook page and on Sunderland North Community facebook page of the location and acknowledge the support from Area Committee to help provide the defib.

We will also record in the CA's committees agenda to acknowledge North Area Committee for their support and assistance with providing this life saving equipment.

We will also contact the local newspaper and ask for an article to promote the new defibrillator and the support and funding from North Area Committee, if we are successful.

Project Description – taken verbatim from Application:

Thompson Park Community Association (TPCA) has a long and proud history of building a thriving community centre in Monkwearmouth. The community came together with Grange Park Primary School in the 1940s and driven, committed people raised the money to build the Centre itself with their own pennies and ha'pennies. Managed by a committed team, the Centre had been thriving with many users of the space for a wide range of groups and projects until March 2020. In August 2021, the former committee gave notice of closure due to the time and energy needed to run the Centre entirely by volunteers, in particular which, following the strain of uncertainty through the pandemic had become a lot worse.

However, following a public meeting and the formation of a new Committee, we are pleased to be starting the New Year with a new programme of events and a funding strategy which aims to breathe new life into the Centre. We will run regular intergenerational activity to engage our community, including regular community groups using the hall (toddlers, after school clubs, bookings from local residents, parties) as well as reopening the bar for well-attended Saturday match day events as in the past.

We held taster events pre-Christmas including a well-attended community volunteer action day in December and a Children's Christmas Party, and the Committee is looking forward to being open again more fully for our community with large numbers of weekly and one-off visitors learning in and enjoying the space.

We are very hopeful of being able to secure a community defibrillator at Thompson Park Community Centre. Statistics show that only one in ten people survive an out of hospital cardiac arrest and we have provisionally agreed with our neighbour at Number 9 Newbold Avenue, with whom we share the party external wall, that we can install a PAD on this wall to allow access when the Centre is not open, to be accessible for community access in an emergency.

According to heartsafe.org.uk, there are no community access PADs in Southwick Ward, and until very recently when the Stadium of Light was given one from the Red Sky Foundation, the nearest PAD is more than 3 miles away in Bunny Hill.

Local statistics deem that there is a high chance that a PAD in this area could save lives.

iLiveHere use the 11 English index of deprivation statistics Lower-Super Output Areas (LSOAs) in Southwick, to provide an at-a-glace overview of deprivation in this area of Sunderland. This takes the average decile score of all the LSOAs in a ward and converts that into a rating out of 10, where 1 is the best and 10 is the worst.

The Southwick Ward as seen at <u>www.ilivehere.co.uk</u> shows a high risk of health deprivation and disability in Southwick, with a score of 9 'very bad' for their rating <u>https://www.ilivehere.co.uk/english-indices-of-deprivation-statistics-comparison-for-</u> <u>southwick-in-sunderland-e05001172.html</u>

This iLiveHere rating is an indicator of the risk of dying prematurely or having your quality of life impaired through poor physical or mental health in Southwick. The IMD domain measures morbidity, disability and premature mortality.

According to Government Statistics (2015), Sunderland is ranked 10th in health deprivation, 11th in health deprivation & disability & overall index of multiple deprivation, Sunderland ranked 38 out of 326 local authority districts across the country.

In Sunderland in 2015 -2017 251 males died from circulatory difficulties and 156 with respiratory difficulties. 208 females died from circulatory difficulties and 191 from respiratory difficulties.

After speaking to a colleague at Community HeartBeat, we were advised that they advocate only devices that meet the standards for Equalities as we do not know who will be using the defibrillator, and therefore any defibrillator that only 'talks' to you will discriminate against hard of hearing, non-English speakers and children. We have therefore based our costings as per their specifications including ongoing support packages to ensure the longest life of the defibrillator. We would hope to work with Community HeartBeat, and they offer included in the package the following:

WebNos Governance system Ambulance service registrations Post rescue counselling service Telephone support

We also will work in close partnership with Red Sky and the local fire service who deliver community defibrillator training, to work with our committee and users of the space, as well as the school community with whom we share a party fence.

Partnerships with:

Grange Park Primary School; we have the school's community manager attend the committee meetings at the centre and in turn, our secretary is part of the schools governance board.

Red Sky and the Community Fire Service for training and maintenance; training will be arranged to deliver in the community around safe use of the defibrillator.

SARA project and events group - we are part of the networks led by SARA, regularly feeding in to these and sharing information and events.

SNYP - we are working closely with SNYP as part of their Raising Aspirations project, which focuses on development of the centre. We have their staff on our committee.

Project Description – taken verbatim from Application:

Veterans in Crisis Sunderland (VICS) is reaching its fourth anniversary in April of 2022. Since inception our company has progressed rapidly and we can now include over 420 members within the metropolitan borough delivering services and activities which are designed to improve physical and mental health wellbeing. Our headquarters offers the only 24-hour emergency accommodation for veterans in the North East. Our city-wide network forms a robust safety net for veterans with mental health needs. We have recruited an Armed Forces Champion in each of the city's key organisations (every GP practice, Sunderland university, SAFC, Sunderland council, police, probation, housing associations, and the Jobcentre etc.).

When veterans come to us, many are homeless, socially isolated and experiencing family breakdown or estrangement. The majority have alcohol or drug problems, or both, and most have mental health problems.

The work we do is valued by the people of Sunderland who recognise the difficulties faced by veterans on leaving the forces and settling into civilian life, something that can take many difficult years to achieve.

We wish to purchase a defibrillator, a life-saving machine which will support residents, visitors, and veterans in the North of Sunderland. If within two minutes of a defibrillator evidence shows the chances of survival from a cardiac arrest is 80% if a device is used within that time. Without a defibrillator, the chances of survival reduce to just 2% (<u>https://www.liverpoolbidcompany.com/get-a-defibrillator-in-your-building-and-become-a-life-saver/</u>).

Our headquarters is located in the heart of Sunderland just north of the Wearmouth Bridge at a very busy intersection in and out of the city. It is also the fulcrum for visitors to Sunderland going to watch Sunderland AFC, visiting our glorious beaches, the National Glass Centre, the Beacon of Light, the City itself, gymnasiums and a wide range of national supermarkets and chain stores. Instantly recognisable with murals depicting military life and adorned with poppies it is an average journey time of 8 minutes for the ambulance service to reach us. We consider this to be one of the key locations for an accessible defibrillator as our location is very accessible for all routes north of the city. Bus services, Metro travellers, car drivers and those on foot are within a short distance that will benefit from a defibrillator should they need it. Journey times from our location are lengthened by traffic congestion during busy periods and having a machine that has the ability to enhance the chance of survival from cardiac arrest is very beneficial to those who need it.

By collaborating with the Community Heartbeat Trust our equipment will be installed using the correct fixings, maintained, and meet IP65 standards. Full and comprehensive records of the defibrillator and its storage solution, where all work, maintenance, supplies and servicing is stored will be available on request including for the local ambulance service North East Ambulance Service.

After use the defibrillator will be re-commissioned replacing electrodes & ready/rescue kits, cleaned/sterilised, tested and operational, returned tested and functional to cabinet, and the ambulance service and other stakeholders notified.

In preparation of this bid Veterans in Crisis considered how beneficial having a defibrillator fitted to our building would be to companies within a short distance. Public service operators will be advised of its location relative to their areas of operation. Notices will be posted on public notice boards at these and other locations such as supermarkets, gymnasiums, Sunderland University and College at St Peter's campus and at small businesses within the local area.

As the primary third sector provider of services for veterans in the metropolitan borough of Sunderland we have an extensive network of partners including Sunderland All Together Better (formerly CCG), the council, housing associations, police, probation and the JobCentre. We will advise these organisations of our defibrillator and its location.

Access to training and training updates on the defibrillator can be provided by the Armed Forces Lead at Sunderland All Together Better. We will also invite local businesses to take part in defibrillation training.

Veterans in Crisis have worked tirelessly during the Covid 19 pandemic collecting and delivering PPE, oximeters, covid testing kits, medical equipment on behalf of Sunderland CCG. Currently we are working with Sunderland Council in delivering the Covid19 messages, encouraging take up of the vaccine, boosters and flu jabs. Our counsellors are providing social prescribing services on behalf of All Together Better (formerly Sunderland CCG) with the aim of treating veterans with mental health conditions.

We support veterans to access health services, housing, unemployment and other benefits, help them with debt advice, and source and provide the other information they need to resolve their immediate challenges. When they feel ready to move on, we offer them volunteering opportunities, training and employment advice and help them to seek and apply for work.

Our service is free to any veteran living in Sunderland.

Veterans in Crisis (VICS) will actively promote this service through our newsletter which is also published on our web site <u>www.veteransincrisis.co.uk</u>, social media through Facebook and Twitter reaching over 9000 followers daily.

VICS also broadcasts a podcast on our YouTube channel

https://www.youtube.com/channel/UCVmFwTusBMTj-5AVF6IVGHA and we will promote our defibrillator in a podcast.

Our connections to media sources such as TV, radio and local press has meant that our good news stories are sought on a regular basis. At the end of last year we were featured in national newspapers for the work we do with the People Health Lottery <u>https://www.dailystar.co.uk/news/ex-army-members-support-network-25727044</u> and we will continue to seek this outlet to promote our good work.

Julie Elliot MP has donated funds recently and we are using some of this funding to purchase the defibrillator. We would like to promote the defibrillator in a news story involving both the council and our local MP at an official ceremony announcing the installation.

We will also publicise occasions that the defibrillator has been used in saving life, mentioning funding and funders within the press release.

Whilst there is no legal requirement for training for the use of a defib, we will access training sessions for the committee, and any members who are interested with a suitable training provider, such as St. Johns ambulance, British Red Cross etc

Training records will be kept and maintained and refresher courses will be carried out in the future in line with recommendations.

We will notify the ambulance service of the location of the defib and register it with Circuit and Heartsafe.

We will publicise on our facebook page and on the Sunderland North community facebook page, the location and acknowledge support from Area Committee to provide the defib.

We will contact other local authority and community sector projects and organisations in the locality and advise them of the defib and how to access it.

We will carry out the necessary checks in line with the DOH and MHRA recommendations

REPORT OF NORTH AREA VOLUNTARY AND COMMUNITY SECTOR NETWORK

1. Purpose of the Report

1.1 The report provides an update with regard to the North Area Voluntary and Community Sector Network

2. Background

- 2.1 To develop the capacity and influence of the Voluntary and Community Sector (VCS) across the City, Area Networks have been established and delegates represent each Area Network at Area Committee taking forward issues on behalf of the whole VCS in the area, reporting on area priority delivery by the VCS, and reporting back, providing a two-way flow of communication.
- 2.2 North Area Network delegates will present a report to each Area Committee meeting informing Members of activity, progress, issues and concerns of the sector.
- 2.3 The North VCS Network is made up of over 100 local groups and strategic local/national/regional partners. The network meets on a regular basis in order to share good practice, support one another and receives regularly updates as part of an information share e bulletin.

3. North Voluntary and Community Sector Network (VCSN) Progress Report

- 3.1 The North VCS Network met via Microsoft TEAMS in June, July, September, October and December 2021 and in person in March 2022.
- 3.2 The meetings have included the following agenda items:

- 3.3 Regular funding bulletins are provided to the Network to ensure VCS organisations are kept informed of funding opportunities available.

- 3.4 Consultation was held with North VCS Youth groups regarding the services and activities they delivered and what activities young people wanted to access, a video was produced presented to the February Neighbourhood and Community Board attended by representatives of youth groups and young people.
- 3.5 A collaboration of North Area VCS groups came together to submit an application to Community Resilience for Targeted Covid Community Champions Project. This application was successful and the partnership is working well ensuring those important Covid messages are reaching residents from the North Area.
- 3.6 Organisations from across the Network are beginning to deliver more of their much needed services as restrictions change. Activity programmes continue to look very different to ensure organisations are working within government guidelines to keep everyone safe by respecting social distancing and implementing rigorous hygiene procedures.
- 3.7 Following significant consultation with the Area Voluntary and Community Sector Networks, a Sunderland VCS Alliance has been formed to support a strong, vibrant, and accessible VCS which both influences and supports delivery of key services in the city. The Alliance is sector-led through the five Area VCS Networks and financially supported by Sunderland City Council, Sunderland Clinical Commissioning Group and Gentoo, alongside external funding secured via the ESIF Community Led Local Development Programme. The Alliance is building upon the importance and strengths of area-based VCS structures and networks, increasing capacity in the sector wherever possible, to support the delivery of the ambitions of the Sunderland City Plan, Neighbourhood Investment Plans, Sunderland Community Wealth Building Strategy and the Community Led Local Development Strategy.

The VCS across Sunderland have worked tirelessly for decades and particularly throughout the pandemic, the VCS Alliance is committed to working hard to ensure the VCS is supported and strengthened over the coming years, working with other Anchor Institutions across the city.

The strategic aim of the Alliance is to develop a VCS Strategy and Delivery plan which results in significant investment for the sector. The Alliance has already worked hard to submit a funding application to the UK Community Renewal Fund, growing volunteering and work placement opportunities across the sector.

The Alliance will ensure the VCS has a strategic voice in the city to inform the design, implementation and delivery of services including commissioning opportunities of those partner organisations to support delivery of the City Plan, Neighbourhood Investment Plans and Community Wealth building Priorities.
