## **Report of the Chief Executive (Acting)**

## **1.0** Purpose Of The Report

1.1 This report provides information to the Area Committee on expenditure from the Strategic Initiatives Budget (SIB) on projects it has previously funded

## 2.0 Background

- 2.1 Each Regeneration Framework area has been allocated a minimum of £200,000 per annum over the last thirteen years from the Strategic Initiatives Budget to promote action on key priorities identified in the relevant Area Regeneration Frameworks, and to attract other funding into the area. Over this period, therefore, the Framework area has been allocated £2,709,172 in this way.
- 2.2 In order that the Area Committee can be kept informed of progress on projects it has previously funded as part of the SIB monitoring process, a programme of report backs has been scheduled.

## 3.0 Purpose of the Feedback Reports

- 3.1 The aim of the reports are to inform the Area Committee how the money it has been allocated through SIB has been used, how successful it has been in achieving its original objectives, and how the project will continue. Specifically, the reports have been asked to address the following key questions :
  - How has the money has been used? How much was capital and revenue?
  - What were the outcomes of the project? How has it helped to achieve the objectives identified in the original submission? Are there any statistics that will support the outcomes?
  - What other funding the SIB allocation helped to attract?
  - What are the key lessons learnt? What difference has the project made in comparison to other areas that did not have such funding? What added value did the project provide? Are there implications for existing service provision?

- Does the project need to continue? Has it come to its natural end? If not, how will it be funded? Has it been considered for mainstream funding? Have other funding sources been approached?

The community alcohol misuse project has came in to being as a result of local residents of Hendon, Sunderland, expressing their concerns about lack of treatment availability and the fact that people were having to wait 11 months for treatment. The pilot project is funded by New Deal for Communities and brings a partnership working between Back on The Map (urban regeneration) Sunderland Teaching Primary Care Trust and NERAF. The first of its kind the project provides information, treatment and aftercare.					
Identification of people that may need to access this service could come from GP's, Housing Projects, Health Trainers, Probation, Police, Sunderland City Hospitals, Jobcentre, Shaw Trust, Wearside Substance Misuse Team, North East Council of Addictions, Social Services and other generic agencies as well as by Self Referral.					
The project has two principal components, each coming from a different discipline yet able to offer a seamless accessible service for the residents of Hendon. The first focuses upon a clinical post, working directly with					

those who have complex needs requiring intensive support, including detoxification and rehabilitation. The second element works with those individuals in the community who are principally hazardous and harmful drinkers, and those needing long term support to achieve their drinking goals.

It utilises local services and groups, and uniquely increases capacity by training and supporting local people to become accredited mentors and educators. It also has the capacity to undertake prevention work – once again working with local people from the East End and Hendon area.

Community based support will be delivered by NERAF which is an independent charity. The service they will develop and deliver will be using locally trained mentors working with and supporting individuals who are experiencing problems with their drinking.

Many mentors themselves have experienced alcohol problems in the past, and as such, understand what the individual is experiencing. They act as a support network operating within a peer support role which includes helping people access existing services within the community.

This project offers an innovative and direct way of engaging with residents who are identified as requiring treatment. It offers a local solution. The project works in an individual's home area and integrates with existing health and lifestyle programmes. It will offer 24-hour support, and operate at weekends when people are often vulnerable.

It offers the best of both the statutory (NHS) and voluntary sector (NERAF). It goes beyond treatment by developing prevention and awareness programmes, which will involve local people. The benefits will include training and accreditation, enabling residents to gain not only experience, but also qualifications.

Outcomes and benefits to local residents will be in terms of reduced social and health risks associated with alcohol use, support from family and friends and reduced crime and disorder, making Hendon and the East End a safer place to live and work. After the initial success of this pilot, it is the intention that the programme will be rolled out across the City, dependent upon its success and the evaluation being undertaken by Northumbria University.

The outcomes will be achieved by effective use of clinical interventions and mentor support; that is, individuals who will engage with the alcohol user and family. It is anticipated that mentors will be recruited from the local area.

3.5 What service does the organisation currently provide and how will this be complemented by the project?

We currently provide a 1-2-1 mentoring service which is tailored to meet an individuals treatment needs and support groups (including women's only). Current treatment systems currently focus on clinical interventions, which we believe is responsible for the revolving door syndrome and the fact that the same people are re-engaging with service providers time after time. We propose to compliment our current services so that they have an equitable approach believing that an individual's alcohol misuse is a symptom of some other problem. We intend that this approach is that all needs are uncovered in conjunction with each other and an overall set of positive outcomes for the individual are planned for. Maslows

Hierarchy of Human Need identifies the needs at the bottom of the hierarchy must be met if a person is to move on to the higher levels and eventually to selfactualisation. Therefore physiological and safety needs ie housing, food, relationships, debt, heat etc should be considered in conjunction with urgent health/treatment needs.

NERAF has the opportunity to develop a flagship service in Sunderland, a model that may well be developed regionally and nationally. We are a young organisation still developing and we will be seeking funding for long-term sustainability of the project from the Commissioners of services.

Consultations with service users and existing service providers including Community Addiction Team (which has substantial client waiting list of which the highest proportion are from Hendon area) North East Council on Addiction and local primary care practice. Discussions with commissioners including Peter Carlin-Page Alcohol Coordinator Sunderland TPCT.

Research including Alcohol Needs Assessment Research Programme (2005) clearly identified the North East as having the lowest number of referral sources for those experiencing alcohol problems. Dr Hornsby Durham University Research 2004 again identified the paucity of services available.

Ongoing consultations with service users and existing service providers. Discussions with commissioners including Sunderland PCT.

Within Sunderland, Hendon has the highest proportion of residents on waiting lists for treatment. As stated above **30% of the waiting list for North East Council on Alcohol (NECA) is from Hendon. Community Addiction Team indicates a figure of over 10%**. If the figures also included East City Centre, then we would

have a considerable increase. Using extremely crude measures, we could estimate that from national figures. Hendon would have in excess of **450 individuals who** are dependant / harmful drinkers and over 1600 hazardous drinkers. This doesn't take into account those family members and carers effected by those who are drinking in such patterns.

Evidence suggests that (Models of Care for Alcohol 2006) the most effective way of working with individuals is to be:

Empathetic – supportive – goal directed –

Helping – understanding – encourage autonomy – help access external resources

Following treatment individuals may need help to:

- Maintain their personal commitment to their drinking goal
- Avoid company of heavy drinkers
- Find housing / employment
- Access training education develop life skills
- Manage personal finances
- Achieve lasting changes in lifestyle

Alcohol is a prime factor in crime – violence – health. This programme will deliver tangible and effected results by engaging with individuals who are either consuming alcohol or affected by a third party use. We also work with families and operate specific groups for instance – women only group.

5.2 Identify outputs / outcomes against which the delivery of the project can be evaluated. Demonstrate how these will contribute to the Area Regeneration Framework(s).

There will be 1-2-1 sessions available each week (1 hour duration) and direct contact available by telephone to residents. Client contact varies from one initial contact and onward referral to mentoring and motivational support of up to 4 sessions. It is anticipated that 500 1-2-1 contacts will be available within Hendon. Specific targeting will be towards female drinkers who research shows are often reluctant to access services. The following benefits will accrue:

Reduction in fear of crime - Engaging with communities reducing perceived fears – using media – presentations and working with individuals within those communities. Reduction in domestic violence – Offering direct service to those affected by domestic violence – access to women's only group. Reduction in anti-social behaviour – Reducing individual drinking patterns

More people accessing treatment/support services Working with providers across Sunderland acting as a first point of contact

Responsible drinking – Driving forward responsible drinking messages
